WHEREAS section 74 of the Constitution Act, 1889, provides that the Governor in Council may vest in Heads of Departments, or other officers or persons within the State, power to make minor appointments; and whereas it is desirable that power of appointment of foremen and other persons employed at a daily rate of wage on works under the control of the Department of Public Works, and of Water Supply, Sewerage and Drainage (exclusive of the Metropolitan Water Supply, Sewerage and Drainage Board) should be vested in Mr. Eric David Cooper: Now, therefore, His Excellency the Governor by and with the advice of the Executive Council hereby vests in Mr. Eric David Cooper the appointment of foremen and all other persons employed on such works at a daily rate of wage under the control of the Department of Public Works.

Fourth Schedule.

The Fourth Schedule to the Poisons Act, 1964-1969, as so substituted, is amended by deleting therefrom the item, "BETA-AMINOPROPYL-BENZENE (AMPHETAMINE)", and adding in its place the following item:—

BENZPHETAMINE and other derivatives of amphetamine except when included in the Third and Eighth Schedules and except ephedrine, pseudoephedrine and phenylephrine in preparations expressly excepted from the Third Schedule.

Eighth Schedule.

The Eighth Schedule to the Poisons Act, 1964-1969, as substituted is amended—

(a) by adding after the item "ALPHAPRODINE," the item—

AMPHETAMINE but not including derivatives of amphetamine not expressly included in this Schedule. ;

(b) by adding after the item "DESOMORPHINE," the item—

DEXAMPHETAMINE but not including derivatives of dexamphetamine not expressly included in this Schedule. ;

(c) by adding after the item "METHYLDIHYDROMORPHINE," the following items—

METHYL AMPHETAMINE but not including derivatives of methyl amphetamine not expressly included in this Schedule.

METHYL PHENIDATE. ; and

(d) by adding after the item "PHENAZOCINE," the item—

PHENMETRAZINE.

WHEREAS by section 33 of the Land Act, 1933-1969, it is made lawful for the Governor to direct that any Reserve shall vest in and be held by any

Municipality, Body Corporate, or other person or persons to be named in the Order, in trust for any of the purposes set forth in section 29 of the said Act, or for the like or other public purposes to be specified in such Order and with power of sub-leasing; and whereas it is deemed expedient as follows:—

Corr. 2612/60.—That Reserve No. 25850 should vest in and be held by the Shire of Gnowangerup in trust for the purpose of Recreation.

Corr. 393/67.—That Reserve No. 29277 should vest in and be held by the Minister for Works in trust for the purpose of Irrigation Works.

Corr. 4014/68.—That Reserve No. 30477 should vest in and be held by the Shire of Irwin in trust for the purpose of Recreation.

Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned Reserves shall vest in and be held by the abovementioned bodies in trust for the purposes aforesaid with power to the said bodies, subject to the approval in writing of the Minister for Lands being first obtained, to lease the whole or any portion of the said Reserves for any term not exceeding 21 years from the date of the lease subject nevertheless to the powers reserved to him by section 37 of the said Act.

WHEREAS by the Forests Act, 1918-1964, it is provided that a dedication under the said Act of Crown Land as a State Forest may be revoked in whole or in part in the following manner:—

- (a) the Governor shall cause to be laid on the Table of each House of Parliament a proposal for such revocation.
- (b) after such proposal has been laid before Parliament the Governor, on a resolution being passed by both Houses that such proposal be carried out, shall by Order in Council revoke such dedication.

And whereas His Excellency the Governor did cause to be laid on the Table of each House of Parliament, his proposal dated the thirteenth day of October, 1965, for the revocation in part of the dedication of Crown Lands as State Forest: And whereas after such proposal had been laid before Parliament a resolution was passed by both Houses that such proposal should be carried out: Now, therefore, His Excellency the Governor with the advice and consent of the Executive Council doth hereby revoke in part the dedication of Crown Land as State Forest No. 14 by excising that portion of such State Forest as is described in the schedule hereto.

1.2 The Scheme shall apply to the whole of the land bordered in blue set out in Map 1 in the Appendices hereto.

1.3 The responsible authority for carrying out the Scheme is the Council of the Shire of Harvey, hereinafter called "the Council".

1.4 Arrangement of the Scheme: The Scheme is divided into the following parts:—

Part I.—Preliminary.

Part II.—Zones.

Part III.—Non-conforming Use of Land.

Part IV.—Advertisements and Overhead Wires.

Part V.—Finance and Administration.

The Scheme Documents also include the Land Use Map and the Scheme Map.

1.5 Interpretation:

- (1) Subject to the provisions of subclause (2) of this clause, in this Scheme the terms used will have the respective interpretations set out in Appendix D of the Town Planning Regulations 1967 unless otherwise specified in this Scheme.
- (2) In this Scheme, unless the context requires otherwise, "highway" means the road designated as such in Map 3.

PART II.—ZONES.

2.1 The Scheme area is zoned Rural.

2.2 (a) The following uses are permitted in the Rural Zone—

Dwellings.

Rural Pursuits.

(b) The following uses may be permitted by the Council in the Rural Zone after considering their affects upon the amenity of the area and the flow of traffic on the highway:—

Outdoor Recreation.

Sports Grounds.

Car Parks.

Public Utilities.

Service Stations (with or without restaurant).

Motels.

Caravan Parks.

Provided that the Council shall not permit a Service Station or Motor Repair Station within 10 miles of an existing Service Station or Motor Repair Station on the same side of the highway, and shall not permit a Motel or Caravan Park within 10 miles of an existing Motel or Caravan Park on the same side of the highway.

2.3 Uses which are not listed in clause 2.2 of this part are not permitted in the Rural Zone.

PART III.—NON-CONFORMING USE OF LAND.

3.1 No provision of the Scheme shall prevent—

- (a) the continued use of any land or building for the purpose for which it was being lawfully used at the time of the coming into force of the Scheme; or
- (b) the carrying out of any development thereon for which, immediately prior to that time, a permit or permits required under the Town Planning and Development Act, 1928 (as amended), or any other law authorising the development to be carried out, had been duly obtained and was current.

3.2 Where in respect of land zoned under Part II of the Scheme a non-conforming use exists or was authorised as mentioned in clause 3.1 of this part on that land, buildings may be extended to the limits prescribed by the Uniform Building By-laws made under the Act for the purpose of limiting the size, location and distance from boundaries and any other matter required by law for that class of use within the boundary of the lot or lots on which the use was carried on immediately prior to the coming into force of the Scheme.

3.3 Discontinuance of Non-conforming use:

4.4 The Council will not approve the erection of any sign, advertisement or hoarding which exceeds 3 ft. in height or 3 ft. in width.

4.5 The Council may remove any public sign, advertisement, hoarding or notice which has been erected contrary to Clause 4.1 of this Part.

4.6 No overhead wires shall be erected within 2 chains of the centre line of the highway save with the approval of the Council.

4.7 In exercising its discretion under this Part the Council will consider the need to preserve the scenic attraction of the area.

4.8 Clause 4.6 of this part shall not apply to the State Electricity Commission when exercising its powers pursuant to the State Electricity Commission Act.

PART V.—ADMINISTRATION.

5.1 The Council may by its engineer or other authorised officer enter at all reasonable times any building or land for the purpose of ascertaining whether the provisions of the Scheme are being observed.

5.2 Any person who fails to comply with any of the provisions of the Scheme is guilty of an offence and without prejudice to any other remedy given herein is liable to such penalties as are prescribed by the Act.

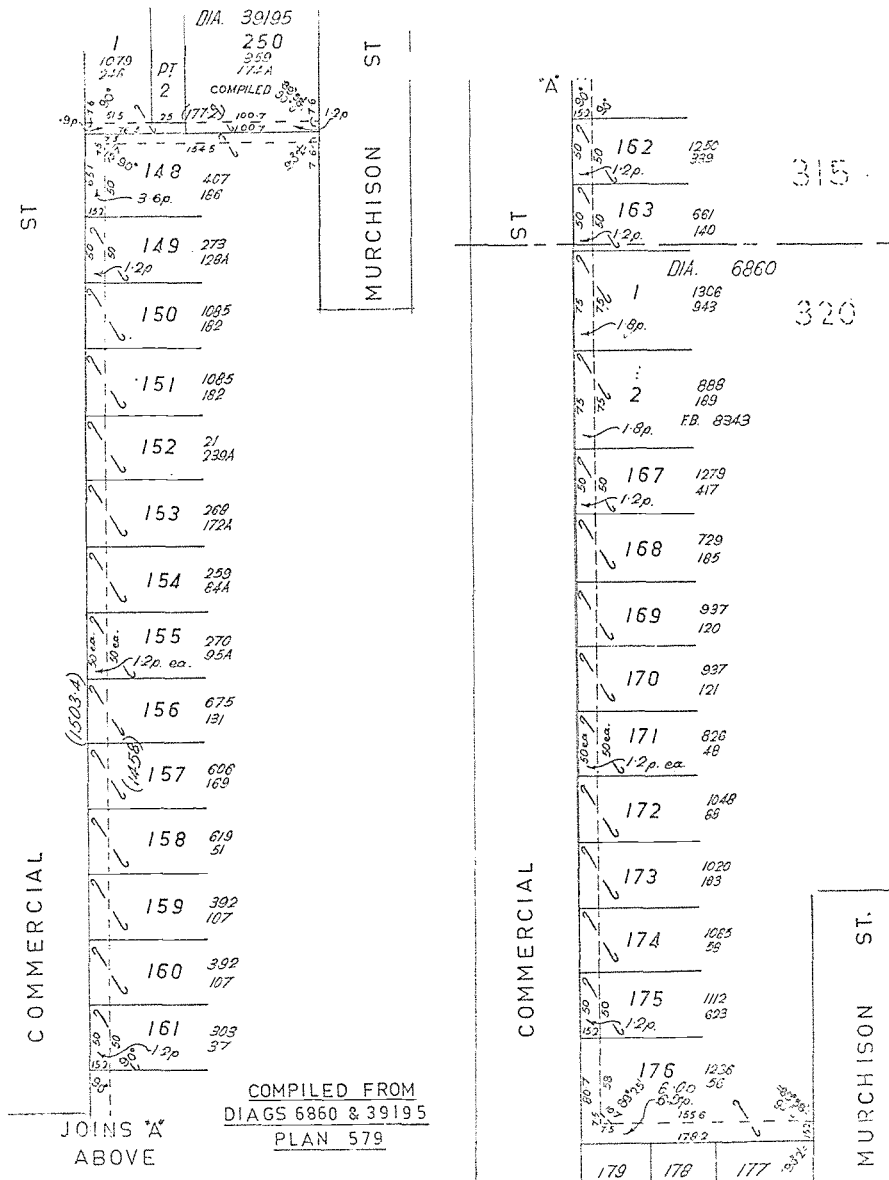
