GAS STANDARDS ACT 1972

THE INDIVIDUAL APPLIANCE CERTIFICATION SCHEME

For Type A gas appliances in Western Australia

Introduction

The Gas Standards Act 1972 (the Act) stipulate that Type A gas appliances must be approved by the Director of Energy Safety (the Director) before being sold, hired, advertised for sale, or installed. The approval pathways for Type A gas appliances are—

- An application made to the Director under Section 13E of the Act; or
- The Director, under Section 13F of the Act, adopts an approval given by a body or authority having among its objectives the duty of examining, testing, or approving gas appliances.

The Director's adoption of approvals given by other bodies is typically for mass-produced Type A gas appliances approved under the nationally recognised 'type test' certification scheme by a JAS-ANZ accredited Conformity Assessment body (CAB).

The purpose of this document is to set out the framework for the approval of Type A gas appliances by the Director under Section 13E of the Act.

Scope

The scope of this document is to provide a cost-effective and practical pathway for achieving an acceptable safety outcome for the approval of individual or custom-built type A gas appliances that may not be suitable for assessment through a 'type test' scheme.

Large quantity mass-produced type A gas appliances shall continue to be approved through the nationally recognised 'type test' scheme. The individual certification scheme is only appropriate in specific scenarios. In particular, the following examples are considered scenarios where this process of assessment and approval may be appropriate.

- Where a manufacturer plans to produce one-off or small numbers of a Type A gas appliance, thus ensuring an acceptable level of safety while still allowing for market testing and gas appliance design innovation.
- Where a one-off or a small number of Type A gas appliance is imported from overseas and does not have a "type test" certification scheme.

Definitions

Type A gas appliance: An appliance of a class or type specified in Regulation 42B of the Gas Standards (Gasfitting and Consumer Gas Installations) Regulations 1999.

Approved: Means approved by the Director of Energy Safety.

Director: Director of Energy Safety (for certain actions may include persons delegated by, or acting under authorisation of, the Director).

Competent authority: A person or an organisation recognised by the Director to test gas appliances under section 13E(2) of the Act.

Excluded gas appliances

The following gas appliances are excluded from the individual certification scheme and are required to be assessed under a nationally recognised 'type-test' scheme—

- Gas appliances that are fuelled by way of/or include a fuel gas canister. This includes but is not limited to butane canister cookers (lunch box cookers), camping heaters, and canister lamps/lights.
- Mobile serving appliances, such as Yum-Char Trolley—mobile food cabinet.
- Ducted air heaters.
- Space heaters.

Applying to become a competent authority

A person or an organisation that wishes to be recognised as a competent authority, may apply to the Director. The application must demonstrate their competencies, experience, and quality control system for the purpose of testing type A gas appliances.

Approval process

The steps for approving gas appliances under the individual certification scheme are—

- The applicant engages a competent authority to arrange for inspecting and testing their gas appliance.
- The competent authority must submit to the Director an application supported with all the required information required in The technical specifications for gas appliances approval.
- The Director will review the application and may approve the gas appliance under the individual certification scheme.

- The Director will send an approval number to the competent authority if the gas appliance is approved.
- The competent authority must attach an approved badge to the gas appliance in a conspicuous position, with the relevant information engraved on the badge.


The technical specifications for gas appliances approval

A competent authority is responsible for providing the Director the following—

- Details of the gas appliance as in Appendix A.
- Photos of the gas appliance.
- The test result of the tests required in Appendix B for commercial catering equipment.
- The test results of the tests carried out for non-commercial catering equipment. The competent authority must coordinate with the Director to determine the tests required for the approval of the gas appliance.

Approval badge

Approval badge for a Type A gas appliance under the individual certification scheme.



Record keeping

Competent authority must keep the records of tests for no less than five years.

Fees

Competent authority and the Director may charge a fee for the inspection, testing and approving of the gas appliances.

Appendix B: Tests required for commercial catering equipment

Commercial catering equipment must be inspected/tested to, but not limited to, the following sections and clauses of Australian Standard AS 4563:2022—Commercial catering gas equipment (the Standard).

A variation from the method of testing (MoT) may be allowed by the Director on a case-by-case basis where it is impractical to conduct the MoT required by the Standard. Where the Director has approved a variation from the MoT, the competent authority must ensure the variation will verify the principles of the requirements of the Standard. The competent Authority must obtain the Director's approval on the variation from the MoT before testing the gas appliance.

Section 11ZOM

APPROVAL OF AMENDMENTS TO THE WESTERN AUSTRALIAN GAS RETAIL MARKET SCHEME—IN009/20W, IN002/22W, IN002/23W, AND IN001/24W

The Economic Regulation Authority (ERA), pursuant to section 11ZOM of the *Energy Coordination Act 1994*, approves the following amendments to the Western Australian gas retail market scheme—

- IN009/20W amends an error in 'Auditor's deed of undertaking' in the Retail Market Procedures (WA) and extends the period for providing an audit report to their client (AEMO, retailer or the network operator) from 2 to 3 months.
- IN002/22W fixes an issue with retailer's deregistration process.

- IN001/24W corrects several issues in clause 16 of the Retail Market Procedures (WA) and reintroduces clause numbering in Appendix 2.
- IN002/23W proposes to fix a discrepancy between two gas retail market scheme technical documents and remove some duplicate/invalid transactions.

These proposals were submitted to the ERA for approval by the Australian Energy Market Operator (AEMO) on 24 June 2024. Pursuant to section 11ZOM(a) of the *Energy Coordination Act 1994* (WA), the ERA approves the amendments in procedure change proposals IN009/20W, IN002/22W, and IN001/24W as submitted by AEMO.

Under section 11ZOM(b) of the *Energy Coordination Act 1994* (WA), the ERA requests that the procedure change proposal IN002/23W be changed. The ERA approves the amendments in this changed form.

The amendments to the Western Australian gas retail scheme will take effect on Monday 16 September 2024

BUSH FIRES ACT 1954

Section 33

Shire of Mundaring

FIREBREAK AND FUEL LOAD NOTICE

Notice to all owners and occupiers of land situated within the Shire of Mundaring

Pursuant to section 33(1) of the Bush Fires Act 1954, the Shire of Mundaring (the Shire) gives notice that the owners and/or occupiers of the land district are required to undertake the following works on land owned or occupied by them. This must be done by 1 November each year and maintained until 31 March the year following.

DEFINITIONS WITHIN THIS NOTICE

<u>Authorised Officer</u>—means an employee of the Shire appointed as a Bush Fire Control Officer, pursuant to the powers conferred in section 38 of the Bush Fires Act 1954.

<u>Trafficable</u>—means to be able to travel from one point to another in an emergency services vehicle on a clear surface, unhindered, without any obstruction that may endanger such vehicles. It must not terminate, lead to a dead end, nor have any pinch points without provision for egress to a safe place, or a cleared turnaround area of not less than an 18-metre diameter.

<u>Vertical Clearance</u>—means a continuous, uninterrupted vertical line at a right angle to the horizontal baseline of the firebreak, to a minimum height of 4 metres from the ground.

<u>Firebreak</u>—means a strip or area of ground, with a minimum width of 3 metres but no wider than 4 metres, and a vertical clearance of 4 metres, immediately inside all external boundaries of any lot and constructed to a trafficable surface, that is kept and maintained clear of all flammable and combustible material. This includes the pruning and removal of any living or dead trees, scrub, or any other material encroaching onto it or into the vertical clearance of the firebreak area. Firebreaks may be constructed by one or more of the following methods: ploughing, cultivating, scarifying, raking, burning, chemical spraying, blowing, or other methods as approved by an Authorised Officer.

<u>Flammable Material</u>—means any substance that will catch fire easily without contact with flames or with a low ignition point, such as but not limited to, petrol or liquefied petroleum gas.

<u>Combustible Material</u>—means any fine fuels, plant, tree, grass, substance, object, thing, or material that may or is likely to catch fire and burn or any other thing deemed by an Authorised Officer to be capable of combustion.

<u>Fuel Depot / Fuel Storage Area</u>—means an area of land, a building, or a structure where fuel, i.e. (petrol, diesel, kerosene, liquid gas, or any other fossil fuel) is kept in any container or vessel.

Fuel Loads

 $\underline{\mathit{Fine Fuel Loads}}$ —means the leaf litter on the ground, including leaves, twigs (up to 6mm in diameter), and bark.

A fine fuel load depth of 5mm from the top of the layer to the mineral earth beneath indicates approximately 2 tonnes per hectare. A fine fuel load depth of 15mm from the top of the layer to the mineral earth beneath indicates approximately 8 tonnes per hectare.

Coarse Fuel Loads—means twigs, branches (6mm or larger in diameter), logs, etc.

<u>Maintaining Fuel Loads</u>—relates to managing fuel loads described in this Notice. Reducing fuel load levels does not necessarily require the removal of existing natural vegetation. A combination of methods can be utilised, including planned burning, raking, weed removal, pruning, and/or removing dead plant material

<u>Managed Vegetation</u>—includes vegetation that is pruned away from buildings, under pruned to minimise contact with ground fuels, and that is kept free of dead suspended matter such as twigs, leaves, and bark.

<u>Habitable Buildings</u>—means any building or other dwelling suitable for human residency, occupation, or use within an already existing Asset Protection Zone. This includes attached or adjacent structures such as garages, carports, verandas, or similar roofed structures that are attached to, or within 6 metres, of the dwelling or primary building.

Asset Protection Zone (APZ)—is an area of very low fuel levels surrounding a habitable building extending to a minimum of 20 metres out from any external walls of the building, attached structures, or adjacent structures within 6 metres of that building. On sloping ground, it shall increase at 1 metre for every degree in slope on the sides of the habitable building that are exposed to downslope natural vegetation.

1. The Land owner (or occupier) is required to do the following

1.1 All land with an area of up to 5,000sqm, with a building on it must

- (a) Maintain all grass on the land to a height no greater than 5cm.
- (b) Maintain fuel loads in natural bush areas at less than 8 tonnes per hectare across the land.
- (c) Maintain an APZ in line with the requirements of section 1.6 of this Notice.

1.2 All land with an area of 5,000sqm up to 50,000sqm (5 Hectares) with a building on it must

- (a) Maintain all grass on the land to a height no greater than 5cm.
- (b) Install a firebreak around all structures outside of the APZ and immediately inside all external boundaries of the land.
- (c) Maintain an APZ in line with the requirements of section 1.6 of this Notice.
- (d) Maintain fuel loads outside an APZ in natural bush areas at less than 8 tonnes per hectare across the land

1.3 All land with an area of 50,000sqm or greater, with a building on it must

- (a) Maintain all grass to a height no greater than 5cm for a distance of 10m from any firebreak.
- (b) All other grasses within the area must be managed by slashing or effective grazing by livestock or as directed by an Authorised Officer.
- (c) Install a firebreak around all structures outside of the APZ and immediately inside all external boundaries of the land.
- (d) Maintain fuel loads in natural bush areas at less than 8 tonnes per hectare across the land.
- (e) Maintain an APZ in line with the requirements of section 1.6 of this Notice.

1.4 All vacant land with an area of less than 2,000sqm

(a) Ensure all grass is maintained on the land to a height no greater than 5cm and that fuel loads in natural bush areas are maintained to less than 8 tonnes per hectare across the land.

1.5 All vacant land with an area greater than 2,000sqm must

- (a) Install a firebreak immediately inside all external boundaries of the land.
- (b) All land with an area of less than $50,000 \, \text{sqm}$ (5 Hectares), all grass must be maintained on the land to a height no greater than $5 \, \text{cm}$.
- (c) All land with an area of 50,000sqm (5 Hectares) or greater, the grass must be maintained on the land to a height no greater than 5cm for a distance of 10 metres from any firebreak, and all other grasses managed by slashing or effective grazing by livestock or as directed by an Authorised Officer.
- (d) Maintain fuel loads in natural bush areas to less than 8 tonnes per hectare across the land.

1.6 Asset Protection Zone Specification

- (a) Maintain all grass on the land to a height no greater than 5cm.
- (b) Fuel loads maintained at 2 tonnes per hectare or lower.
- (c) Clear separation between adjoining or nearby tree crowns.
- (d) Small group/s of trees within close proximity to one another may be treated as one crown provided the combined crowns do not exceed the area of a large or mature crown size for that species.
- (e) No trees/shrubs over 2 metres high are to be within 2 metres of a habitable building.
- (f) Trees and shrubs must be under-pruned to a minimum height of 2 metres from the ground.

- (g) Shrubs over 2 metres high must not be planted in groups close to habitable buildings, ensuring there is a gap of at least three times the height (at maturity) of the shrub away from habitable buildings.
- (h) Ensure no part of a tree overhangs any buildings.
- (i) Gutters are free of fine fuels and other flammable/combustible materials.
- (j) Roofs and walls of all buildings within an APZ on the land are free of fine fuels and other flammable/combustible material. Including wood piles against building walls and flammable/combustible materials against that building or stored under pole-framed houses.
- (k) Ensure paths and non-flammable features immediately adjacent to habitable buildings are installed.
- (l) Wood piles and flammable materials are stored at a safe distance from habitable buildings.

1.7 Fuel Depot /Storage Area, Haystacks / Stockpiled Flammable Material

- (a) Remove all flammable/combustible material within 10 metres of where it is stored.
- (b) Install a firebreak immediately adjacent to any haystacks or stockpiled flammable material.

1.8 Application to vary the above Requirements/Arrangements

An application to vary any of the above requirements can be made to the Shire to implement measures in the case of topographic or environmental obstructions. This will be assessed by an Authorised Officer and will be granted for a time period as decided by the Authorised Officer assessing your application. If approved you must still comply with the other sections of this notice. If not approved, your property is still required to comply with this notice. Bushfire Management Plans, Bushfire Management Statements, or Fuel Load Management Plans, approved by the Shire to reduce and mitigate fire hazards within a particular subdivision, lot, or other area of land anywhere in the district, are also included.

1.9 Additional Works
