The following are the rates of Postage chargeable on the above :---

For a packet not exceeding 2 s. d. ounces in weight ...... 0 8 exceeding 20z, but not exceeding 40z. 1 0 exceeding 40z, but not exceeding 80z. 2 0 exceeding 80z, but not exceeding 120z. 3 8 exceeding 120z, but not exceeding 11b 4 0

No packet of Patterns or Samples must exceed 80z. in weight, and no Book packet must exceed 3 pounds in weight.

It is also notified that arrangements have been concluded with the Post Office of New South Wales under which Trade Patterns and Samples of merchandise may now be forwarded by Post to that Colony at the same rates as book packets are forwarded, and subject to the same regulations as apply to patterns for the United Kingdom.
