PROCLAMATION

Western Anstralia, to wit.

(L. S.) F. Napier Broome, Governor. By His Excellency SIR FREDERICK NAPIER BROOME, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Governor and Commander-in-Chief in and over the Territory of Western Australia and its Dependencies, &c., &c., &c.

THEREAS by the third Section of "The Customs Ordinance, 1860" (24 Victoriæ, No. 5), after declaring the limits of certain Ports of the said Colony, it is provided amongst other things that it shall be lawful for the Governor to alter or vary the limits and boundaries of any of the said Ports, and to establish any new Port or Ports as to him may seem meet, by Proclamation to be published in the Government Gazette: Now THEREFORE I, the said Governor, do hereby proclaim all that piece of water embraced within an East and West line drawn through Station Hill, a North and South line drawn through Fall Point, an East and West line drawn three miles South of Entrance Point, a North and South line three miles West of Entrance Point, and including the whole extent of Dampier Creek, to be a Port of the said Colony, from and after the 10th day of August, 1889.

(L. S.) F. Napier Broome, Governor. By His Excellency SIR FREDERICK NAPIER BROOME, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Governor and Commanderin-Chief in and over the Territory of Western Australia and its Dependencies, &c., &c., &c.

To all to whom these Presents shall come, Greeting:

WHEREAS by the Ordinance passed in the 24th year of Her Majesty's reign, No. 5, intituled "The Customs Ordinance, 1860," it is amongst other things enacted that it shall be lawful for the Governor, with the advice of the Executive Council, by his Warrant from time to time to appoint the Ports in the Colony which shall be Warehousing Ports for the purposes of the said Ordinance, and also what sort of goods in addition to Wines, Spirits, and Tobacco may be Warehoused without payment of duty upon the first entry thereof: Now know ye that I, Sir Frederick Napier Broome, by virtue of the power so vested in me, and with the advice of the Executive Council as aforesaid, do hereby appoint the Port of Broome as a Warehousing Port, from and after the 10th of August instant, for the purposes of the said Ordinance; and I do further by virtue of such power, and by and with the advice as aforesaid, declare that in any Queen's Warehouse to be provided in such Port there may be warehoused, in addition to Wines, Spirits, and Tobacco, all such general Merchandise and other Goods as the Chief Collector of Customs may approve of; and I do further appoint that such Port shall be and remain a Warehousing Port for the purposes of the said Ordinance, until such time as this Warrant shall be revoked in accordance with the provisions of the said Ordinance.

Whereas by the "Foreign Deserters Act, 1852," it is pro-WHEREAS by the "Foreign Deserters Act, 1852," it is provided that whenever it is made to appear to Her Majesty that due facilities are or will be given for recovering and apprehending Seamen who desert from British Merchant Ships in the territories of any foreign power, Her Majesty may, by Order in Council stating that such facilities are or will be given, declare that Seamen, not being slaves, who desert from Merchant Ships belonging to a subject of such power, when within Her Majesty's dominions, shall be liable to be apprehended and carried on board their respective ships, and may limit the operation of such Order, and may render the operation thereof, subject to such conand may render the operation thereof, subject to such conditions and qualifications, if any, as may be deemed

And whereas it has been made to appear to Her Majesty that due facilities will be given for recovering and apprehending Seamen who desert from British Merchant Ships in territories belonging to the United States of Mexico under a Treaty between the Governments of Great Britain and the United States of Mexico, signed at the City of Mexico, on the 27th November, 1888:

Now, THEREFORE, Her Majesty, by virtue of the power vested in Her by the said "Foreign Deserters Act, 1852," and by and with the advice of Her Privy Council, is pleased to order and declare, and it is hereby ordered and declared, that from and after the publication hereof in the London Gazette, Seamen, not being slaves, and not being British subjects, who, within Her Majesty's dominions, desert from Merchant Ships belonging to Citizens of the United States of Mexico, shall be liable to be apprehended and carried on board their respective ships. Provided always, that if any such deserter has committed any crime in Her Majesty's dominions, he may be detained until he has been tried by a competent Court, and until his sentence, if any, has been fully carried into effect. to order and declare, and it is hereby ordered and declared, has been fully carried into effect.

And the Secretary of State for the Home Department, the Secretary of State for the Colonies, and the Secretary of State for India in Council are to give the necessary directions herein accordingly.

And I make this solemn declaration conscientiously believing the same to be true, and by virtue of the provisions of an Act of Parliament of Western Australia, rendering persons making a false declaration punishable for wilful and corrupt perjury.
