The Forests Act, 1918.

ORDER IN COUNCIL.

Forests File No. 1612/27; Lands and Surveys File No. 719/29.

WHEREAS by "The Forests Act, 1918," it is provided that the Governor may by an Order in Council declare any Crown lands as "State Forests," within the meaning and for the purpose of that Act: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, doth hereby declare the Crown lands described in Schedule attached hereto as an addition to State Forest No. 36, within the meaning and for the purpose of "The Forests Act, 1918."

The area bounded by lines starting from the North-East corner of Nelson Location 11048 and extending 270deg. 2min. 12 chains 88 8/10 links along part of that location's North boundary; thence North about 5 chains 20 links, East about 34 chains, and South about 14 chains along boundaries of State Forest 36; thence 288deg. 11min. 9 chains 51 2/10 links and 264deg. 32min. 11 chains 88 9/10 links along the Northern side of a public road, and thence 359deg. 42min. 6 chains 55 3/10 links along the East boundary of Location 11048 aforesaid to the starting point, and on the inner part by and exclusive of a public road (No. 7588) one chain wide; all bearings being true or thereabouts and the measurements more or less. John Harry Cooper and John Guise: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the before-mentioned Reserve shall vest in and be held by Mrs. Amelia Macdonald, Messrs. John Harry Cooper and John Guise, with power to the said Mrs. Amelia Macdonald, Messrs. John Harry Cooper and John Guise to lease the whole or any portion of the said Reserve for any term not exceeding twenty-one years from the date of the lease, subject, nevertheless, to the powers reserved by Section 41 of "The Land Act, 1898."

TOWN PLANNING REGULATIONS, 1930.

THE Hon. the Minister for Lands, in pursuance of the powers conferred on him by Section 9 of the Town Planning and Development Act, 39 of 1928, doth hereby make the Regulations hereinafter set forth:—

Regulations.

1. These Regulations may be cited as the Town Planning Regulations, 1930.

2. In these Regulations, unless the context otherwise requires "The Act" means "The Town Planning Act, 1928."

Resolution.

3. The resolution of a Local Authority to prepare a Town Planning Scheme shall be in terms of Form 1 (a) when within the area of the Local Authority making the resolution, and in terms of Form 1 (b) when the area of the scheme includes lands of one or more Local Authorities outside the area or district of the Local Authority making the resolution.

Civic Survey Plan.

4. (1) A Local Authority resolving to prepare a Scheme under the Act, or being required by the Minister to prepare a Scheme, shall forthwith compile, in accordance with the following provisions of this clause, a plan or plans of the area covered by the resolution. Such plan (or if more than one, all such plans taken together) shall constitute and be known as the Civic Survey Plan.

(2) The following particulars, as existing at the date of the preparation of the Civic Survey Plan, shall be shown thereon:—

- (a) The position of all streets, ways, and private streets, with the names, widths, and surface levels thereof;
- (b) The routes of tramways, railways, and licensed motor omnibus services;
- (c) The position of any harbour or other waterway, showing in relation thereto all bridges, wharves, quays, piers, jetties, or landing-stages;

- (d) All reserves and other open spaces, with particulars as to their several purposes;
 - (e) Areas of Crown land and of endowment land, or other land owned by the Local Authority;
 - (f) Land with buildings thereon, with particulars as to the kinds of buildings (for example, residences, shops, factories, public buildings, or as the case may be) to be shown by means of distinctive colours.
 - (g) The allotments into which the land within the area of the Local Authority or the Scheme is divided, showing location or lot numbers or other subdivisional references.
- (3) Any existing plan or plans on which the particulars required above are shown may be used as the Civic Survey Plan, and in such case the Local Authority shall not be required to prepare a special plan for the purpose.

Preliminary Town Planning Scheme.

5. (1) On the completion of the Civic Survey Plan, and either by way of addition thereto, or by the preparation of a new plan, the Local Authority shall prepare a plan, to be known as the Preliminary Plan.

(2) On the Preliminary Plan there shall be shown all works proposed for the purposes of a Town Planning Scheme, and in particular, the following matters:—

- (a) All new streets and ways proposed to be laid out;
- (b) Any proposed widening, deviation, or other alteration of any existing street;
- (c) The proposed building-lines, whether in respect of new streets, or of the widening of existing streets, or of new buildings to be erected in existing streets;
- (d) Areas proposed to be reserved for recreation grounds, children's playing areas, parks, or other open spaces, specifying with respect to each the purpose for which it is proposed to be reserved;
- (e) The restrictions (if any) proposed with respect to the use of any land, showing in each case the area to which the restriction relates and the nature of the restriction. Without limiting the generality of this provision, such restriction may relate to—
 - (i) the character of the buildings (as for example whether dwelling-houses, or shops, or public buildings, or workshops, or factories for inoffensive trades, or factories for noisome or offensive trades, or partly one class of building or partly another class);
 - (ii) the density of buildings;
 - (iii) the heights of buildings;
 - (iv) land not naturally drained and land liable to inundation;
 - (v) any other matters in the First Schedule of the Act or ancillary thereto.

(3) The areas proposed to be reserved for open spaces as aforesaid, and the areas proposed to be made subject to restrictions as to use, should be shown by distinctive colours or hatchings on the Preliminary Plan prepared in accordance with this clause.

(4) The contours of the several areas within the area of the Local Authority in relation to which any works are proposed to be carried out for the purposes of the Scheme shall be shown on the Preliminary Plan, as the Minister may from time to time require.

6. (1) In addition to the Preliminary Plan hereinbefore required to be prepared, the Local Authority shall prepare a statement setting forth in detail an explanation and description of the several proposals as shown on the plan, and, after having approved the Scheme in accordance with the said Act, shall forward to the Minister, in duplicate—

- (a) the Civic Survey Plan, to be marked "Plan No. 1";
- (b) the Preliminary Plan, to be marked "Plan No. 2";
- (c) the statement hereinbefore required to be prepared in explanation of the several proposals contained in the Preliminary Plan;
- (d) the By-laws of the Local Authority in so far as they may affect the operation of the Town Planning Scheme, together with any proposal of the Local Authority with respect to new By-laws, proposed under the Schedule of the Act.

(2) Where the Civic Survey Plan has been converted into the Preliminary Plan, it shall be marked as "Plan No. 1" and also as "Plan No. 2."

7. The Minister may, on receipt of the documents specified in the preceding regulation, refer the matter to the Board, which shall examine the same and advise the Minister thereon, including any modifications or alterations to the preliminary Town Planning Scheme and the Preliminary Plan that in the opinion of the Board are advisable or necessary.

7a. The Minister may require the Local Authority, within such time as he may specify in that behalf, to make such modifications or alterations of the Preliminary Town Planning Scheme and the Preliminary Plan as he considers proper. Subject to the due compliance with such alterations or modifications to the satisfaction of the Minister, the Minister may refer the whole matter to the Board for investigation and inquiry, and notify the Local Authority in writing, whereupon the provisions of Regulations 8 to 13 inclusive shall apply.

Notification of Preliminary Scheme.

8. (1) On receiving a notification from the Minister under the preceding regulation, the Local Authority shall publicly notify the same by advertisement in one or more newspapers circulating in the area of the Local Authority. Such advertisement shall be in the form set out in Form 2.

(2) Such advertisement shall be published not less than once in each of three successive weeks, and shall be in the Form No. 2 in the Schedule hereto or to the effect hereof.

(3) The Local Authority may also, if it thinks fit, publicly notify the Town Planning Scheme by posters or in any other appropriate manner.

Objections.

9. (1) Any objection to the Scheme made by the owner or occupier of any rateable property within the Local Authority, may be in the Form No. 3 in the Schedule hereto, or to the effect thereof.

(2) The owner of any rateable property within the area of the Local Authority, not being the occupier of such property, shall have a right of objection to the provisions of a Town Planning Scheme to the same extent as if he were the occupier of such property.

10. (1) Any person interested in the Scheme, other than as an owner or occupier of rateable property within the area of the Local Authority as aforesaid, may, in writing, make representations to the Local Authority for the alteration of the Scheme or otherwise in respect thereto.

(2) Every person making any representation as aforesaid with respect to a Scheme (as distinguished from a formal objection to the Scheme) shall in his notice state the capacity in which he is acting, as, for example, whether he is acting individually, or is acting as the representative of some specified society or association of persons interested in the particular Scheme, or generally in the furtherance of town planning principles, or as the case may be.

Submission to Minister of Preliminary Scheme with Objections, Representations, and Recommendations.

11. As soon as convenient after the expiration of the period of three months from the date of the first public notification of the Scheme, the Local Authority shall forward to the Minister—

- (a) a copy of each advertisement, poster, or other notification of the Scheme;
- (b) all objections and representations received in relation thereto;
- (c) a report of the Local Authority with reference to the several objections and representations made in relation to the Scheme; and any recommendations that the Local Authority may have to make for the modification of the Scheme, who may refer the same to the Board under Regulation 12.

Consideration by Board of Objections and Representations as to Scheme.

12. (1) The Board shall fix a time and place for the hearing of objections and the consideration of recommendations made with respect to the Scheme, and shall give notice of such time and place by advertisement published in one or more newspapers circulating in the area of the Local Authority to which the Scheme relates.

(2) The first such advertisement shall be published not less than seven days before the date fixed for the hearing.

(3) The Board shall, after such hearings, submit the Scheme with any amendments recommended, to the Minister for final approval.

Final Approval of Scheme.

13. (1) If the Minister approves of the Town Planning Scheme, including any amendments recommended by the Board, the Local Authority shall prepare a plan to be known as the Approved Plan, on which shall be shown the particulars specified in Clauses 6 and 12 hereof as finally approved by the Minister. The Approved Plan shall be marked, and may be referred to as "Plan No. 3." This approval shall be notified in the *Government Gazette*.

(2) With the approval of the Board, the Preliminary Plan may be adopted and used as the Approved Plan, in which case it shall be marked both as "Plan No. 2" and "Plan No. 3."

(3) A copy of the Approved Plan, together with a final statement of proposals and an explanation thereof, shall be prepared by the Local Authority for the use of and filed with the Board.

By-laws for the Regulation and Licensing of Hawkers.

P.W. 1219/29.

WHEREAS by "The Road Districts Act, 1919," the Road Board of any District is empowered to make By-laws for all or any of the purposes mentioned in the said Act; and whereas the Williams Road Board, in pursuance of the powers vested in the said Board, under and by virtue of the said Act, and of any authority enabling it in that behalf, doth hereby make and publish the following By-laws:—

1. In the construction of these By-laws, subject to the context, "Board" shall mean the Williams Road Board.

2. No person shall hawk any fruit, fish, vegetables, or any article of merchandise within any part of the Board's District without first obtaining a license from the Board.

3. Any person who trades or travels on foot, or with any vehicle or animal or carries to sell, or expose or offer for sale within the Board's District, any of the articles or things above-mentioned, shall be deemed to hawk the same:

Provided that nothing contained in this section shall apply to any person or persons paying rates, or liable to pay rates, for any shop or store carrying on the usual business, trade, and delivery trade, or delivery of goods therefrom.

4. A Hawker's License shall be in the Form No. 3 in Schedule A attached hereto.

5. The fees to be paid for licenses issued to hawkers shall be as set forth in Schedule B attached hereto.

6. Every application for a Hawker's License shall be made during the currency of the financial year in which the license is to have effect; and every such license shall have effect for and during that year, or the unexpired portion thereof, and no longer.

7. Every hawker, while employed in hawking, must produce his license, upon being required to do so by any police officer or officer of the Board.

8. Every hawker shall rigidly affix to some conspicuous part of his cart, barrow, or other vehicle or basket, and at all times maintain thereon, a board or plate bearing his name and the words "Licensed Hawker" legibly written thereon, in letters not less than one inch in height and of corresponding width.

9. No person to whom a Hawker's License shall have been granted shall lend, transfer, or assign his license, and no person shall borrow or make use of such license granted to a person other than himself.

10. Any person who does, permits, or suffers any act, matter, or thing contrary to these By-laws, or commits or permits any breach or neglect thereof, shall be liable on conviction to a penalty not exceeding £10 for every such conviction.
