WHEREAS it is enacted by "The Factories and Shops Act, 1920," that the expression "Public holiday" shall mean certain days therein specified, and any other day declared by Proclamation to be a public holiday for the purposes of the said Act: Now therefore I, the said Lieutenant-Governor, by and with the advice and consent of the Executive Council, do hereby proclaim and declare that Wednesday, the 12th day of May, 1937, shall be a public holiday throughout the State for the purposes of the said Act, and shall be observed as a public holiday under every part of the said Act in which the expression occurs.

WHEREAS it is provided by Subsection (2) of Section 102 of "The Factories and Shops Act, 1920," that, subject to the said Act, the day on which all shops affected by the said section shall close at one o'clock p.m. shall be Saturday, but that the Governor may by Proclamation at any time and from time to time, on the petition (according to the form in the Sixth Schedule to the said Act) of the majority of the keepers

of such shops in any District, substitute in that District for Saturday any other week day: And whereas a petition in due form has been presented to the Governor by a majority of the keepers of such shops, in the Capel Shop District, praying that Wednesday may be substituted in that District for Saturday as the day on which such shops shall close at one o'clock p.m. and it is desirable to accede to the prayer of that petition: Now, therefore I, the said Lieutenant-Governor, acting with the advice and consent of the Executive Council, do hereby substitute Wednesday for Saturday in the Capel Shop District accordingly, and do declare that, subject to the said Act, the day on which all shops as aforesaid shall close at one o'clock in the afternoon in the said District shall be Wednesday.

nine o'clock in the evening shall be Saturday, and it is desirable to accede to the prayer of such petition: Now, therefore I, the said Lieutenant-Governor, acting with the advice and consent of the Executive Council, do hereby proclaim and determine that, subject to the said Act the day in each week on which all such shops as aforesaid in the Capel Shop District shall remain open until nine o'clock in the evening shall be Saturday.

The Inspection of Machinery Act, 1921.

#### ORDER IN COUNCIL.

WHEREAS by Section 14 of "The Inspection of Machinery Act, 1921," the Governor may by Order in Council published in the *Government Gazette* declare that any kinds of machinery shall cease to be machinery subject to the said Act: Now, therefore, His Excellency the Lieutenant-Governor, by and with the advice and consent of the Executive Council, hereby declares that as from and including the 1st day of November, 1936, the machinery hereinafter specified shall be deemed to have ceased to be machinery subject to the said Act, and also that the machinery aforesaid shall until this Order in Council is revoked, continue hereafter to cease to be machinery subject to the said Act, that is to say:— With the exception of refrigerating machinery exceeding 5 ton capacity, all machinery driven other than by steam which is used on banana or pineapple plantations situate on the banks or within a distance of two miles from the banks of the Gascoyne river.

#### FARMERS' DEBTS ADJUSTMENT ACT, 1930-1934.

NOTICE is hereby given that the following Stay Orders have been issued in accordance with Section 7, Subsection 1, of "The Farmers' Debts Adjustment Act, 1930-1934," which reads as follows:—

## THE HEALTH ACT, 1911-1935.

## Amendment of By-laws.

M.H.D. 227/22; Ex. Co. No. 660.

WHEREAS under the provisions of "The Health Act, 1911-1935," a Local Health Authority may make By-laws, and may amend, repeal, or alter any By-laws so made: Now, therefore, the Toodyay Road Board, being the Local Health Authority within the meaning of the said Act for the Health District of Toodyay, doth hereby make the following By-laws:—

## Dairies.

On and after the 1st day of April, 1937, no person shall establish and open a dairy within the area specified in the Schedule hereunder, and the establishment and opening of dairies in such area is hereby prohibited.

## Keeping of Swine.

On and after the 1st day of April, 1937, no person shall keep swine within the area specified hereunder.

## Slaughter-houses, etc.

On and after the 1st day of April, 1937, no person shall establish a slaughter-house, nor shall any person establish a place for storing, drying, or preserving bones, hides, hoofs, or skins within the area specified in the Schedule hereunder.

A By-law prescribing the Regulations, manner, and keeping of Goats within the Townsite of Broome, or at large, within any road, street, reserve, or any other place vested in or under the control of the Broome Road Board within the said Townsite.

THE Broome Road Board, in pursuance of the powers vested in the said Board under and by virtue of "The Road Districts Act, 1919-1934," and of every other authority enabling it in that behalf, doth hereby make and publish the following By-law, to have effect within the Townsite of Broome:

1. The owner or keeper of any goat or goats shall annually register the same with the Board and pay to the Board an annual registration fee of sixpence for each goat so registered.

2. Every registration shall be in force from the date of registration to the thirtieth day of June next following the date of registration.

3. Every registration shall be effected within thirty days after the publication in the *Government Gazette* of this By-law, and thereafter within 14 days after the close of each financial year ending the thirtieth day of June.

4. The Board shall supply a suitable disc for each registered goat and such disc shall be attached by the owner or keeper to a collar fastened and kept round the neck of the goat.

5. Any goat, whether registered and wearing the prescribed disc or unregistered, found at large within the Townsite of Broome may be seized, impounded, or destroyed by any officer or person under the instructions of the Board.

6. The owner or keeper of any goat or goats so seized, impounded, or destroyed shall forfeit a penalty not exceeding one pound for every goat so found at large, in addition to all costs and expenses incurred in so seizing, impounding, or destroying such goat or goats.

7. The Board reserves the right to restrict the number of goats to be kept by any one householder within the Townsite of Broome and to refuse registration accordingly.

8. The Board may at any time refuse the registration of any male goat or goats, unless proof is given to the satisfaction of the Board that the same is or are required for stud purposes.

The Board may regulate the supply of the water at any well, dam, tank, or other watering place under its authority or control within its District for domestic or other purposes, by affixing a notice, duly signed by the secretary, at such well, dam, tank, or other watering place.

Any person using or attempting to use any water for other purposes than those for which it has been set aside by the Board, unless specially authorised by the Board in writing, shall be guilty of an offence against this By-law, and shall be liable upon conviction to pay any charge for such water as may have been prescribed by the Board, in addition to being liable for a penalty not exceeding Twenty pounds.

## Serpentine-Jarrahdale Road Board.

## By-laws of the Serpentine-Jarrahdale Road Board.

P.W. 326/26.

WHEREAS by "The Road Districts Act, 1919-1934," the Road Board of any District is empowered to make By-laws for all or any purposes in the said Act mentioned, the Serpentine-Jarrahdale Road Board, in pursuance of the powers vested in the said Board, under and by virtue of the said Act and of every other authority enabling it in that behalf, doth hereby make and publish the following By-laws:—

## Interpretations.

1. In these By-laws the interpretations set out in the Road Districts Act shall apply, in addition to which the following terms shall, unless the context otherwise indicates, bear the meaning set against them in the Road Districts Act, or respectively, that is to say:—

"The Act"—"The Road Districts Act, 1919-1934," and all amendments thereto which may hereafter come into force.

"Board"—The Serpentine Jarrahdale Road Board.

"Board Room"—The office, hall, or building in which the meeting of the Board is held from time to time.

"District"—The District under the jurisdiction of the Serpentine Jarrahdale Road Board.

"Footpath" or "Footway"—That part of a road set apart for the sole use of foot passengers, whether the same be made or kerbed or otherwise, and not less than 6 feet wide. Wherever a road has been formed or constructed and/or drained, the portion of the road between the drain and the fence on each side shall be set apart for the sole use of foot passengers, with a minimum width of 6 feet, and in each case shall constitute the footpath.

"Secretary"—The Secretary of the Board.

All other interpretations to be as prescribed in the Road Districts Act or other Acts or Regulations thereunder.

## Duties of Secretary.

2. The duties of the secretary shall be:—

- (a) to attend all Board meetings;
- (b) to attend all Committee meetings;
- (c) to take notes of minutes and prepare reports of Committees;
- (d) to conduct all correspondence, and to give the other officials instructions, as directed by the minutes, and to carry out the resolutions of the Board as contained in such minutes;
- (e) to answer all questions on the Board's business;
- (f) to see that the accounts and balance sheets are prepared and published yearly, and to carry out any other duties specified under "The Road Districts Act, 1919-1934," or amendments thereto;
- (g) to prepare and place before the Board the financial statement to date at the end of each month of the financial year;
- (h) to supervise the preparation of the Rate Books and the Board's electoral lists; to examine proof of the latter, and to arrange for distribution of the copies prior to the elections; also to attend all Courts of Revision or Appeal; to make the necessary arrangements for the elections; to issue instructions to the engineer in accordance with the Board's resolutions;
- (i) to summons members to Board and Committee meetings;
- (j) to keep all the books up to date, in accordance with instructions issued by the Minister and additional instructions of the Board; to balance all books in ink every month;
- (k) to check all accounts sent into the Board, and to see that all accounts for works have stated in them the authority under which such works have been done, and to check all returns made by the collector or other of the Board's officers, and to see that the counterfoils of the receipt book accompany all returns; to supervise and attend to the

due payment of all moneys coming through the hands of the Board's officers and payable to the credit of the Board;

- (l) to report at the Board at its next meeting any officer neglecting to make his returns as provided, with the necessary vouchers attached thereto;
- (m) to see that no payments to the credit of the Board's banking account shall be made except through the secretary, or such other officer as may be acting temporarily in that capacity;
- (n) to readily and cheerfully obey all lawful commands or orders of the Board, and to attend to all other matters affecting the finances and welfare of the Board not herein specified;
- (o) to see that all bonds and other forms of security to be taken from the contractors are prepared, and that the security required from servants is taken within due time, and to report on such matters to the Board;
- (p) to report to the Chairman any servant, who has been duly appointed under By-law No. 3, who has been guilty of any neglect of duty, or who is incapable of performing the duties allotted to him, and, if necessary, to suspend or dispense with the services of any other servant, and to duly report with respect to such action to the next ordinary meeting of the Board;
- (q) to exercise, subject to any directions given by the Board or the Chairman thereof, control over all servants of the Board;
- (r) to see that no receipt is on any other than the forms prescribed by the Acts and Regulations under which authority is given for the issue of such receipt;
- (s) to be responsible for the issue of receipts on the proper prescribed forms, and that all receipts issued are in proper sequence;
- (t) to keep in the safe all current books and legal documents when not in actual use; to retain one key of the safe in his own personal custody, and to deposit the duplicate with the Board's bankers in the joint name of the Chairman and one other member of the Board; to lock in the safe at the end of each day such of the Board moneys as remains unbanked; to enter in the bank deposit book full details of all cheques and other moneys, and to obtain a proper deposit receipt thereto.

## Engineer's Duties.

3. The duties of the engineer shall be:—

- (a) to promptly attend to all instructions received through the secretary;
- (b) to prepare proper plans and specifications for all works and improvements as regards roads, bridges, culverts, buildings or premises under the control of the Board situate within the District; examine all material to be employed in such works, and see the same faithfully and properly executed and performed; lay out such work as to height, lines, levels, and dimensions, and watch the progress and formation thereof; submit all specifications and plans to the Board before tenders are called;
- (c) to see that the work of cleaning and repairing all public roads and footways is properly carried out;
- (d) to see that no labourers are engaged but those who are able-bodied and sober, and to immediately discharge any labourer guilty of disobedience, insubordination, and found incapable of performing the duties allotted to him;
- (e) to see that all drains, sewers, culverts, and bridges are maintained in a state of efficiency;
- (f) to see that all officers under his control carry out their duties efficiently, and to report any departure therefrom;
- (g) to attend all Board meetings and Committee meetings, if required;

- (h) to specially examine all roads throughout the District at least twice a year;
- (i) to render to the secretary, when required, reports and accounts of all matters under his control, and to supply monthly or oftener, if required, to the Board, returns of all work completed or in progress, with remarks thereon.

#### Appointment of Officers.

4. No permanent appointment shall be made to any office under the Board until after an advertisement has been published in one or more local newspapers calling for applications from persons competent to fill such appointment. All appointments shall be made by a resolution passed by the Board. The election of all officers shall be by a show of hands, unless a ballot is demanded; the salary or allowance attached to the office under consideration of the Board shall in all cases be fixed prior to the appointment, and the salary of any officer, when fixed, shall not at any time be considered with a view to its increase or reduction, unless specially authorised by a meeting of the Board.

5. All complaints against servants of the Board must be in writing, and must in every case be signed by the person or persons complaining, and no notice whatsoever shall be taken of any complaint not made in accordance with this By-law; all such complaints as are receivable shall be addressed to the Chairman, who, upon receipt of such complaints, shall have the power to investigate the same, and he shall report thereon to the Board at its next meeting.

#### Meetings and Proceedings.

6. Seven days' notice in writing shall be given by the Chairman or secretary of ordinary or regular meetings, and also of every meeting adjourned for a term exceeding six days.

7. Meetings of the Board shall be of two kinds—"Ordinary" and "Special." Ordinary meetings are those held regularly in pursuance of these By-laws, for the transaction of the general business of the Board, including adjourned meetings, at which uncompleted business shall be completed, together with other business considered necessary. Special meetings are those called under Section 131 of the Act, and shall include those called by the Chairman in response to a requisition signed by three members, or on his own behalf, and the notices for such special meetings shall have such special business specified thereon, and nothing shall be discussed at any special meeting other than the special business specified on the notice of the meeting; provided, however, that any matter of emergency may be discussed on the ruling of the Chairman and with the consent of those present.

The ratepayers' meeting shall consist of one called under Section 144 of the Act, and the Standing Orders, so far as the Act allows, shall apply to the proceedings, but the provisions of the Act shall be first observed.

The Chairman, if present, shall preside at all meetings of the ratepayers and of the Board, and in his absence, or if, after being present, he shall retire, the person to preside at a meeting of ratepayers shall be a ratepayer chosen by the ratepayers present, and the person to preside at a meeting of the Board shall be the Vice-Chairman, or in his absence, a member chosen by the majority of those present.

8. Ordinary meetings shall be held at the Office of the Board or at some other convenient place, at 2 p.m. on the third Saturday of each month, or on such day and at such hour as may be appointed from time to time by resolution of the Board passed at the previous ordinary meeting of the Board.

9. A special meeting may, on the requisition of three members of the Board, be called at any time in the manner prescribed by the Act, but the Chairman may call a special meeting of the Board as often as he deems proper.

10. No business shall be transacted at any ordinary or special meeting unless a quorum, as specified by the Act, shall be present.

11. At all meetings of the Board, when there is not a quorum present, or when the Board is counted out (which counting out shall take place whenever there shall be less than a quorum present, or within 30 minutes after the time for which the meeting is called)

such circumstances, together with the names of the members then present, shall be recorded in the Minute Book.

12. At any meeting of the Board it shall rest with the majority of the members of the Board present to exclude the public from such meetings, when in their opinion it is expedient to do so.

13. The first business at all ordinary meetings of the Board shall be the consideration of the minutes of the preceding meeting, with a view of their confirmation. Reading of the minutes may be dispensed with, if members have been supplied with a copy thereof at least three days prior to the meeting at which such are to be confirmed. No discussion shall take place upon the minutes of the proceedings, except as to their accuracy, or for the rectification of a clerical error.

14. The Minute Book prescribed by the Act shall be kept, in which any item of business transacted by the Board at the meeting shall be entered by the secretary; provided that pasting or permanently affixing the minutes of the meeting of the Board to the leaves of a book shall be equivalent to entry therein. Minutes of both special and ordinary meetings shall be confirmed at the next succeeding ordinary meeting of the Board.

15. Each member (including the Chairman) shall have one vote and, in the case of an equality of votes, the question shall pass in the negative. In all other cases all questions at such meetings shall be decided by a majority of the votes of the members present. All motions and amendments shall be decided by a show of hands, unless a division is demanded, before the next business is proceeded with.

#### Standing Orders.

16. The order of business at all ordinary meetings of the Board shall be as follows, that is to say:—

- (a) reading of minutes of last ordinary, also special meetings, and confirmation thereof;
- (b) consideration of business arising out of the minutes;
- (c) the Chairman shall have the right of directing attention at any meeting to any matter or subject within the jurisdiction or official cognisance of the Board, by a minute signed by himself, and such minute shall, when introduced, take precedence over all business before or to come before the Board, and the adoption thereof shall be put by him from the Chair, as a motion, without being seconded, but he shall confine himself to the questions contained therein.
- (d) reading of correspondence received and despatched, and taking action, as may be deemed expedient, in regard thereto;
- (e) reports of sub-committees or officers;
- (f) questions of which due notice has been given by members or officers of the Board;
- (g) deputations and presentation of petitions or memorials, and consideration thereof;
- (h) consideration of tenders and ratification of contracts;
- (i) motions of which previous notice has been given;
- (j) motions without notice, by leave of the Board;
- (k) general business;
- (l) notice of motions;
- (m) presentation of monthly statement and passing of accounts for payment.

17. In the event of any member having urgent business to place before the meeting, he may move the suspension of the Standing Orders, and, if agreed to by the Board, such business shall take precedence of all other business.

18. Every petition or memorial shall be respectful and temperate in its language, and shall be presented to the Board by a member only; and any member presenting a petition or memorial shall acquaint himself with the contents thereof, and ascertain that it does not contain language disrespectful to the Board; the nature or prayer of any petition or memorial shall be stated to the Board by the member presenting same.

19. Tenders for work shall be opened and dealt with when the subject-matter of the tenders comes on to be considered at the meeting of the Board, or by a Committee appointed for the purpose. The Board may require a deposit of 5 per cent. of the amount of each tender to accompany each tender, or the Board may require two satisfactory bonds lodged with the Board.

20. A member, when speaking, shall not digress from the subject of debate.

21. All correspondence to the Board shall be addressed to the secretary and submitted to the Board; no letter addressed to the Board shall be presented or read by a member.

22. (a) If, in a report of a Committee, distinct recommendations are made, the decision of the Board may be taken separately on each recommendation.

(b) Any report of a Committee, or any portion of such report may be amended by the Board, in any manner it may think fit, or may be referred back to the Committee for further consideration.

(c) The recommendation of any Committee, when adopted by the Board, shall be a resolution of the Board.

23. When the Chairman rises in his place during the progress of a debate, any member then speaking or offering to speak shall immediately resume his seat, and every member shall preserve strict silence so that the Chairman may be heard without interruption, but the member who was speaking may resume when the Chairman takes his seat.

24. In the absence of any member who has placed a notice of motion on the business paper for any meeting, any other member may at such meeting move the same, or such motion may be deferred until the next ordinary meeting of the Board.

25. If any member has been granted leave of absence, and any matter comes before the Board for discussion, the subject-matter of which is of particular interest to the absent member, unless in the opinion of the Chairman it is a matter of urgency, such matter shall be held over until the absent member is present; provided that, if he is not present at the meeting at which the matter again came before the Board, no discussion shall take place until the next meeting of the Board, when such matter shall be dealt with.

26. Except as elsewhere provided, no motion, after being placed on the business paper, shall be withdrawn without the consent of the Board.

27. No motion shall be debated unless or until it has been seconded.

28. When a motion has been proposed and seconded it shall become subject to the control of the Board, and shall not be withdrawn without the consent of the Board.

29. When a motion has been proposed and seconded, any member shall be at liberty to move an amendment thereon, but no such amendment shall be debated unless or until it has been seconded. After an amendment has been moved and seconded, any member desirous of moving a further amendment may give notice of his intention so to do and may briefly state his proposed amendment and the effect thereof.

30. No motion or amendment shall be debated unless or until it has been reduced to writing, if the Chairman so directs.

31. In submitting a motion or amendment the Chairman shall put the question first in the affirmative and then in the negative.

32. If an amendment has been carried, the question as amended shall itself become the question before the Board, whereupon any further amendment upon such question may be moved.

33. If an amendment, whether upon an original question or amended as aforesaid, has been negatived, then a further amendment may be moved to the question to which such first-mentioned amendment was moved, and so on until there are no further amendments, and the question is then decided by the final vote in the affirmative or in the negative; provided that no more than one question and one proposed amendment thereof shall be before the Board at any one time.

34. No discussion shall be permitted upon any motion for the adjournment of the Board. If, upon the question being put on any such motion the same is negatived, the subject then under consideration or next on the business paper shall be discussed, and it shall not be competent for any member to again move for adjournment until half an hour has elapsed from the time of moving the one that has been negatived.

35. On resuming any discussion that has been adjourned, the mover of such adjournment shall be entitled, if he has not already spoken on the subject under discussion, to speak first.

36. Every such question shall be put (categorically) and without argument.

37. No discussion shall be permitted respecting any reply or refusal to reply to any question.

38. Members shall on all occasions, when at a meeting, address the Chairman and secretary by their official designations, such as Chairman or secretary, as the case may be, and, with the exception of the Chairman, shall rise in their places and stand while speaking, except when prevented from doing so by bodily infirmity.

39. No member shall be interrupted while speaking, except for the purpose of calling him to order, as hereinafter provided, or in pursuance of By-law No. 23.

40. The mover of an original motion shall have the right of general reply to all observations which have been made in reference to such motion, or to any amendment moved thereon, as well as the right to speak upon every such amendment. Every member, other than the mover of the original motion, shall have the right to speak once upon such motion, and once upon every amendment moved thereon. No member shall, without the consent of the Board, speak more than once upon any one question, or for a period of more than ten minutes at any one time, unless when misrepresented or misunderstood, in which case he may be permitted to explain without adding any further observations than may be necessary for the purpose of explanation.

41. Upon a vote being taken all members present within the Board Room, unless disqualified from voting, shall, and the Chairman, unless so disqualified, may, upon the question being put, record their respective votes in the affirmative or negative, as each shall deem desirable, but if a member other than the Chairman neglects or refuses to vote, his vote shall be counted for the negative.

42. (a) All questions shall, if not otherwise decided by law, be determined thus:—Upon a question being put, those in favour shall say "Aye" and those against "No," and the Chairman shall declare whether the "Ayes" or "Noes" have determined the question; or, if the Chairman prefers, he may call for a show of hands for and against the question. The decision of the Chairman shall be final and conclusive, unless such decision be immediately challenged and two members rise and demand a division.

(b) Where there is only one dissentient, he may request that his name be recorded in the minutes as opposed to the motion, and it shall be so recorded.

43. Upon a division being called for, the question shall be put in the affirmative first and then in the negative, and the Chairman and all the members present shall vote by a show of hands, and the names and the votes of the Chairman and members present shall be recorded in the minutes by the secretary. Any member of the Board present when a division is called for, who does not in the manner above indicated vote on such motion, not being disqualified by law from voting, shall have his vote counted in the negative.

44. The Chairman shall be at liberty to put any question as often as may be necessary, to enable him to form his opinion as to the result of voting, and declare the same.

45. Any member who at any meeting of the Board or any Committee commits a breach of any By-law, or who moves or attempts to move any motion or amendment embodying any matter beyond the legal jurisdiction of the Board or Committee, or who in any other way raises or attempts to raise any question, or addresses or attempts to address the Board or Committee upon any subject which the Board or Committee has no legal right to discuss, or who uses any language which according to the common usage of gentlemen would be held to be disorderly, or makes use of any expression inconsistent with good order and decorum, or who says or does anything calculated to bring the Board or Committee into contempt, shall be guilty of an act of disorder.

46. The Chairman, when called upon to decide a point of order or practice, shall state the rule or precedent applicable to the case, without further argument or comment, and his decision shall be final in that particular case. If the ruling of the Chairman be disagreed with, then the usual Parliamentary procedure may be adopted.

47. Any member having been called to order by the Chairman more than once for any infringement of any of the provisions of these By-laws, or for any breach of decorum, shall, upon the request of the Chairman, withdraw from the Board Room for the remainder of the meeting.

48. If disorder arises at any meeting the Chairman may adjourn the meeting for a period of fifteen minutes, and quit the Chair. Then, on resuming, shall, on question put from the Chair, decide without debate whether the business be proceeded with or not.

49. The Board may at any time appoint one or more members as a Committee to inquire into any matter, and make a report and recommendation thereon, but no Committee shall incur a financial liability or in any way commit the Board to any responsibility whatever, without express and specific authority conferred by the By-laws or a resolution of the Board.

50-1. At the meeting of the Board in each year a Finance and Works Committee shall be appointed; the Finance Committee shall meet at a time and place to be decided at the preceding general meeting, and shall carry out the duties specified in the regulations and report to the Works Committee on the funds available for future works.

52. All accounts, bills, and vouchers, except as hereinafter provided, shall be submitted to the Finance Committee meeting, and the ordinary Board meeting, and, after being certified as correct, shall be paid by cheque: Provided that the Board may by resolution authorise the payment of wages, emergency accounts, and progress contract payments to be made by cheque between meetings; all such accounts to be placed before the Finance Committee at its next meeting, who shall review same, and, if satisfied with the necessity of the action taken, include same in their report.

53. An account shall be opened with such bank as the Board may from time to time direct, and all moneys received, from whatever source, with the exception of moneys granted by the Government, shall be paid into such bank to the credit of the Board, and no account shall be paid by other than cheque signed by the Chairman and one member of the Board and countersigned by the secretary: Provided that payments less than two pounds may be made in cash from petty cash account kept for that purpose. Such petty cash account shall be kept on the imprest system, and the amount thereof shall be decided by the Board from time to time.

54. All moneys belonging to the Board shall, within twenty-four hours, or such time as specified by the Board, after they come into the hands of any officer, servant, or clerk, be paid to the secretary or responsible officer directed by the Board to receive same.

55. In the case of emergency the following amounts may be expended by the persons mentioned:—Chairman alone, up to £3; one member alone, up to £2; Chairman and one member, up to £5; two members, up to £4; by the engineer, up to £10, which expenditure shall, if found correct, be confirmed by the next ordinary meeting.

56. Every item of expenditure, and every liability incurred by any Committee or member of the Board, otherwise than under the Act or of these By-laws, shall be deemed unlawful expenditure and a breach of this By-law by that person.

57. The Common Seal of the Board shall be kept in the Board's safe. The Common Seal shall not be affixed to any deed or to any other instrument, except by a resolution of the Board.

#### Offences, Omissions or Neglects.

58. Any person guilty of any of the following offences shall on conviction thereof pay a penalty not exceeding £20:—

- (a) Damaging or destroying any dam, well, tank, pump, windmill, windlass, bucket, rope, stand-pipe, meter, stop valve, piping, troughing, fence or gate under the control of the Board.
- (b) Placing any placard or other document, writing or printing on, or otherwise defacing any house or building abutting or contiguous to a public road, or on any wall, fence, gate or lamp-post, without the consent of the owner or occupier thereof.
- (c) Throwing or discharging any stone or any other missile in any road to the damage or danger of any person.
- (d) Blasting any rock, stone or timber, in or near any road, without the permission of the Board, and not attending to such directions in regard thereto given by such Board.

59. No person shall make or leave a fire near any road or track or reserve under the jurisdiction of the Board, without taking proper precautions against such fire spreading, and any person offending against this By-law shall upon conviction pay a penalty not exceeding £20.

60. No person shall set fire to any standing tree upon or near any road or track, any such offender shall upon conviction pay a penalty not exceeding £20. Provided, however, that any such tree may be set alight if the permission of the secretary or Chairman (who shall have power to delegate their authority to grant such permission) is first obtained, and that such precautions as are necessary are observed by the person so lighting such tree.

61. Any person who shall light a fire (except by order of the Board), or shall place any rushes, bushes, or other inflammable substance, under, near, or against any bridge or culvert in the District for the purpose of making a camp or sleeping place, or for any other purpose, shall be liable to a penalty not exceeding £20.

62. No person, without having first obtained the permission of the Board, shall break up, cut down, damage, destroy, or injure any footpath, gutter, drain, culvert, bridge, road, public way, tree, plant, gate, fence, post, lantern, lamp-post, implements, materials, buildings, or other property of the Board, or under the control thereof.

63. Any person who shall carelessly, wilfully, or wantonly injure, destroy, carry away, or remove from its place any tree, shrub, or plant standing in any of the roads, enclosures, public places of or belong to or under the control of the Board, or who shall carelessly, wilfully, or wantonly injure, destroy, carry away, or remove out of its place, or ride or drive against any of the treeguards, fences, or other protection to any such trees, shrubs, or plants as aforesaid, shall forfeit for every such offence a penalty not more than Ten pounds.

#### Park Lands, Reserves, and Recreation Grounds.

64. All park lands and recreation grounds shall be open to the public daily for recreation purposes, excepting as otherwise provided for in these By-laws. The Board shall have the power to grant the exclusive right to use any park lands, recreation grounds or reserves placed under its control within the District for holding public sports or amusements to any responsible person or persons; any person or persons obtaining such right shall be responsible for the care of all such fences, buildings, trees, or other improvements upon or enclosing such park lands, recreation grounds, or reserves, and shall pay the Board a fee to be fixed for admission on such occasions.

65. No horse, cattle, or vehicle shall be allowed upon any park lands or recreation grounds, without the written permission of the Board.

66. All persons using or being upon any park lands, recreation grounds, or reserves shall at all times conduct themselves in a becoming manner, persons creating any disturbance or annoyance to the public shall be liable to be expelled from such lands by any police constable or officer of the Board.

67. The Board may in its discretion prohibit any games or gymnastics from being played or carried on by any person or persons upon any park lands, recreation grounds, or reserves on any Sunday, Christmas Day, or Good Friday.

68. No person shall sell or expose for sale any goods, wares, fruit, or merchandise in any park lands, recreation grounds, or reserves without having first obtained the permission of the Board and shall pay a fee, the amount of which shall not exceed Ten pounds.

69. The Board, or any person duly authorised, may make charges for admission to any reserve, recreation ground, or park lands, or to any specified portion thereof, but such charges shall not exceed 5s. for adults, 2s. 6d. for children under 15 years, with free entry for children under six years of age (if accompanied), and for horses and vehicles 2s. 6d. each.

70. Such person to whom the use of any reserve is given for picnic sports, races, or other use, shall be held responsible for the removal of all rubbish brought thereon, on the occasion of such use, and a deposit not exceeding £5 may be asked as a guarantee for the due removal of such rubbish. On the removal of such rubbish to the satisfaction of the Board, the deposit shall be returned.

71. No person shall damage or injure any fence, building, tree, shrub, or plant in any park lands, recreation grounds, or reserves. Any person offending against this By-law shall forfeit and pay upon conviction a penalty not exceeding £10 for each offence.

72. No person shall, except as hereinafter provided, frequent any reserve for the purpose of camping, lodging, or tarrying thereon.

73. Notwithstanding the provisions of Section 72 of these By-laws, camping may be permitted in areas set aside for the purpose by the Board, but not elsewhere, upon the issue of permission signed by the Board's secretary and subject to the following conditions:—

- (a) The Board may at any time make and declare a schedule of charges and issue permits to persons desirous of camping on any such area.
- (b) No person shall sublet any camp, or sell, give, or otherwise dispose of any permit to any other person.
- (c) Except by the permission of the secretary, no person shall bring into or keep within the camping area any animal or bird.
- (d) No person shall bring into or keep or consume any intoxicating liquor in the camping area.
- (e) Campers must keep the area covered by their permit in a clean and sanitary condition at all times. All rubbish capable of destruction by fire must be burned by the occupier in the approved fireplaces.
- (f) All campers must use the sanitary conveniences provided, and in no circumstances will improvised conveniences on individual camping sites be permitted.
- (g) Camping permits may at any time be withdrawn by the secretary, if in his opinion a breach of any of these By-laws has been committed, or if in his opinion it is desirable that the permit shall be terminated. In the event of the termination hereunder, the rental paid shall be forfeited to the Board, and no compensation shall be paid or claimable for loss, damage, or inconvenience suffered by reason of the withdrawal of the permit.
- (h) Subject to the right of the secretary of the Board, or any person acting under his instructions, or any police constable, to enter any camping site at any time, no person shall enter into or remain within such camping site, except with the permission of the holder of the permit.
- (i) No fires shall be lighted on any camping area, except in places approved by the secretary.

#### Fencing.

74. The board may require owners of land within any townsite or prescribed area within the District to fence the boundaries thereof abutting on any road, and prescribe the manner in which the fence is to be erected and maintained, and the description, style, and material of any such fence.

75. The owner of any land within the District, other than within a townsite, whose land abuts upon the intersection of two roads, shall, unless such land be already fenced at the date of passing this By-law, fence the corner only in such a manner as will truncate the corner of the intersection to a distance of at least one chain on either side.

76. The owners of vacant townsite lots within the District shall, when required by the Board, clear such lots of trees, scrub, and undergrowth wholly or partially and within such time as may be directed by the Board. Penalty for breach not exceeding Five pounds.

#### Fires.

77. (a) The Board may appoint the time for the prohibition of lighting fires in the bush, which after being duly advertised in the *Government Gazette* and in the local paper, shall be binding within the District, and the Board may proceed against any person disobeying this By-law. Penalty: Twenty pounds.

(b) The Board may, on being shown cause, temporarily suspend this By-law.

#### Sand and Timber, Gravel, etc.

78. No person shall remove any timber, sand, gravel, soil, or other material from any land belonging to or in charge of or under control of the Board, unless he shall be the holder of a license in the form set out in Schedule A hereto. Any person who shall so cut or remove timber, sand, gravel, soil, etc., without being the holder of a license as aforesaid, shall forfeit and pay upon conviction a penalty not exceeding Five pounds, and shall also pay to the Board the value of the materials removed.

#### Construction of Footways, Crossing Places, etc.

79. It shall be lawful for the owner of any land fronting or adjoining any road or public way requiring access thereto with horses or vehicles from such road to such land across any existing footway, having first had and obtained the permission of the Board, to construct a crossing of a width not less than 12 feet or more than 18 feet, using reinforced concrete pipes of approved quality, properly laid and cement-joined, with concrete inlet and outlet aprons, and stone facings laid in cement or sound jarrah bedlogs, with 3-inch jarrah decking, secured with ewbank spikes, with inlet and outlet wings to the full depth of the drain and 3 feet long, the diameter of the pipes and the capacity of the bedlog culverts and the level and position to be as directed by the Board. A covering of gravel of approved quality not less than 3 inches in thickness, consolidated, and the full width of the culvert, extending for a distance of 28 feet, measured at right angles from the boundary of such lands towards the centre of the road, shall be provided if the Board so direct. The whole of the work to be done to the satisfaction of the Board. In lieu of the aforementioned concrete pipe or jarrah culvert, the Board may, if it thinks fit, permit the formation of a spoon drain, of such dimensions and to such specification as it may deem requisite. Provided also, that the Board may, at the request of any owner as aforesaid, supply and construct a crossing, provided the owner shall pay at least one half of the cost of such crossing.

80. Every person who wilfully and without lawful excuse shall ride or drive, or wheel any carriage, cart, or other vehicles, or shall ride any bicycle or tricycle or motor upon or along or across any footway, kerbing, or water channel or gutter, by the side of any street, road, or public way, save in each case upon, or by, or at some properly constructed crossing shall forfeit and pay upon conviction a sum not exceeding Five pounds, and shall also pay to the Board such sums, not exceeding Ten pounds, by way of compensation for any damage done to the footway, kerbing, or channel, as the Justice adjudicating upon the information shall on the hearing thereof order.

#### Lamp Posts, etc.

81. No lamp-post, bridle post, watertrough, telegraph, telephone, or electric lighting pole or flagstaff shall be erected by any person in any street or road without the written consent of the Board, and upon consent being obtained shall be placed in such a position, and shall be painted at least once in every three years, as may be directed by the Board, and the Board may order the removal by the owners of all bent, dangerous, or unsightly posts or poles. Any person offending against this By-law shall forfeit and pay on conviction a penalty not exceeding Two pounds for every such offence.

#### Lighting.

82. Any unauthorised person who shall put out when lighted, or in any other way interfere with any lamp belonging to the Board, or any person who shall damage or destroy any such lamp shall pay, in addition to the value of such damage, if any, on conviction a sum not exceeding Five pounds.

#### Removal of Obstructing Verandahs, etc.

83. Any verandah or balcony which obstructs the footway or roadway, or is dangerous, and all other obstructions on the footway or roadways, or overhanging same, shall be removed, when ordered, within such time as shall be notified by the Board, and all expenses incurred in removing same shall be borne by the owner or occupier of such verandah, balcony, or otherwise, and any person whatsoever interfering or obstructing any person or officer employed by the Board in carrying out this By-law, on conviction, shall pay a penalty not exceeding Ten pounds.

#### Removal of Encroachments or Obstructions.

84. On the order of the Board the secretary or other appointed officer may direct the removal, within 14 days, of any building, fence, or any other obstruction or encroachment in or upon any street, road, lane or public place under control of the Board. In any case where, after service of notice of such removal, any such obstruction or encroachment has not been removed

within the time specified, it shall be lawful for the officer appointed by the Board to remove same, at the cost of the person so offending, and to proceed against the offender for the breach of this By-law, the penalty for breach of which shall not be more than Twenty pounds.

#### Damaging Roads.

85. No person shall, either wilfully or negligently, damage or destroy by means of a horse team or any other means any road under construction or repair; any person found guilty of such damage or destruction shall be liable to a penalty not exceeding Twenty pounds. Any person who draws upon any road any timber, stone, or other material other than a wheeled vehicle, or suffers such material, when carried principally or part upon a wheeled vehicle, or suffers such material to drag upon a road, or draws upon a road a whim or timber carriage any portion of which or any portions of chains attached thereto, or any portion of other attachment trails or drags upon a road, shall be deemed guilty of an offence against these By-laws, and shall be liable to a penalty not exceeding Five pounds for every such offence.

86. Any person taking any plough, cultivator, or other implement over or along a road and thereby damaging or marking such road in such a manner which in the opinion of the Board may indirectly cause ultimate damage to the road, shall be liable to a penalty not exceeding Five pounds.

87. No person shall drive upon any road a vehicle the wheel or wheels of which are locked, unless there is placed at the bottom of such wheel a protection to prevent damage to such road; and any person contravening this By-law shall be liable to a penalty not exceeding Five pounds.

#### Depasturing of Cattle, etc.

88. Any person who shall turn loose or suffer any kind of animal belonging to him or under his control to stray or go about, or to be tethered or depastured in or upon any road, recreation ground, or reserve, shall upon conviction be liable to a penalty not exceeding Five pounds.

89. No animal shall be allowed to stray on any road or place, and no animal suffering from any infectious or contagious disease shall be ridden or driven on any road within the District. Any animal so suffering may be slaughtered and destroyed at the owner's expense.

#### Heavy Loading on Culverts, etc.

90. The owner of every vehicle which, together with its load shall weigh more than seven and one-half tons, shall travel the roads, bridges, and culverts within the District at his own risk, and shall be liable to pay for all damage done.

91. The Board may by notice affixed to any bridge or culvert declare the maximum weight of any engine, agricultural, or other machine or vehicle of any kind, and of any load or material which shall be permitted to cross such culvert or bridge, and also the pace at which such engine, machine, vehicle shall be driven, led, or taken over any such bridge or culvert, and any person who shall cross any bridge or culvert in contravention of this By-law shall, in addition to any liability for damage he may have caused, be liable to a penalty not exceeding Ten pounds.

#### Stalls, Hawkers, etc.

92. No person, unless he be the holder of a stall license issued by the Board, and shall have paid the prescribed fee therefor, shall place or erect within the District any movable, temporarily fixed or fixed stall, including any vehicle used or intended to be used as a stall for the sale of any meat, game, poultry, fruit, vegetables, food or any articles of merchandise, in or near any street or way, or in or on any footpath, right-of-way or reserve.

The Board reserves the right to allocate the position to be occupied by any such stall or stand.

The fees for a stall or stand shall be as prescribed in Schedule B hereto.

License must be produced on demand to any police officer or officer of the Board.

93. No person shall hawk, peddle, or cry foodstuffs or wares of any description within the District unless he shall be the holder of a Hawker's License issued by the Board.

Provided that nothing in this By-law shall be read to apply to any recognised storekeeper within the District who may be fulfilling by delivery *bona fide* orders for the goods of his business or store, or to any rate-payer of the District who may be disposing of the *bona fide* primary products of his or her property situated within the District.

License must be produced on demand to any police officer or officer of the Board.

The fees for a Hawker's License shall be as prescribed in Schedule B hereto.

94. Neither Stall Licenses nor Hawkers' Licenses are in any way transferable, either by way of loan, gift, sale or assignment.

#### Discount for Rates.

95. The Board may allow discount, not exceeding five per centum for prompt payment of rates, but such discount will be allowed in respect of general rates only (not including supplementary rates), and shall not be allowed in respect of rates not paid on or before the 30th day of September of the year in which the rates have been imposed: Provided that the Minister, under special circumstances, may agree to an extension of time for a period not exceeding one month, in which case the Board may allow such discount on rates as aforesaid paid on or before the last day to which the Minister has so extended the time.

#### Pounds.

96. Any person who shall break, damage, or destroy any pound, fence, gate lock, shed, trough, or premises shall on conviction be liable to a penalty not exceeding Ten pounds.

97. Any person who shall break, obliterate, deface, or damage any table of fees, placard, or other notice required by "The Cattle Trespass, Fencing and Impounding Act, 1882," or any subsequent amendments thereof, shall be guilty of an offence against this By-law and shall on conviction be liable to a penalty not exceeding Five pounds.

98. Any person who shall release or attempt to release any cattle which shall be lawfully seized for the purpose of being impounded, whether such cattle shall be in the pound or on the way to or from such pound, shall be guilty of an offence against this By-law and shall on conviction be liable to a penalty not exceeding Five pounds.

#### Bathing.

99. No person shall bathe in any open dam, pool, or open public water on any land or road within control of the Board, nor within clear sight thereof, unless he shall be clothed in a suitable bathing costume or clothes. Any person offending against any provision of this By-law shall be liable on conviction to a penalty not exceeding Twenty pounds.

#### Damage to Notices, Placards, etc.

100. No person shall obliterate, deface, or damage any table of fees, placard, or any other notice published by the Board in accordance with the provisions of any Act. Any person offending against this By-law shall on conviction be liable to a penalty not exceeding Five pounds.

#### Water Supply.

101. Any person who shall waste or allow water to escape, foul, or pollute any water contained in any bore, pipe, tank, or place of storage, shall be guilty of an offence against this By-law, and shall on conviction be liable to a penalty not exceeding Twenty pounds, in addition to any sum which he may be legally required to pay as damages.

102. No person shall pollute or cause to be polluted any watercourse, pool, well, tank, reservoir, or other water within the District.

103. Any person or persons leaving open a lid of any well in the District shall be guilty of an offence against this By-law, and notwithstanding any civil remedy for damage so caused shall be liable on conviction to a penalty not exceeding Five pounds.

104. Any person who shall remove any water from any bore, well, pipe, tank, standpipe, or other place of storage under the control of the Board, except for direct watering of stock, or for *bona fide* household use, or for camping purposes, or except with the written consent of the Board and payment thereon of such reasonable fee as may be demanded, shall forfeit and pay on conviction a penalty not exceeding Five pounds for each such offence.



Watercourses.

105. No person shall cause or allow any obstruction in any watercourse, water channel, creek or other water passing through or adjoining or abutting on his property, either by the construction of permanent or temporary weirs or dams, or by allowing any accumulation of rubbish, soil, sand, or dead or growing scrub or timber, and shall at least once in every year so clean and maintain such watercourses, water channels or creeks so as to retain their full natural discharging capacity. No person shall alter or deviate in any way the course of any watercourse, channel or creek, without first obtaining the permission of the Board in writing.

Licenses.

106. The several licenses mentioned in these By-laws may be granted by the Board for such periods not exceeding twelve months, or for such purposes, irrespective of any period or duration, and upon payment of such fees as may be prescribed; and if any person holding any such license shall make default in any of the conditions contained in such license, the license shall thereupon become null and void, and the fees thereof shall be forfeited to the Board, and such person shall, in the event of any breach of such license, be guilty of an offence against this By-law, and shall on conviction thereof be liable to a penalty not exceeding Five pounds.

Control of Road Board Hall.

107. Application for the hiring of the hall and/or any other buildings under the control of the Board shall be made to the Secretary, who shall issue a receipt for all moneys relating to such hire, and such hire fee shall be paid in advance by the applicant.

108. The name and place of the abode of the actual person or persons hiring the building and effects, if any, shall be given at the time of the application.

109. The fees and hire charges shall be as set out by the Board from time to time, and may be exhibited on the notice board, if any, at the building.

110. The hours for which the building or part thereof may be hired shall be:—(a) Day, 9 a.m. to 6 p.m.; night, 6 p.m. to midnight; (b) extension of time may be granted on payment of the prescribed fee to the secretary.

111. Hirers may decorate the buildings, using only those fixtures that are especially provided for the purpose, and no person shall drive a nail into any part of the walls, windows, floors, doors, etc., or otherwise deface the building. All decorations must be done during daylight, otherwise a charge of two shillings (2s.) per hour or part thereof shall be made for the use of the lighting. All decorations used in connection with any entertainment must be removed from the premises and disposed of to the satisfaction of the secretary within twenty-four hours of the commencement of the hiring period: provided that, with the consent of the secretary first had and obtained, such decorations may be permitted to remain.

112. The Board may at any time demand that the hirer shall, prior to the term of engagement, deposit an amount estimated to cover the cost of any damage that might occur during the time of hiring and/or to cover the cost of removal and disposal of any decorations not so removed by the hirer within the specified time stated in the preceding section.

113. The Board shall have the right to let or hire, or to refuse to let or hire, any part of the building, fixtures, furniture, or fittings, etc., to any applicant, without assigning any reason for doing so.

114. The Board may at any time cancel any agreement made for the hiring of any part of the building, fixtures, fittings, etc., by giving such reasonable notice in writing as may be possible, but which shall not be less than seven (7) days.

115. The Board may without considering priority of claim of any applicant, determine to which applicant the hire of the building or part thereof shall be granted, in the event of two or more applicants desiring to hire such building or part thereof at the same time and date.

116. The hirer of the building or part thereof shall comply with the provisions of the Health Act, Entertainments Tax Act, Performing Rights Association Act, or any other Act and/or regulation in force for the time being and applicable to such hiring and the use of the building. If in the opinion of the Board, all necessary actions have not been taken to comply with the said Acts or any other Acts in force, the Board may at any time prior to or during the term of engagement, forbid and prevent the use of such building or part thereof. The hirers must accept full responsibility, in

the event of any dispute arising in connection with the provisions of necessities under this By-law or the non-compliance therewith.

117. In the event of the use of the building or any part thereof being forbidden or prevented under the last preceding section, the hirer shall forfeit the full amount of the hire paid, and the Board shall not be responsible to any hirer for the loss or damage incurred or sustained.

118. No spirituous liquors, wine, beer, cider, sherry, stout, etc., shall be brought into and consumed in any part of the building during the term of engagement or period of hire, except by written consent or permission of the Board.

119. Except at a banquet or smoke social, or with written permission of the Board, no person shall smoke any tobacco, cigar, cigarette, or other objectionable substance, nor strike or otherwise ignite any light in any part of the building during any ball, dance, or entertainment, or at any gathering of persons in the said building, whether such person has been admitted by payment of money or otherwise.

120. No offensive person or offensive impersonation or representation of living persons, or anything calculated to cause a disturbance, riot, or breach of peace, shall be permitted in or about the premises.

121. No person shall, in any part of the building or premises—

- (a) enter or be allowed to enter, whilst intoxicated or under the influence of liquor;
- (b) be guilty of any misbehaviour whatsoever;
- (c) use profane or improper language;
- (d) damage, mark, inscribe, indent, or deface any wall, furniture, fittings, or any part of the building. (Any person who does or suffers to be done such damage, shall be liable to pay the cost of such damage in addition to any penalty imposed by these By-laws.);
- (e) stand, loiter, or cause any obstruction whatsoever in the exits or passage-ways.

Any persons so doing shall disperse, upon being requested so to do by the secretary or other authorised person, or by a police constable.

Penalties.

122. Where any person by these By-laws or any of them is required to do or perform any act, and such act is not done, or remains undone or unperformed, it shall be lawful for the Board to perform the same and charge the cost and expenses against the person and the amount thereof may be recovered summarily.

123. Any person who does, permits, or suffers any act, matter, or thing contrary to any of these By-laws, shall be deemed guilty of an offence against these By-laws, and, when not otherwise provided, shall be deemed liable to a penalty not exceeding Twenty pounds for each such offence.

124. All penalties or other sums recovered under the provisions of these By-laws shall, unless otherwise provided, be paid to the Board, and shall become the property of and form part of the ordinary income of the District, except as so much as may be payable to any informer.

THE following Statutes Nos. 36, 37, and 38, which have received the approval of His Excellency the Lieutenant-Governor, are published in the *Government Gazette* in accordance with Section 33 (1) of "The University of Western Australia Act, 1911."

Statute No. 36—Guild of Undergraduates.—New Statute replacing present Statute No. 26, which is repealed.

## Statute No. 36.

1. Throughout this Statute, unless the context otherwise indicates, the following terms have the meanings set against them respectively:—

"Guild"—The Guild of Undergraduates referred to in Section 28 of the University of Western Australia Act.

"Guild Council"—The Council of the Guild referred to in Section 6 of this Statute.

"Regulations"—Regulations made by the Guild under the authority of Section 5 of this Statute.

"University Society"—Any club, society, or association within or connected with the University of Western Australia the name of which contains the word "University" and which admits to membership members of the Guild as such, or any section of them, and any other club, society, or association within or connected with the University which upon its written application is granted recognition as a University society by the Guild Council.

2. The Guild shall be the recognised means of communication—

- (a) between the students or any section of them and the governing authority of the University;
- (b) between the students of this and other Universities;
- (c) between student associations within the University and outside bodies.

3. The objects of the Guild shall be—

- (a) to foster all that tends to the advancement of learning and the ennoblement of life;
- (b) to afford means of social intercourse to students at the University;
- (c) to provide facilities for and to encourage amateur sport at the University and to promote and control sporting contests between teams representative of the University and other bodies;
- (d) to exercise a general supervision and control over all student associations within the University;
- (e) generally to further the common interests of students at the University;
- (f) such other objects as the Guild shall by regulation adopt.

4. (a) All matriculated and unmatriculated students proceeding to a degree or diploma in the University shall be members of the Guild. No other person shall be a member of the Guild.

(b) A certificate signed by the Vice-Chancellor or other authorised officer of the University that a person named therein is or is not a member of the Guild, as the case may be, shall be sufficient evidence of the fact stated.

(c) The Guild may by regulation prescribe conditions upon which persons other than members may be admitted to associate membership, associateship, honorary associateship, and honorary life associateship.

5. The Guild in general meeting or by referendum, and subject in every case to the approval of the Senate, may make, alter, and repeal regulations—

- (a) (1) to provide for the internal administration and organisation of the Guild;
- (2) to delegate to subsidiary organs of the Guild and to University Societies a power to make by-laws and to impose fines for breach thereof; provided that any such by-laws shall be approved by the Guild Council before coming into force, and provided that the limits of any fines which may be imposed for breach of such by-laws shall be clearly stated in the regulations or by-laws;
- (b) (1) to provide for compulsory registration with the Guild of all University Societies (such registration shall be for purposes of record only and shall not imply any rights, privileges, or obligations as between the Guild and registered University Societies as such);
- (2) to enable such University Societies voluntarily to become affiliated to the Guild and to prescribe the conditions upon which such affiliation shall be terminable;
- (3) to prescribe conditions upon which such affiliated societies may admit to membership persons other than members of the Guild;
- (4) to provide for the proper administration and finance of such affiliated societies;
- (5) to provide for the representation of the University in sporting and other competitive activities by such affiliated societies and to prescribe the conditions upon which the University may be so represented;
- (c) to prescribe the form and manner in which recommendations may be made to the governing authority of the University for the amendment of this Statute and to prescribe the form and manner in which the regulations may be altered, added to, or repealed;
- (d) to provide for the interpretation, subject to an appeal to the Senate, of the provisions of this Statute and the regulations and by-laws authorised to be made by this Statute, and for the interpretation, subject to an appeal to the Guild Council, of any by-laws authorised to be made by the regulations;

- (e) (1) to adopt objects additional to those set forth in Section 3 of this Statute;
- (2) to admit to associate membership, associateship honorary associateship, or honorary life associateship persons other than members, and to prescribe the conditions upon which such persons may be admitted;
- (3) to provide for the election of the members of the Guild Council and other officers of the Guild;
- (4) subject to the provisions of Section 7 of this Statute, to prescribe the constitution, powers, and duties of the Guild Finance Committee;
- (5) generally for any other purpose requiring regulation.

6. (a) (1) The Guild shall be governed by a Council, to be termed the Guild Council.

(2) Two members of the Guild Council shall be members of the Senate appointed by the Senate.

(3) The other members of the Guild Council shall be elected in the manner prescribed by regulation.

(b) Subject to this Statute and the regulations, and subject to the authority of the Senate, the Guild Council shall have the entire control and management of the affairs and concerns of the Guild, and may act in all matters concerning the Guild in such manner as appears to it best calculated to promote the interests of the Guild and, without prejudice to the generality of this section, the Guild Council shall have power—

- (i) to engage and employ servants;
- (ii) to expend and invest moneys;
- (iii) to open banking accounts;
- (iv) generally to transact such financial business as may be necessary for the purpose of carrying out the objects of the Guild.

(c) (1) For the purpose of exercising any of the powers conferred upon the Guild Council by this Statute and for the purpose of carrying into effect any provision of the regulations, the Guild Council may make, alter, and repeal by-laws.

(2) All by-laws made by the Guild Council shall be reported to the Guild, which may thereupon confirm or disallow such by-laws or any of them.

(3) A copy of all by-laws made by the Guild Council and duly confirmed by the Guild shall be transmitted to the Senate, which may thereupon confirm or disallow such by-laws, or any of them.

(4) Any disallowance by the Guild or the Senate of by-laws made by the Guild Council shall be without prejudice to anything done before the date of such disallowance, and any by-laws not expressly disallowed shall be deemed to have been confirmed.

(5) The Guild Council may impose fines upon members, associate members, and associates of the Guild, and upon the members and officers of University Societies, for breach of the provisions of this Statute or the regulations or by-laws authorised to be made by this Statute, or any by-laws authorised to be made by the regulations: provided that the limits of all such fines shall be clearly stated in the regulations or by-laws.

(d) Subject to the authority of the Senate the Guild Council shall make provision for the control and management of the buildings from time to time occupied by the Guild and for the purpose of regulating the conduct of any persons using such buildings, or for any other like purpose may from time to time appoint from amongst the members of the Guild certain persons to be disciplinary officers of the Guild. Such duly appointed disciplinary officers of the Guild shall exercise such powers and carry out such duties as the Guild Council shall prescribe by by-law.

7. (a) (1) There shall be a Guild Finance Committee which, subject to the provisions of this Statute, shall be constituted in the manner prescribed by regulation.

(2) At least one member of the Guild Finance Committee shall be appointed by the Guild Council from amongst the two members of the Guild Council appointed by the Senate.

(3) All the members of the Guild Finance Committee shall be members of the Guild Council.

(b) All property of the Guild and its subsidiary organs, and all property of any University Societies (other than those University Societies which are incorporated bodies) which subsequently to the date upon which this Statute comes into force shall have voluntarily become affiliated to the Guild, shall be vested in the Guild Finance Committee. Subject to the provisions of this Statute and the regulations, the Guild Finance Committee shall deal with all property vested in them as directed by resolution of the Guild Council, of which an entry in the minute book of the Guild Council shall be conclusive evidence: provided that the Guild Council may at its discretion authorise the Guild Finance Committee to deal with the property of any University Society affiliated to the Guild in accordance with resolutions of the society concerned, of which a declaration in the form prescribed by regulation shall be conclusive evidence, and provided that in any case of disagreement between a University Society affiliated to the Guild and the Guild Council as to the manner in which the property of the Society concerned shall be dealt with, the Society shall have the right to appeal upon the question at issue to the Senate, and the Senate's decision thereon shall be final.

(i) Notice of any such appeal in writing signed by the secretary of the Society concerned and setting out fully the question at issue shall be lodged with the secretary of the Guild within 14 days of the decision of the Guild Council from which the appeal is made.

(ii) Upon receipt by the secretary of the Guild of such notice of appeal, no person or body shall deal in any way with the property of such Society until such appeal shall have been heard and decided or withdrawn by the Society concerned.

(c) The Guild Council may authorise the Guild Finance Committee—

- (i) on behalf of the Guild;
- (ii) on behalf of any University Society affiliated to the Guild, to enter into contracts, the terms of which have been duly approved by the Guild Council, and for the purpose of carrying into effect decisions of the Guild

Council (but not any other purpose) to acquire and dispose of property: provided that, in the case of any contract the aggregate liability under which exceeds the sum of £40, and in the case of the disposal of property the aggregate value of which exceeds the sum of £40, the Guild Finance Committee shall not exercise such authority without reference to the Vice-Chancellor, who shall have power to suspend the proposed exercise of authority pending the decision of the Senate thereon, and provided further, that no action taken by the Guild Finance Committee in the exercise of any of the powers hereby conferred upon it shall be deemed to have imposed any legal obligation upon the Senate or the University.

When a proposal to enter into a contract involving a liability exceeding £40, or to dispose of property exceeding the same amount, is referred to the Vice-Chancellor, it shall be accompanied by a statement showing the full amount of outstanding obligations already incurred by the Guild or by the Guild Finance Committee on its behalf.

(d) (1) The Guild Finance Committee may at the discretion of the Guild Council and with the written consent of the Senate in each case first had and obtained and subject to such terms and conditions as the Senate may impose—

- (i) take on lease any part of the University buildings and any other real property the control and management of which is at any time vested in or acquired by the University;
- (ii) take on lease or on hire agreement (with or without a right of purchase) any personal property.

(2) The University shall not directly or indirectly be liable for any rent or purchase money nor for any other obligation undertaken by the Guild or its Finance Committee in any such lease or hire agreement, and further, the Guild or the Finance Committee of the Guild shall indemnify the Senate against any damage to the buildings or fittings resulting from such lease or hire agreement.

(e) (1) The Guild Finance Committee shall make provision for the keeping of proper books of account in connection with all financial transactions with which it is concerned.

(2) The Guild Finance Committee shall make provision for the auditing of such books of account at least once in each year.

(3) An audited copy of the annual balance sheet of the Guild shall each year be transmitted to the Senate.

(f) The members of the Guild Finance Committee shall be indemnified out of the property vested in the Guild Finance Committee against all risk and expense arising out of any action taken by the Guild Finance Committee in accordance with the provisions of this Statute or the regulations.

8. The annual subscription to the Guild shall be—

- (i) for members who are internal students, the sum of two guineas;
- (ii) for members who are external students, the sum of ten shillings and sixpence;
- (iii) for associate members and associates, such sums not in excess of two guineas, as may be prescribed in the regulations.

9. The Guild Council shall have power to recommend to the Senate that any member be expelled from the University, or that he be suspended from attending the University, or that he be not re-admitted to the University.

10. (a) A copy of this Statute and any amendments thereof, and a copy of any regulations and by-laws made under this Statute and any amendments thereof shall be enrolled upon a Statute Book.

(b) An entry upon the Statute Book signed by the Clerk of the Senate shall be *prima facie* evidence that the subject matter thereof was duly approved by the Senate.

11. (a) This Statute shall be deemed to have come into operation upon the first day of October, 1935.

(b) Statute No. 26 and all regulations and by-laws made thereunder prior to the 1st day of October, 1935, are hereby repealed.

(c) All regulations and by-laws made under the authority of Statute No. 26 subsequently to the first day of October, 1935, shall be deemed to have been made under the authority of this Statute.

Statute No. 37—Amendment to Statute No. 5—Admission *Ad Eundem Statum*.—To provide for the recognition of courses at institutions such as the Australian Forestry School, etc., which may not wish to apply for affiliation, the Senate approved of an amendment to Statute No. 5—Admission *Ad Eundem Statum* (page 78 of 1933 Calendar), as follows:—

In connection with Clause 1, the Senate decided:—

- (a) To substitute for the words “Universities of Great Britain and Ireland, Australia or New Zealand” the words “Universities of the British Empire”;
- (b) After the words “or in any other University” add the words “or institution”;
- (c) End of Section: Omit last five words—“but who have not graduated.”

As amended the Statute would read:—

Statute No. 37—Admission *Ad Eundem Statum*.

1. The University may admit *ad eundem statum* persons who have attained any status in any of the Universities of the British Empire, or in any other University or institution recognised from time to time for that purpose.

2. Applicants for admission must submit sufficient evidence of their status and of their good fame and character.

3. The fee for admission *ad eundem statum* shall be one guinea.

Statute No. 38—Affiliated and Associated Institutions.—New Statute, replacing present Statute No. 14, Affiliated institutions:—

1. Any college, whether incorporated or not, or any educational establishment, wheresoever situated, may apply to be recognised as an affiliated or an associated institution of the University.

2. Every such application shall be accompanied by evidence of the educational status of the institution, and of the permanency of its establishment.

3. The Senate shall obtain from the Professorial Board a report on the educational status of the institution, and, after receiving the report, shall decide whether the institution shall be affiliated or associated with the University; such affiliation or association, when granted, shall in no case be for a period of more than five years, but may be periodically renewed after report from the Professorial Board.

4. If it is desired that any courses in the institution, taken singly or in groups, shall be recognised by the University as equivalent in scope and standard to certain courses in the University, or as suitable to be included as part of the work required for a degree or diploma granted by the University:—

- (a) The institution shall supply to the University full syllabuses of any such courses referred to, with details as to the amount of lecture, tutorial, and practical work involved, and the names, qualifications, and experience of the teachers, and the standard of examinations in the institution concerned, if these are to be recognised in lieu of corresponding examinations in the University.
- (b) The Senate, after receiving the report of the Professorial Board on the scope and standard of the courses for which recognition is sought, shall decide which courses (if any) in the affiliated or associated institution shall be recognised as qualifying courses for admission to the University Annual Examinations or which examinations in such institution may be accepted as suitable to form part of the requirements for a degree or diploma granted by the University. Such recognition shall in no case be for a period of more than five years, but may be periodically renewed after report from the Professorial Board. The Senate reserves the right of inspecting at any time the buildings and equipment of any affiliated or associated institution, and of inquiring into the qualifications of the teachers, and may nominate any person or persons for this purpose.
- (c) Recognition of any course shall cease, in the event of a change of teacher in charge of the course, or of a change in the scope or standard of the course, unless such changes are approved by the Professorial Board.
- (d) An affiliated or associated institution may from time to time apply for the recognition of further courses or examinations. Such application shall be accompanied by the same details as are required in Subsection 4 (a), and shall be dealt with as provided in Subsection 4 (b).
- (e) The Professorial Board shall have power to make from time to time, subject to the approval of the Senate, such regulations as it may deem advisable for the admission, registration, and control of students attending recognised courses in an affiliated or associated institution as part of their work for a degree or diploma of the University.

IN accordance with the provisions of Section 62 of "The Mine Workers' Relief Act, 1932," His Excellency the Lieutenant-Governor in Executive Council has been pleased to amend Scale I. of the Second Schedule to the Regulations under the said Act by substituting the following scale in lieu thereof:—

1. The maximum weekly payment shall not exceed £3 10s.
2. In the case of widowers, the additional payment in respect of any child under 16 years may be paid to any other person or institution direct, as the Board may in its discretion think fit.
3. A married man shall not be entitled to any allowance for his wife and children unless they are being supported by him.
4. The additional payment in respect of a wife or child may be paid to the wife or any other person or institution direct, as the Board may in its discretion think fit.
5. In the case of widows, benefits in respect of children under 16 years of age shall cease on re-marriage of the widow.

6. The benefit of £1 10s. per week for a widow under 60 years of age shall be reduced to 12s. 6d. per week, on such widow attaining the age of 60 years.
7. Any beneficiary who is residing in a foreign country or who leaves Australia to reside in a foreign country shall not be entitled to receive any greater benefits than those in force under Scale I. of the Regulations under the Mine Workers' Relief Act on the 1st February, 1933.

Provided further, that—

1.
