THE ADMINISTRATION ACT, 1903-1934.

We, the Honourable Sir John Alfred Northmore, K.C.M.G., Chief Justice of Western Australia, and the Honourable Thomas Percy Draper and the Honourable John Patrick Dwyer, Judges of the Supreme Court of Western Australia, hereby make an additional Rule to the Rules prescribed by the Fourth Schedule to "The Administration Act, 1903-1934," to come into operation on the 1st day of September, 1937, as follows:—

By-laws to Control Camping in the Cue Road District. P.W. 451/36.

P.W. 451/36.
WHEREAS under the provisions of "The Road Districts Act, 1919-1934," the Board of any District is empowered to make By-laws for all or any of the purposes mentioned in the said Act, the Cue Road Board doth, in exercise of the powers aforesaid and of every power enabling it in this behalf, hereby make the following By-laws: lowing By-laws:-

(1)—Camping.

No person shall, except as hereinafter provided, camp, lodge, or tarry for a longer period than seven consecutive days on any Crown lands or reserve for the purpose of camping, lodging, or tarrying thereon.

(2)-Permits for Camping.

Notwithstanding the provisions of Clause (1), camping may be permitted in areas set apart for the purpose by the Road Beard, but not elsewhere, upon the issue of a permission by an inspector or ranger appointed by the Road Board, and subject to the following condi-

The Board may at any time make and declare a schedule of charges and issue permits to persons desirous of camping on any such area.

(a) No person shall sublet any camp, or sell, give, or

otherwise dispose of any permit to any person.

(b) No person shall cut or otherwise destroy any

trees or shrubs within the camping area, excepting only by permission of the inspector or ranger for clearing those areas actually required for erecting camps thereon.

(c) Campers must keep the area covered by their permit in a clean and sanitary condition at all times. All rubbish capable of destruction by fire shall be burned by the occupier in the approved fireplace, and all other rubbish shall be placed in proper receptacles.

(d) All campers must use the sanitary conveniences provided, and in no circumstances will improvised conveniences on individual camping sites be permitted.

(e) Camping permits may at any time be withdrawn by the Inspector if in his opinion a breach of these By-laws has been committed, or if in his opinion it is desirable that the permit shall be terminated.

In the event of termination hereunder the rental paid shall be forfeited to the Road Board, and no com-pensation shall be paid for loss, damage, or incon-venience suffered through the withdrawal of the permit.

(f) Subject to the right of the inspector and the officers and employees of the Road Board, or any person acting under their instructions, or any police officer, to enter any camping site at any time, no persons shall enter any camping site at any time, no persons shall enter into or remain within such camping site, except with the permission of the holder of the permit.

(g) No fires shall be lighted on any camping area, except in places approved by the inspector.

(h) Permits issued shall be for a period of three months only, and an extension of this period can only be obtained by the approval of the Board granted at a Board meeting.

(i) Tents only will be allowed.

Buildings constructed with a wooden or iron frame-

work are prohibited.

Notwithstanding anything to the contrary contained in these By-laws, the Board may at a full board meetmg, upon application by an old age or other pensioner, agree to the issuing of a permit for the erection of a wood and iron camp for permanent occupation by the person to whom the permit is issued.

(j) Businesses of any description will not be allowed

on any camping area.

(3)—Penalty.

For every offence against the provisions of these Bylaws, the offender shall upon conviction before any one or more Justices of the Peace forfeit and pay a penalty not exceeding Twenty pounds (£20).

Schedule of Fees.

For each private camping site (33ft. x 69ft.) two shillings and sixpence (2s. 6d.) to be paid in advance. This is for a period of three months or portion thereof.

Persons occupying camps must also pay a fee of sixpence (6d.) per week for each camp, such payment to be utilised towards the payment of sanitary services carried out on the camping ground.

Industrial Board-Sheet-metal Working Industry. THE Industrial Board for the calling or industry of Sheet-Metal Working, in pursuance of the powers and duties conferred upon it by Section 107 of "The Industrial Arbitration Act, 1912-1935," and in pursuance of a remission to it by the Court of Arbitration, doth hereby make the following Award in connection with the industrial dispute between the abovenamed parties:-

AWARD.

- 1.—Interpretations.
 (a) "First-class bench hand" shall mean a worker required :-
 - (i) To work from blue prints, drawings, or measurements (whichever is required of him) for completed articles, and to make the articles throughout; or
 - (ii) To do work, the ability to do which involves the ability to do the work specified in (i).

The expression "blue prints, drawings, or measuremeans blue prints, drawings or measurements furnished by the customer to the employer for the purpose of specifying the nature and/or dimensions of the articles ordered or part thereof, or blue prints, drawings, or measurements of a similar nature; but the expression does not include drawings, sketches, or measurements supplied to the individual workman for the purpose of assisting such workman to understand the nature of and to carry out the work required of

(b) "Stock hand" shall mean a tinsmith or sheetmetal worker employed except as above in manufacturing or partly manufacturing articles out of any class of sheet-metal of ten (10) gauge or lighter, and including wire work in connection with such articles.

2.-Scope of Award.

This Award shall apply to workers employed to do work in galvanised iron, sheet-tin and other sheet-metal, including stove and oven-making and repairing, canister making, gas-meter making and repairing, manufacture of metal furniture, making and repairing circulating radiators.

3.—Hours.

Forty-four (44) hours shall constitute a week's work, which hours shall be worked in five and a half (5½) days: Provided that no worker shall be called upon to work after 11.45 a.m. on Saturday (except at overtime

4.—Wages.

Basic wage: Adult males—£3 13s. 9d. per week; adult females—£1 19s. 10d. per week.

5.—Dirt Money.

One penny halfpenny (1½d.) per hour shall be paid to workers employed outside the works of the employer in removing old stoves and ranges, or installing new stoves or ranges, where the work is of a specially dirty nature.

6.—Overtime.

All time worked in excess of the ordinary working hours in any one day shall be deemed to be overtime and shall be paid for at the rate of time and a quarter for the first two (2) hours, and double time thereafter.

7.—Payment of Wages.

Workers shall be paid at the shop or on the job within five (5) minutes of the time for ceasing work.

- 8.—Holidays.

 (a) Each worker shall be entitled to twelve (12) days' annual leave on full pay, or, should the period of continuous employment be less than one year, the worker shall be paid holidays in proportion as his length of service is to the full year's employment. The following shall be days upon which, if the employer's establishment be closed, payment may be deducted:—New Year's Day Amiyersary Day Good Friday Easter establishment be closed, payment may be deducted:—New Year's Day, Anniversary Day, Good Friday, Easter Eve, Easter Monday, Christmas Day, Boxing Day, Anzae Day, King's Birthday, Labour Day, Foundation Day, and Union Picnic Day: Provided, however (if it suits the convenience of the employer and worker), the employer shall be entitled to grant six (6) of the holidays abovementioned as paid holidays, and, if such six (6) days are granted in this manner, they shall be deducted from the twelve (12) days' annual leave.

 (b) Holidays without deduction of pay, whether granted annually or in the manner set out in the above
- granted annually or in the manner set out in the above proviso, shall be limited to twelve (12) days for each year of service.
- (c) In the event of a worker being employed by an employer for portion only of a year, he shall only be entitled to such holidays on full pay as are proportionate to his length of service during that period with such employer, and, if such holidays are not equal to the holidays given to the other workers, he shall not be

entitled to work or pay whilst the other workers of such employer are on holiday on full pay.

(d) All work performed on Sunday, New Year's Day, Good Friday, Labour Day, Christmas Day, Boxing Day, and Easter Monday shall be paid for at double time

(e) Holiday pay shall not accrue during a worker's absence from his employment for any cause whatever.

(f) A worker who is dismissed for wilful miscon-

duct shall not be entitled to the benefit of the provisions of this clause: Provided that any dispute as to what may constitute wilful misconduct shall be referred to a Board of Reference that may be constituted for that purpose, in accordance with the provisions of "The Industrial Arbitration Act, 1912-1935," under this

9.—Under-rate workers.

Any worker who by reason of old age or infirmity is unable to earn the minimum wage may be paid such lesser wage as may from time to time be agreed upon in writing between the Union and the worker, and, in default of such agreement within twenty-four (24) hours after such worker shall have applied in writing to the secretary of the Union stating his desire that such wage should be agreed upon, such wage as shall be fixed by the most convenient Resident or Police Magistrate upon the application of such worker after twenty-four (24) hours' notice in writing shall have been given by him to the said secretary, who shall, if he so desires, be heard by the Magistrate upon such application. The secretary of the Union may by writing under his hand appoint an agent or substitute to represent the Union at the hearing of the application before the Magistrate.

10.—Apprentices.

(a) The maximum number of apprentices allowed to any employer shall be in the proportion of one apprentice to every three (3) or fraction of three (3) journey-men employed by him. The fraction to be not less than one journeyman.

(b) The minimum wage payable to an apprentice shall

Provided that no apprentice shall be employed on a press until he has attained his third year.

(c) The wages of apprentices under this Award shall be subject to alteration by the Court when the wages of journeymen under this Award are reviewed.

(d) The employment of apprentices shall be governed by Schedule I. of the Court of Arbitration Apprenticeship Regulations (annexed hereto).

11.—Time and Wages Book.
A time and wages book shall be kept by each employer, in which book shall be entered the name of each worker, the nature of the work he is doing, the hours worked each day, and the amount of wages received by him each week. The employer and the worker shall be severally responsible for the proper posting of the book each week. The said book shall be open to the inspection of the secretary of the Union during working hours: Provided, further, that in the event of an industrial dispute existing or anticipated concerning any of the provisions of this Award, the secretary or an accredited representative of the Union shall be permitted on the business premises of the employer during working hours: Provided that such officer shall not wilfully hamper or hinder the workers during their working time, and he may interview any worker or converse with him during any lunch hour or non-working time.

12.—Tools.

The employer shall supply the whole of the tools required.

13.-Junior Workers.

Stove and Range Section-

The number of junior workers employed in the Stove and Range Section shall not exceed one to every two (2) or fraction of two (2) adult workers: Provided that, when an employer has one or more junior workers in his Stove or Range Factory who has completed three (3) years' service in the industry, then such employer may employ one junior worker in addition to the quota of junior workers prescribed above.

Any junior worker without previous experience entering the trade at seventeen (17) years or over may be paid for the first year of service and thereafter the rate of pay he would have received had he been one year younger.

No junior worker under the age of eighteen (18) years, nor any female, shall operate a press or power hammer. "Press" shall mean a machine ordinarily used for the production of stamping or cutting by means

of dies operated other than by human exertion.

There shall be no limitation upon the class of article any canister-making machine is capable of making or partly making.

14.—Contract of Service.

The contract of hiring of every worker, excepting apprentices, shall be deemed to be a contract of hiring by the day.

15.—Absence from Employment.

A worker shall be entitled to payment for non-attendance on the ground of personal ill-health for one half-day for each completed month of service: Provided that payment for absence through such ill-health shall be limited to six (6) days in each calendar year. Payment hereunder may be adjusted at the end of each calendar year or at the time the worker leaves the service of the employer, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred. clause shall not apply where the worker is entitled to compensation under the Workers' Compensation Act.

16.—Term.

The term of this Award shall be three (3) years from the 17th day of April, 1937: Provided that either party may after the expiration of twelve (12) months from its date apply to the Court of Arbitration to alter, amend, or revise the same.

17.—Area.

The area over which this Award shall operate shall be that comprised within a radius of twenty-five (25) miles from the General Post Office in the City of Perth.

18 .- Junior Worker's Certificate.

- (a) Junior workers shall furnish the employer with a
- (a) Junior workers shall furnish the employer with a certificate showing the following particulars:—

 (i) Name in full.

 (ii) Age and date of birth.

 (iii) Name of each previous employer.

 (iv) Length of service with each previous employer.

 (b) This certificate shall be signed by the worker.

 (c) No worker shall have any claim upon his employer for additional process in the synt of his age or length
- for additional wages, in the event of his age or length service being wrongly stated on this certificate.
 (d) No indorsement whatever shall be made by an
- employer on any such certificate.

19.—Obviation of Notice in the case of Stoppages and Breakdowns.

The employer shall be entitled to deduct payment for any day or portion of a day upon which the worker cannot be usefully employed by reason of any strike by the applicant Unions, or by any Union or Unions affiliated with them, or through any breakdown of the employer's machinery or any cause which the employer cannot reasonably prevent: Provided that, except in the cases of strikes, a worker shall be entitled to payment for a full day if he commences work upon that day.

Schedule I.

APPRENTICESHIP.

Definitions.

1. (1) "Act" means "The Industrial Arbitration Act, 1912-1935," and any alteration or amendment thereof for the time being in force.

- (2) "Apprentice" means any person of either sex of any age who is apprenticed to learn or to be taught any industry, trade, craft, or calling to which these Regulations apply, and includes an apprentice on probation.
 - (3) "Award" includes Industrial Agreement.
 - (4) "Court" means the Court of Arbitration.
 (5) "Employer" includes any firm, company, or

corporation.

- (6) "Minor" means a person not less than fourteen years of age and not more than eighteen years of age who customarily works under the direction of or in association with an employer, master, or journeyman upon the material and with the tools or implements used in the industry.
 (7) "Registrar" means the Registrar of the Court.

Employment-Probation.

- 2. No minor shall (except where provision is otherwise made in this Award) be employed or engaged in the industry, except subject to the conditions of apprenticeship or probationership herein contained.
- 3. (1) Every apprentice shall be employed on probation for a period of three months to determine his fitness or otherwise for apprenticeship, and shall work only for such hours per day and for such remuneration as may be prescribed by the Award. In the event of his becoming an apprentice such probationary period shall be counted as part of the term of apprenticeship.
- (2) The Court may in any case where it seems expedient to do so, order that the probationary period of employment be extended for a further period not ex-

ceeding three months.

- (a) Any employer taking an apprentice on probation shall within 14 days thereafter register such probationer by giving notice thereof to the Registrar in the prescribed form. If at the date of the coming into operation of these Regulations an employer is employing any apprentice or probationer who has not been duly registered as such, he shall forthwith apply for the due registration of such apprentice or probationer.
- (b) At the end of the period of probation of each apprentice, if mutually agreed upon by the employer and the legal guardian of the boy, but not otherwise, he may become an apprentice under an agreement.
- 5. The employer of every apprentice shall keep him constantly at work and teach such apprentice or cause him to be taught the industry, craft, occupation, or calling in relation to which he is bound apprentice, by competent instruction in a gradual and complete manner, and shall give such apprentice a reasonable opportunity to learn the same, and receive, during the period of his apprenticeship, such technical, trade, and general instruction and training as may be necessary. And every apprentice shall, during the period of his apprenticeship, faithfully serve his employer for the purpose of being taught the industry, eraft, occupation, or calling in relation to which he is bound, and shall also conscientiously and regularly accept such technical, trade, and general instruction and training as aforesaid, in addition to the teaching that may be provided by his employer.
- 6. An employer shall be deemed to undertake the duty which he agrees to perform as a duty enforceable under an Award of the Court.

Advisory Committee.

- 7. A Board to be called "The Advisory Committee" may be appointed by the Court to advise in regard to any apprenticeship matter. Such committee shall consist of the following:-
 - (a) Some person appointed by the Court who shall act as Chairman.
 - (b) Two representatives appointed by the employers.
 - (c) Two representatives appointed by the industrial union or unions of workers in the trade.

The Advisory Committee shall have such powers and duties as the Court in each case may determine.

8. (i.) No employer shall refuse employment to any person, or dismiss any worker from his employment, or injure him in his employment or alter his position to his prejudice, by reason merely of the fact that the worker is a member of any Advisory Committee, or by

reason merely of anything said or done or omitted to be done by any such person or worker in the course of his duty as such member.

(ii.) In any proceeding for any contravention of this Regulation it shall lie upon the employer to show that any person proved to have been refused employment, or any worker proved to have been dismissed or injured in his employment or prejudiced whilst acting as such member, was refused employment or dismissed or injured in his employment or prejudiced for some reason other than that mentioned in this Regulation.

Agreement of Apprenticeship.

- 9. (a) All agreements of apprenticeship shall be drawn up on a form approved by the Court, and signed by the employer, the legal guardian of the apprentice, the apprentice, and the Registrar. No employer, guardian or apprentice shall enter into any agreement or undertaking purporting to add to, vary, after or amend any such agreement without the approval of the Court.
- (b) There shall be three copies of each agreement, of which one copy shall be held by the employer, one shall be held by the legal guardian of the apprentice, and one copy shall be retained by the Registrar.

(e) The apprenticeship agreement shall be completed within one month of the termination of the proba-

tionary period.

- (d) Every agreement of apprenticeship shall be subject to the provisions of the award in force for the time being applicable to apprenticeship in the industry.
- 10. Every agreement entered into by the employer and the legal guardian of the apprentice shall be for a period of five years, but this period may be reduced in special circumstances with the approval of the Court.
- 11. Every agreement of apprenticeship entered into shall contain-
 - (a) The names and addresses of the parties to the agreement.

(b) The date of birth of the apprentice.

- (c) A description of the industry, craft, occupation or calling or combination thereof to which the apprentice is to be bound.
- (d) The date at which the apprenticeship is to commence and the period of apprenticeship.
- (e) A condition requiring the apprentice to obey all reasonable directions of the employer and requiring the employer and apprentice to comply with the terms of the industrial award so far as they concern the apprentice.

(f) A condition that technical instruction of the apprentice, when available, shall be at the employer's expense, and shall be in the employer's time, except in places where such instruction is given after the ordinary working hours

- (g) A condition that in the event of any apprentice, in the opinion of the examiners, not progressing satisfactorily, increased time for technical instruction shall be allowed at the employer's expense to enable such apprentice to reach the necessary standard.
- (h) The general conditions of apprenticeship.

Transfer of Apprentices.

- 12. (a) The Court shall have power to transfer an apprentice from one employer to another either temporarily or permanently
 - (i.) if the employer does not provide the necessary facilities for the apprentice to become proficient in his trade; or
 - (ii.) upon the application of the employer or the apprentice for good cause shown.
- (b) The transfer of every agreement shall be on a form approved by the Court, and shall be made out in quadruplicate, and shall, unless the Court otherwise directs, be signed by the late employer or his assigns, the legal guardian of the apprentice, the apprentice, the Registrar, and the new employer. The transfer form shall be completed within two months of the date on which the transfer is effected.
- (c) One copy of the transfer agreement shall be held by the late employer, one shall be held by the new employer, one shall be held by the legal guardian of the apprentice, and one shall be retained by the Registrar.

- 13. Should an employer at any time before the determination of the period of apprenticeship desire to dispense with the service of the apprentice he may with the consent of the apprentice and guardian transfer him to another employer carrying on business within a reasonable distance of the original employer's place of business, willing to continue to teach the apprentice and pay the rate of wages prescribed by the Court in its award or otherwise according to the total length of time served, and generally to perform the obligations of the original employer.
- 14. On the transfer or termination of any apprenticeship, from whatever cause, the employer shall give the apprentice a certificate stating what time he has served, full particulars of the branches of the trade or industry in which he has received instruction, the proficiency attained, and shall also notify the Clerk of the Court, and the cause thereof.
- 15. In the event of an employer being unable to provide work for the apprentice or to mutually agree with the legal guardian of the apprentice to cancel the agreement or to arrange a transfer, application may be made to the Court to arrange for such transfer or to have such agreement cancelled.
- Where a person is apprenticed to partners his agreement of apprenticeship shall upon the retirement or death of any partner be deemed to be assigned to the continuing partner or partners.

Cancellation of Agreement.

- 17. Every agreement shall include a provision that it may be cancelled, by mutual consent, by the employer and the legal guardian of the apprentice giving one month's notice in writing to the Court and to the parties concerned that such apprenticeship shall be terminated.
- 18. If the apprentice shall at any time be wilfully disobedient to the lawful orders of the employer, his managers, foremen or other servants having authority over the apprentice, or be slothful, or negligent, or dishonest, or shall otherwise grossly misbehave himself, or shall not conduct himself as a good and faithful ap-prentice should do, or shall not faithfully observe and keep his part of his agreement, then it shall be lawful for the employer, with the consent of the Court, to discharge the apprentice from his service.
- 19. The Court may in its discretion for any cause which it may deem sufficient on the application of any party to an apprenticeship agreement vary or cancel the agreement, either unconditionally or subject to such terms and conditions as it may deem advisable.
- 20. No apprentice employed under a registered agreement shall be discharged by the employer for alleged misconduct until the registration of the agreement of apprenticeship has been cancelled by order of the Court on the application of the employer.

Provided, however, that an apprentice may be suspended for misconduct by the employer, but in any such case the employer shall forthwith make an application for cancellation of the agreement of apprenticeship, and in the event of the Court refusing same the wages of the apprentice or such portion thereof, if any, as the Court may order shall be paid as from the date of such suspension, and, in the event of the application tor cancellation being granted, such order may take effect from the date when the apprentice was suspended.

- 21. Subject to the provisions of the Acts relating to Bankruptey and Insolvency and the Winding-up of Companies, the following provisions shall apply:
 - (a) The Trustee or Liquidator, as the case may be, may give written notice to the apprentice and his parent or guardian of his intention to discontinue the employment of the apprentice from a date to be named in such notice, and thereupon the agreement shall be deemed to be terminated from the said date; subject, however, and without prejudice to the right of the apprentice, his parent or guardian, to compound, compromise, or agree upon or to sue for and recover such damages (if any) as he may have sustained through such rescission of the agreement as aforesaid.
 - (b) Any proceedings for damages hereunder must be commenced within six weeks after the service on the apprentice of the notice referred to in subclause (a) hereof, otherwise any claim for damages shall be deemed to be waived and forfeited.

Extension of Term.

- Subject to Regulation 37, time lost by the apprentice through sickness or any other cause whatsoever may, with the consent of the Court on the application of any party, be added to the original term in the apprenticeship agreement at the end of the year of service in which the time has been lost or at the termination of the apprenticeship period.
- 23. The term of apprenticeship may be extended by the Court on the failure of an apprentice to pass any of the examinations, and for such purpose it shall be the duty of the examiners to make any necessary recommendation to the Court. Any extension of the term of apprenticeship shall be subject to all the conditions and stipulations in the original agreement, except as to rates of wages, which shall be such amount as the Court may determine.

Technical Education Classes.

- 24. (a) Every apprentice shall attend regularly and punctually a Government or other approved technical school vocational classes or classes of instruction, for instruction in such subjects as are provided for his This clause shall be deemed to have been complied with if the apprentice takes a course in an approved correspondence school: Provided, however, that attendances shall not be compulsory when the apprentice is resident outside a radius of 12 miles from the place where instruction is given, or in the case of illness of the apprentice the proof whereof lies on him: Provided also that if technical instruction is not available in the locality in which the apprentice is employed and is available by correspondence, at reasonable cost to be approved by the Court, the Court may prescribe such correspondence course as the technical instruction to be taken by the apprentice and paid for by the employer.
- (b) The fees for the classes attended by the apprentice shall be paid by the employer.

 (c) The period during which apprentices are to at-

- tend such technical school or classes, if any, shall be four hours per week.
- Where in any case it is shown to the satisfaction of the Court that any apprentice, by reason or his engagement on country work or other good cause, cannot conveniently attend a technical school or other prescribed classes, such of these Regulations as relate to attendance at a technical school or other prescribed classes, and to examinations, shall not apply to such apprentice, but he shall be subject to such conditions as the Court may direct.
- 26. If the examiners or the industrial union or employer concerned, make representations to the Court that the facilities provided by the Technical School, or other place of vocational training for the teaching of apprentices, are inadequate, the Court may make such investigations and such report to the Minister controlling such Technical School, or such other place, as it deems necessary.
- When an apprentice attends a technical school, vocational classes, or other class or classes of instruc-tion during his ordinary working hours, where such is prescribed, the time so occupied shall be regarded as part of the term of his apprenticeship, and the employer shall not be entitled to make any deduction from the wages of the apprentice for such time.

Examinations.

- (a) Every apprentice shall be bound to submit himself to examination at the places and times appointed by the Registrar after consultation with the examiners.
- (b) Every apprentice shall, prior to submitting himself to examination, produce to the examiners a certificate that he has made at least 70 per centum of attendances at the technical school or other place of instruction unless he is exempted from such attendance for good cause.
- (c) The clerk of the Court shall notify the examiners of the names and addresses of the apprentices required to submit themselves to examination.
- (d) The employer shall place at the disposal of the examiners such material and machinery on his premises as may be required by them, and shall in all ways facilitate the conduct of the examination.
- 29. (a) The examiners shall be persons skilled in the industry and appointed as prescribed by the Award. Failing provision or appointment as aforesaid the Court may appoint such person or persons as it may deem fit. In the event of a disagreement between the examiners

the matter in dispute shall be referred to a third person agreed to by them or nominated by the Court or the President at the request of any of the examiners, and the decision of such person shall be final and conclusive.

- (b) It shall be the duty of the examiners to examine the work, require the production of the certificate of attendance, inquire into the diligence of each apprentice, and as to the opportunities provided by the employer for each apprentice to learn, and to submit a report to the Court in writing as to the result of the examination within one month from the date of holding the examination, but this period may be extended by the Court.
- (e) Such examination shall, where possible, include theory and practice as applied to the trade, industry, eraft, occupation, or calling to which the apprentice is indentured.
- 30. The Registrar shall, after each examination, issue a certificate to each apprentice indicating his degree of proficiency, taking into consideration the term of apprenticeship served. A duplicate of such certificate shall be lodged by each apprentice with his employer and the secretary of the Union, each of whom shall keep the same in safe custody, and produce the same for inspection by the Industrial Inspector whenever demanded by the latter to do so. When the final examination has been passed the certificate shall also be signed by the examiners.
- 31. Whenever it is possible so to do, the examiners, before entering upon the examination, shall draw up a syllabus showing what, in their opinion, is the stage of proficiency which an apprentice should attain at each of the examinations prescribed. The syllabus shall be subject to review by the Court at any time, and shall be kept as a record by the clerk of the Court and a copy handed to the examiners before each examination. The said syllabus may be subject to alteration from time to time by the examiners, who shall forthwith notify the clerk of the Court thereof.
- 32. In lieu of, or in addition to, examiners above referred to the Court may appoint, wholly or partly, examiners to be appointed by the Director of Technical Education for the whole or any portion of the subjects of instruction, and at such remuneration as the Court may determine.
- 33. In the event of an apprentice failing to pass any of his examinations the employer may apply to the Court to disallow the increase in wages prescribed by the Award, and the Court, on any such application, may make such order as the circumstances of the case may seem to require.
- 34. Upon the failure of an apprentice to pass two consecutive examinations, it shall be the duty of the examiners to report same to the Court with a recommendation as to the cancellation of the apprenticeship agreement, or such other remedial measuries (i.e., increased time for technical instruction) as they may deem advisable. The Court, after notice to all parties concerned, may cancel the agreement or make such other order in the circumstances as it may deem necessary.
- 35. Upon the completion of the period of training prescribed for apprenticeship, each apprentice shall be required to pass the final examination test to the satisfaction of the examiners, and upon passing this test shall be provided with a certificate to that effect by the Registrar.

Lost Time.

- 36. The employer shall pay the apprentice for all time lost through sickness or the holidays prescribed by this Award: Provided—
 - (a) payment for such sickness shall not exceed a total of one month in each year;
 - (b) where the time lost through sickness exceeds four consecutive working days, the employer may demand from the apprentice the production of a medical certificate, and a further certificate or certificates may be required if any time is lost through sickness within seven days from the date of resumption of duty, the cost if any of such certificate or certificates not exceeding 5s. to be borne by the employer;
 - (c) an apprentice shall not be entitled to receive any wages from his employer for any time lost through the result of an accident not arising out of or in the course of his employment, or for any accident or sickness arising out of his own wilful default.

- 37. The employer shall pay the apprentice, in respect of time lost through compulsory military or naval training, the amount by which the wages prescribed by the industrial award for the trade, calling, craft, occupation, or industry exceeds the amount received by the apprentice from the Department of Defence: Provided, however, that this clause shall not apply to military or naval training imposed through failure to attend compulsory parades.
- All time lost by reason of compulsory military or naval training other than the additional training mentioned in the above proviso, shall count as part of the apprenticeship.
- 38. When an apprentice is absent from work for any cause other than sickness or in pursuance of the provisions of these Regulations, the employer shall be entitled to deduct from the wages of the apprentice an amount proportionate to the time so lost.
- 39. When an apprentice cannot be usefully employed because of a strike the employer shall be relieved of his obligations under the apprenticeship agreement during the period of the strike.

Part-time Employment.

40. Where in any case an employer is temporarily unable to provide work to employ an apprentice for his full time, application may be made by the employer to the Court for permission to employ the apprentice for such lesser time per week or per month, and at such remuneration as the Court may determine, being not less than the proportionate amount of the rate of wages prescribed by the industrial award for the trade, calling, or industry. If the Court grants the application holidays will be reduced *pro rata*.

Miscellaneous.

- - (a) a record of all apprentices and probationers placed with employers;
 - (b) a record of all employers with whom apprentices are placed;
 - (c) a record of the progress of each apprentice, recording the result of the examiners' reports;
 - (d) any other particulars the Court may direct.
- (2) These records shall be open to inspection by employers and the Union of workers interested upon request.
- 42. For the purpose of ascertaining the number of apprentices allowed to be taken at any time, the average number of journeymen employed on all working days of the twelve months immediately preceding such time shall be deemed to be the number of journeymen employed. Where the employer is himself a journeyman regularly and usually working at the trade he shall be counted as a journeyman for the purpose of computing the number of apprentices allowed. Where a business is in operation for less than twelve months the method of ascertaining the number shall be as agreed by the parties to the Award, or, if no agreement arrived at, as determined by the Court.
- 43. Every industrial inspector appointed in pursuance of the provisions of "The Industrial Arbitration Act, 1912-1935," shall have the power to enter any premises, make such inspection of the premises, plant, machinery, or work upon which any apprentice is employed or could be employed, interview any apprentice or employee, examine any books or documents of the business relating to the wages and conditions of apprentices, interrogate the employer in regard to any of the above-mentioned matters.
- 44. With a view to determining whether the number of apprentices being trained is sufficient to meet the future requirements of the industry in the matter of skilled artisans, the Registrar may require any employer to furnish him with any specified information relating to the said industry, or relating to the workers engaged therein.
- 45. In every application under Clauses 15, 18, 19, 20, 22, 23, 33, and 40 of this Schedule, the Union of Workers registered may intervene and make such representations at the hearing as it may deem necessary. The representative shall be appointed in the manner prescribed by Section 65 of the Act.
