ORDER IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1954, it is made lawful for the Governor to direct that any reserve shall vest in and be held by any municipality, road board, or other person or persons to be named in the order in trust for the like or other public purposes to be specified in such order; and whereas it is deemed expedient as follows:—

Corr. No. 5228/53.—That reserve No. 24147 (Koorda Lot 30) should vest in and be held by the Koorda Road Board in trust for the purpose of a Children's Playground.

ORDER IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1954, it is made lawful for the Governor to direct that any reserve shall vest in and be held by any municipality, road board, or other person or persons to be named in the order, in trust for any of the purposes set forth in section 29 of the said Act, or for the like or other public purposes to be specified in such order and with power of sub-leasing; and whereas it is deemed expedient that reserve No. 24143 (Greenmount Lots 307, 313 and 475) should vest in and be held by the Mundaring Road Board in trust for the purpose of Recreation: Now, therefore, His Excellency the Lieutenant-Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned reserve shall vest in and be held by the Mundaring Road Board in trust for Recreation, with power to the said Mundaring Road Board subject to the approval in writing of the Minister for Lands being first obtained, to lease the whole or any portion of the said reserve for any term not exceeding twenty-one (21) years from the date of the lease.

ORDER IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1954, it is *inter alia*, made lawful for the Governor to direct that any land reserved pursuant to the provisions of the Act shall be leased for the purpose for which the land is reserved as aforesaid, by Instrument of Lease in accordance with the form in the Fourth Schedule of the Act, to any person (as defined in the said section); and whereas it is deemed expedient as follows:—

Land Act, 1933-1954.

ORDER IN COUNCIL.
