Land Act, 1933-1954. ORDER IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1954, it is made lawful for the Governor to direct that any reserve shall vest in and be held by any municipality, road board, or other person or persons to be named in the Order, in trust for any of the purposes set forth in section 29 of the said Act, or for the like or other public purposes to be specified in such order and with power of subleasing; and whereas it is deemed expedient as follows:—

Land Act, 1933-1954. ORDER IN COUNCIL.

WHEREAS by section 34 of the Land Act, 1933-1954, it is made lawful for the Governor by Order in Council, without issuing any deed or grant, to place any reserve under the control of any municipality, road board, or other person or persons, as a board of management, and to empower such board to make, repeal, and alter by-laws for the control and management of such reserves, and prescribe fees for depasturing thereon or other use thereof, and for other purposes, such by-laws to be approved by the Governor and published in the Government Gazette; and whereas it is deemed expedient as follows:—
