WHEREAS by section 33 of the Land Act, 1933-1954, it is made lawful for the Governor to direct that any reserve shall vest in and be held by any municipality, road board, or other person or persons to be named in the order in trust for the like or other public purposes to be specified in such order; and whereas it is deemed expedient as follows:—

Corr. No. 1408/92—That reserve No. 2066 (Kent Location 1175) should vest in and be held by the Gnowangerup Road Board in trust for the purpose of Public Utility.

Metropolitan Water Supply, Sewerage and Drainage Act, 1909.

Metropolitan Stormwater Drainage. Bayswater District.

- (a) Compensating Basin C4, as shown in green on Plan M.W.S.S. and D.D. W.A. No. 7935.
- (b) Outlet drain from Compensating Basin C4, comprising 15in. diameter reinforced concrete stormwater drainage pipes, manholes, and all other apparatus connected therewith, length about 2,000 feet, as shown in red on Plan M.W.S.S. and D.D. W.A. No. 7935.

This Order in Council shall take effect from the $10th\ day\ of\ June,\ 1955.$

4.—Scope.

This Award shall apply to such work in, or in connection with stevedoring operations as may be undertaken by the Harbour and Lights Department.

5.—Term.

The term of this Award shall be for a period of three (3) years from the date hereof.

6.—Hours.

The ordinary hours of duty shall be from 8 a.m. to 5 p.m. Monday to Friday inclusive.

7.—Wages.

- (a) Basic wage £12 9s. 4d. to be calculated on an hourly basis.
- (b) Secondary Wage—There shall be added to the hourly rate of wage as arrived at by dividing the basic wage by thirty (30) such an amount or amounts as shall make the ordinary hourly rate, exclusive of other allowances, payable in the various ports equal to the following:—

8.—Overtime.

Overtime as hereinafter defined shall be paid for at the following rates:— $\,$

- (a) Between 6 p.m. and midnight, Monday to Friday inclusive, ordinary rate and a half.
- (b) Between midnight and 7 a.m. Monday to Saturday inclusive, double ordinary rate.
- (c) For work done on Saturday between 8 a.m. and midnight, double ordinary rate shall be paid.

9.—Sunday and Holiday Work.

Payment for time worked on Sundays and holidays shall be as under:—

- (a) Ordinary Holidays—For work done on ordinary holidays the rates shall be:—
 - (i) Between midnight and 7 a.m.—two and a half times the ordinary rate.
 - (ii) Between 8 a.m. and 5 p.m.—ordinary rate and a half.
 - (iii) Between 5 p.m. and midnight—double ordinary rate.
- (b) Sundays and extraordinary holidays—For work done between midnight on Saturday and midnight on Sunday and between midnight and midnight on extraordinary holidays; two and a half times the ordinary rate shall be paid.

10.—Holidays.

The holidays shall be as follows:-

- (a) Extraordinary holidays—Christmas Day, Good Friday, Labour Day, Picnic Day and Sundays.
- (b) Ordinary Holidays—New Year's Day, Foundation Day, Easter Monday, Boxing Day, State Foundation Day and Anzac Day.

11.—Meal Hours.

The hours for meals shall be:—Breakfast—7 a.m. to 8 a.m. Dinner—Noon to 1 p.m.
Tea—5 p.m. to 6 p.m.

Supper—If work commences before 11 p.m., a supper hour may be taken between the hours of 11 p.m. and 1 a.m. but if work commences at 11 p.m. or later no supper hour shall be allowed.

12.—Working During Meal Hours.

(a) Any employee required to work during meal hour shall be paid at the appropriate rate plus the rate applying between 8 a.m. and 5 p.m. on an ordinary day, for such meal hour or portion thereof worked and such rate, subject to the exception

- hereinafter mentioned, shall continue until the employee is discharged or has been allowed a full hour of leisure for a meal.
- (b) Employees of their own will working with the concurrence of the employer through a meal hour in order to complete a ship or job, shall not be entitled to meal hour rates.
- (c) The extra payment after the expiry of a meal hour period shall not continue in the following cases:—
 - (i) Where the employee has, during the meal hour, been on duty for only the last quarter of the hour assisting to handle the vessel's lines.
 - (ii) Where the employee is desirous of working during the meal hour as hereinbefore provided.
 - (iii) Where the work begins for the day at or during a meal hour.

13.—Annual Leave.

(1) Each worker shall for every one hundred and four (104) hours of qualifying service, as defined in paragraph two (2) hereof, be credited with four (4) hours leave, with payment of ordinary wages as prescribed, accumulated on the foregoing basis:—

Provided that-

- (a) leave shall be taken each year at a time suitable to both the employer and employee;
- (b) if after dividing the total number of qualifying hours of service by one hundred and four (104), odd hours less than 104 remaining shall be credited on the basis of one hour of leave for every 26 hours of completed service:
- (c) the maximum leave which shall be credited shall be eighty (80) hours;
- (d) that annual leave shall not apply to regular and/or permanent employees of other Government Departments.
- (2) Qualifying service shall be calculated as follows:—
 - (a) One hour shall be credited to each worker for each hour he works or performs some work provided that no credit shall be given to a worker who fails without reasonable cause to commence or resume work as ordered.
 - (b) Eight hours shall be credited to each worker for each eight hours he is absent from work on annual leave paid for pursuant to this clause.
- (3) If a worker desires to leave the industry he may require payment for annual leave in respect to qualifying service standing to his credit.

Provided that-

- (a) payment shall be made at the ordinary working rate then applicable on the basis of four (4) hours pay for each completed period of one hundred and four (104) hours of qualifying service;
- (b) if such worker returns to the industry within one month no qualifying service shall be credited to him for a further period of one month.

14.—Time of Duty.

- (a) The place of engagement shall be the goods sheds.
- (b) The time of duty shall commence at a time and place to which the employee is directed to present himself for work or for conveyance to work and shall cease at the time he shall be returned to that place. Provided that employees are conveyed from Roebourne to Point Samson and returned to Roebourne after work has ceased.
- (c) Travelling time of twenty (20) minutes each way shall be added to the term of engagement at Carnarvon, and thirty (30) minutes each way to the term of engagement at Point Samson, provided that waiting time at the end of actual work in each engagement shall not be included.

- (d) Employees who are engaged for work shall be paid for four hours at the least even if they are not turned to work, and after four hours of work they shall be paid for each fraction of a half hour as if it were a full half hour.
- (e) Employees who present themselves by direction of the employer for work after meal hours without having been discharged shall be paid as for one hour at the least, even if they are not turned to work.

15.—Smokos.

- (a) 10 a.m. to 10.20 a.m.—Providing work commences at or before 9 a.m.
 - 3 p.m. to 3.20 p.m.—Providing work commences at or before 2 p.m.
 - 9 p.m. to 9.30 p.m.—Unless work ends at or before 10 p.m.
 - 3 a.m. to 3.15 a.m.—Unless work ends at or before 3 a.m.
 - 5 a.m. to 5.15 a.m.—Unless work ends at or before 5 a.m.
- (b) The employees shall not be entitled to the said breaks of work if the employer be willing to pay double the appropriate rate for work done during the smoko or where the actual work commences less than two hours before the time mentioned.

Provided that in the case of the 10 a.m. to 10.20 a.m. smoko, the employees shall be entitled to the said break where actual work commences one hour before the time mentioned.

Employees shall not be bound to work through smoko, except when finishing a ship or to meet unexpected rushes of cargo or for some special reason necessary to enable a ship to leave port to schedule time or to prevent delay owing to tidal conditions, and if required by the employer to work through the whole or part of a smoko for any such reason they shall do so and shall be paid double the appropriate rates for the whole or part of such period actually worked.

(c) The employer shall notify his employees of the time of commencement of any smoko or meal break and shall also give a warning three (3) minutes prior to the time fixed for resumption of work thereafter. No employee shall cease work prior to the appointed time or be late in returning to his place of work at the expiration of the time fixed therefore.

16.—Frozen Cargo.

Employees handling frozen cargo shall be entitled, without deduction of pay, to five (5) minutes at the beginning and finishing of work each day and before and after meal hours for the purpose of changing clothes.

Employees handling frozen cargo shall be provided with suitable warm clothing by the employer or if no such clothing is provided, shall be paid three pence (3d.) per hour extra.

17.—Working During Rain.

- (a) The employer's sanction to cease work owing to rain shall not be unreasonably with-held.
- (b) No employee shall work in rain unless he so elects, if he ceases work or does not commence work owing to rain, with the sanction of the employer, he shall be entitled, until discharged to payment at the ordinary rates for standing-by time.
- (c) If he ceases work or does not commence work, owing to rain, without the sanction of the employer, he shall be entitled until discharged, to payment of half the ordinary rate.
- (d) The provisions in respect to ceasing work or not commencing work owing to rain contained in paragraphs (b) and (c) hereof shall also be applicable to cases where work ceases or is not commenced owing to boisterous weather or grounding of lighters.
 - 18.—Damaged, Difficult and Obnoxious Cargo. Employees required to work on—
 - (a) Cargoes handled at marine casualties;
 - (b) cargoes damaged by fire or water;

- (c) cargoes which are unusually dangerous to handle:
- (d) cargoes which are unusually obnoxious or unusually difficult to handle,

shall be entitled to such special rates and conditions as may be determined by their representative and by the representative of the employer, or if they differ, by a Board of Reference, providing that the employee forthwith proceeds with the job as required, leaving special rates and conditions to be determined as aforesaid.

19.—Handling Stock.

All cattle and sheep shall be handled from stock receiving yards to ship or vice versa by the agents or a stockman.

20.—Preference.

Preference of employment shall be given to members of the Australian Workers' Union.

21.—Board of Reference.

The Court hereby appoints for the purpose of this Award a Board of Reference. Such Board shall consist of a chairman and two other representatives, one to be nominated by each of the parties.

There are assigned to such Board in the event of no agreement being arrived at between the parties to this Award the functions of—

- (a) allowing, approving, fixing, determining, or dealing with, any matters or things arising under or out of this Award which may require from time to time to be allowed, approved, fixed, determined or dealt with by the Board;
- (b) deciding any other matter that the Court may refer to such Board from time to time.

An appeal shall lie from any decision of such Board in the maner and subject to the conditions prescribed in the regulations to the Industrial Arbitration Act, 1912-1952, which, for the purpose, are embodied in this Award.

INDUSTRIAL AGREEMENT.

No. 7 of 1955.

(Registered 4th May, 1955.)

THIS Agreement made in pursuance of the Industrial Arbitration Act, 1912-1952, this 27th day of April, 1955, between the Swan Brewery Company Limited and the Emu Brewery Company Limited and the Emu Brewery Company Limited, both of Perth (hereinafter called "the employers"), of the one part, and the Metropolitan and South-Western Federated Engine Drivers and Firemen's Union of Workers of Western Australia, being an industrial union of workers registered under the provisions of the Industrial Arbitration Act, 1912-1952 (hereinafter called "the Union") of the other part, whereby it is mutually agreed by and between the parties hereto that the several stipulations, conditions and provisions set out herein shall in all cases be binding upon and shall be faithfully and promptly carried out, observed, performed and complied with according to the true intent and meaning thereof by the parties hereto.

For the purpose of this Agreement—

(a) "Engine-driver" shall mean and include a worker who operates or drives any engine or engines the motive power of which is either steam, gas, air, oil, water, compressed air or electricity.

(b) "Fireman" shall mean a worker employed in a stokehole attending a steam boiler or suction gas generator over 6 h.p.

2.—Wages Schedule.

(a) The parties to this Agreement mutually agree that the minimum rate of wages that shall be paid by the employers respectively to the persons employed by such employers in the capacities undermentioned shall up to the 14th December, 1954, be the rates provided by Industrial Agreement No. 12 of 1952, subject to any variations in the basic wage declared since the date thereof and as on and from the 15th day of December, 1954, as follows:—

(b) Engine-drivers, or firemen, who shall be employed on boiler cleaning work, cleaning inside of pasteuriser, or bottle soaker shall receive payment at the rate of one shilling (1s.) per hour for all time so employed in addition to his ordinary or overtime rate of pay.

Firemen

3.—Hours.

- (a) Forty hours, consisting of eight hours per day from Mondays to Fridays inclusive, shall constitute a week's work for engine-drivers and firemen who shall commence work not before 5 a.m. on any day, and the employer may require any engine-driver or fireman to start work at any time after that time. Where one shift only is worked such shift shall begin not later than 8 a.m. Any alteration to the working hours shall be by mutual arrangement.
- (b) In all cases, in reckoning the time of duty any time necessarily occupied in raising steam, in starting up or closing down engines, or in banking fires shall be included.

4.—Shift Work.

- (a) Workers may be employed-
 - (i) On "regular shift work" that is in regular rotation from week to week on two or three shifts spread over 16 or 24 hours respectively day shift to be worked from 7.30 a.m. to not later than 3.30 p.m., afternoon shift from 3.30 p.m. to not later than 11.30 p.m., and night shift from 11.30 p.m. to not later than 7.30 a.m.
- (ii) On "casual shift work" that is on one weekly shift only worked in any department, casual, day, afternoon and night shifts to start and finish at the times respectively referred to in the preceding paragraph.
- (b) In the case of both regular and casual shift work the first shift of the week will begin on Sunday at 11.30 p.m. and the last shift of the week shall finish at 11.30 p.m. on Friday. Duty rosters shall be posted on Friday in each week and shall show the starting and finishing times of each worker during each week. Particulars relating to starting and finishing times shall be rigidly adhered to.
- (c) The provisions contained in the previous subclause of this clause may be varied by mutual agreement between any employer and the Union.
- (d) All workers employed on regular shift work shall be paid an allowance equal to 5 per cent. of their ordinary weekly rate of pay for any week during which they work afternoon shift and an allowance equal to 10 per cent. of their ordinary weekly rate of pay for any week during which they work night shift.
- (e) All workers employed on casual shift work shall be paid an allowance equal to $7\frac{1}{2}$ per cent. of their ordinary weekly wage for any week during which they work afternoon shift and $12\frac{1}{2}$ per cent. of their ordinary weekly wage for any week during which they work night shift.

(f) The additional allowances mentioned in subclauses (d) and (e) hereof shall be taken into consideration in calculating overtime rate for any overtime for work done beyond eight hours per day on Mondays to Fridays inclusive. Except as aforesaid the above allowances shall not be included for purpose of calculating any other penalty rates under this Agreement.

5.--Overtime.

- (a) The following overtime shall be paid for at the rate of time and a half:—All time up to 4 hours worked:
 - Over 8 hours per day on Mondays to Fridays inclusive.
 - (ii) Before the starting time of 5.0 a.m. mentioned in clause 3 (a).
 - (iii) In the case of shift workers outside rostered starting and finishing times.
 - (iv) On Saturday.
- (b) All overtime in excess of four hours worked during the periods referred to in subclause (a) shall be paid for at the rate of double time.
- (c) Subject to any alteration by mutual arrangement all workers on day work engaged in or about a brewery or bottling works shall, if required to work more than one hour's overtime after the usual finishing time, be entitled to knock off for one hour after the usual finishing time for refreshments in which event and if notice of overtime has not been given at least twenty-four hours previously, tea money shall be paid at the rate of four shillings (4s.)

6.—Record.

Each employer shall keep a record of the name of each worker, the time he starts and finishes each day, total number of hours worked, overtime worked, and wages paid to each worker, and such record shall be open to the inspection of the secretary of or any other person appointed by the Union during working hours.

Each worker shall sign the record kept for all moneys received by him.

7.—Sundays.

All work performed on Sundays shall be paid for at the rate of double time.

8.—Holidays.

All work performed by workers in any department on the undermentioned holidays shall be paid for on an hourly basis at a rate equal to one and one half $(1\frac{1}{2})$ times the ordinary rate of pay per hour with a minimum of four (4) hours' pay and in addition such workers shall be paid one (1) day's pay for the holiday. All holiday shifts shall rotate. One ordinary day's pay shall be paid for the undermentioned holidays to workers who do not work that day.

The days to be observed as holidays according to the provisions of this Agreement are Christmas Day, Boxing Day, New Year's Day, Anniversary Day (in January), Annual Picnic Day, Good Friday, Easter Monday, Anzac Day, Labour Day, Foundation Day (in June), Show Day, and Sovereign's birthday. In case any of the above holidays falls on a Saturday or a Sunday the following Monday shall be observed in lieu thereof.

9.—Annual Bonus.

The employer shall pay each employee receiving wages under this Award a week's pay by way of bonus on the last week in December in each year. Any employee leaving the employer's service for reasons other than misconduct, dishonesty, or neglect of duty before the payment of such bonus in any year, shall, when leaving, be paid a prorata payment in lieu thereof; any employee who shall not have been in the employ of the employer for a year in the first week in December shall receive a part of his week's pay bearing the same proportion to a week's pay as the period of his service bears to a year.

10.—Annual Leave.

Each employee on completion of twelve (12) months' service shall be granted three (3) weeks' annual leave, two weeks on double pay and one week on single pay, such leave to be taken at times to be mutually agreed upon between the workers and the employers. The annual leave shall be in addition to the holidays mentioned in clause 8 hareof.

On termination of services of a worker who has been continuously employed for more than three (3) months, he shall receive a pro rata payment in lieu of leave on the basis of two and one-twelfth (21/12th) days' pay for each completed month of service.

On termination of service of a worker who has been continuously employed for more than one month, but less than three months, he shall receive a pro rata payment in lieu of leave on the basis of one and one-quarter $(1\frac{1}{4})$ days' pay for each completed month of service.

Relieving engine-drivers and firemen shall be paid for annual holidays pro rata to the length of time they have been employed on the higher rates.

11.-Long Service Leave.

- (a) All employees who from time to time shall complete 25 years of continuous service with an employer shall be given long service leave. Such long service leave shall be taken at the conclusion of 25 years of continuous service and shall comprise 13 weeks' leave of absence for recreational purposes.
- (b) Should an employee who has completed fifteen years of continuous service be retired compulsorily on medical grounds on the advice of a medical officer appointed by the employer or by reason of being over the employer's retiring age or die before completing 25 years' continuous service, there shall be paid by the employer to such employee or to his dependants as the case may require a sum of money bearing the same relation to 13 weeks' pay at his rate as his service with the employer bears to 25 years. "Dependant" shall mean the widow and/or children under the age of 16 years, or any child in fact dependent, of any employee and, in the case of a single employee, shall mean such dependant (if any) as such single employee may in writing notify to the Company during his lifetime, accompanied by proper proof of actual dependency.
- (c) Continuous service shall include any interval spent on service with Her Majesty's Armed Forces during the duration of any war on which Her Majesty may be engaged, and shall also include any interval spent during the duration of any war on which Her Majesty may be engaged with any National Service into which an employee is compulsorily drafted for defence purposes.
- (d) Unless otherwise agreed in individual cases, long service leave shall be taken at such period as shall be mutually agreed upon within two years of it becoming due. In default of agreement it shall be taken at such time within such period of two years as the employer shall determine.
- (e) Except in the case of an employee who, at the time he becomes eligible for long service leave, is of an age exceeding 60, all long service leave shall be taken by way of actual holiday and not by way of payment in lieu thereof on retirement. An employee who at the time he becomes eligible for long service leave is beyond 60 years of age shall have the option of taking actual holiday under this scheme or of receiving payment in lieu thereof on retirement. Such option shall be exercised by a notice in writing addressed to the employer at the time of becoming eligible for long service leave.
- (f) Employees on long service leave shall, while on such leave, continue to be paid at the actual rate (exclusive of overtime or other allowance) enjoyed by them at the commencement of such leave. Except in special circumstances payment shall be at the same times as during normal employment but may be made by cheque by mutual arrangement.

- (g) It shall be a condition of every employee's taking long service leave that he (or she)— $\,$
 - (i) shall not under any circumstances be engaged in any gainful employment while on such leave;
 - (ii) shall return to the active service of the employer forthwith at the expiration of the leave; and
 - (iii) shall not draw any sick or accident pay simultaneously with long service leave pay.
- A breach of condition (i) above will result in immediate discharge from the employer's service accompanied by forfeiture of all rights (if any) to retiring allowance or other similar payments or benefits. A breach of condition (ii) above (except as on the grounds of illness necessitating retirement or additional leave on the advice of a medical officer appointed by the employer) will result in forfeiture of all rights (if any) to retiring allowance or other similar benefits or payments.
- (h) In order to avoid manning difficulties, the long service leave of employees who become entitled to the same in the first year of operation of the scheme shall be taken during such periods during the first two years of the scheme as shall be mutually agreed upon and in default of agreement at such time as the employer may decide.
- (i) The employer shall have the right in cases of emergency to recall any employee from long service leave, in which case the unexpired leave shall be made up on some mutually convenient date
- (j) In order to avoid confusion and embarrassment employees whilst on long service leave shall not, without the prior permission of the officer in charge of the particular establishment visit any of the premises of the employer except for the purpose of collecting pay or transacting genuine business with the employer's officers. Social visits shall not be indulged in. "Establishment" means any brewery, cooperage or workshop but does not include hotels or annual picnies or sports or usual weekly competitive sporting activities.
- (k) The benefits of long service leave shall be in addition to all benefits at present or hereafter to be enjoyed by employees.
- (1) In the event of any governmental or similar long service leave scheme being introduced for industry as a whole, the parties concerned shall meet to consider alterations necessary in order to adjust the scheme to such new conditions.
- (m) Notwithstanding anything in this clause contained no employee nor his legal personal representative shall be entitled to any of the benefits by this clause conferred in any of the following circumstances:—
 - (i) When, in the opinion of the directors of an employer an employee has committed fraud upon the employer or any defalcation in relation to the employer or breach of trust or similar act prejudicially affecting or likely so to affect business or interests of the employer and is dismissed.
 - (ii) If the employee shall become a bankrupt or insolvent debtor within the meaning of any Act of the Parliament of the Commonwealth of Australia or of the State of Western Australia or shall assign, alienate or charge his benefits hereunder or any part thereof or attempt to do so or if through his own act or default or by operation or process of law the same shall become vested in or payable to some other person, firm or company.

12.—Engagement.

The engagement between the employer and employee, except casual hands, shall be weekly, and may be terminated by a week's notice from either party, except in the case of the employee absenting himself without leave, not obeying lawful commands, or being guilty of other misconduct or of the works of the employer being stopped through fire or tempest when such agreement may be terminated immediately.

13.—Absence Through Sickness.

(a) An employee who is unable through sickness or accident to attend his duties, shall notify the employer not later than 10 a.m. on the day he first absents himself from duty.

(b) An employee shall be entitled to sick pay in respect of any period of absence on account of sickness after the 1st day of January, 1948, on the basis of one half day's pay for each completed month served with the employer between the said 1st day of January, 1948, and the date of commencement of such absence provided that in calculating the amount due to an employee in respect of any particular period of absence through sickness there shall be deducted therefrom any sum or sums previously paid to him hereunder.

(c) The term "sickness" shall not include any case where the employee is entitled to compensa-tion under the Workers' Compensation Act.

(d) No employee shall be entitled to the benefits of this clause unless he produces proof of his sickness satisfactory to the employer. This proof shall be in the form of a medical certificate if the absence is for three days or more. The employer shall have the right at any time to have the employee examined by a doctor on behalf of the employer.

(e) Except as aforesaid an employee shall not be entitled to payment for time lost through sickness or accident.

14.—Area.
This Agreement shall apply to all employees engaged in the brewing industry as engine-drivers and firemen in the area comprised within a radius of fifteen (15) miles from the General Post Office,

15.—Term of Agreement. This Agreement shall be for a term of one year from the 15th day of December, 1954.
