#### HEALTH ACT, 1911-1954.

Municipality of Bunbury-By-law.

P.H.D. 368/46.

THE Council of the Municipality of Bunbury (being the local authority under the Health Act, 1911-1954, for the municipal district of Bunbury) in pursuance of the provisions of the Health Act, 1911-1954, doth hereby constitute and prescribe an area having the boundaries prescribed in the Schedule hereunder a prescribed area within and for the purposes of section (112A) of Health Act, 1911-1954, where the Municipality of Bunbury undertakes or contracts for the efficient execution for the removal of house or trade refuse and other rubbish from premises.

# Schedule.

The area bounded by Preston Street, Strickland Street, King Road, the South-West Railway, the East and South boundaries of location 3053, the East boundary of lot 17, Hands Avenue, Little Street, Nuytsia Avenue, Spencer Street, Timperley Road, Minninup Road, West Road, the East and North boundaries of reserve 19633, Northwards along the Indian Ocean foreshore, South-Eastwards along the foreshore of Koombana Bay and Leschenault Inlet to lot 28 off Richmond Street, and thence in a straight line to the intersection of Preston Street and Australind Road. Including all occupied premises on both sides of all streets or roads mentioned herein.

# TRAFFIC ACT, 1919-1954. Municipality of Bunbury.

Traffic By-laws.

L.G. 2254/52.

IN pursuance of the powers conferred by His Excellency the Governor by Order in Council published in the *Government Gazette* dated the 13th day of April 1951, the Bunbury Municipal Council doth hereby make the following by-laws for control of traffic within the Municipality of Bunbury:—

1. No person in charge of any vehicle shall cause or permit such vehicle to stand on any part of any bus stop described hereunder:—

Stirling Street (South Side).—Commencing at a point 20 feet West of the Western building alignment of Spencer Street and extending Westwards for a distance of 76 feet.

Spencer Street (West Side).—Commencing at a point 105 feet South of the Southern building alignment of Beach Road and extending Southwards for a distance of 47 feet.

Spencer Street (East Side).—Commencing at a point 97 feet North of the Northern building alignment of Beach Road and extending Northwards for a distance of 74 feet.

2. No person in charge of any vehicle shall cause or permit such vehicle to stand on the South side of Stephen Street within 20 feet of either side of the main entrance door to the Prince of Wales Hotel building from 7 p.m. to 9 p.m. on any week day or Saturday. 3. Nothing in these by-laws shall render it unlawful for a vehicle to be stopped and remain stationary to allow passengers sufficient time to alight from or enter the vehicle.

4. Any person committing a breach of any of the foregoing by-laws shall, on conviction, be liable to a penalty not exceeding  $\pounds 20$  or to imprisonment for not more than one month.

# TRAFFIC ACT, 1919-1954.

Manjimup Road Board.

Parking By-law.

L.G. 947/52.

THE Manjimup Road Board, pursuant to an Order in Council under section 49 of the Traffic Act, 1919-1954, published at page 3 of the *Government Gazette* dated the 8th day of January, 1953, and in exercise of the powers thereby conferred, doth hereby make the following by-law, prescribing rules to be observed in respect to any vehicle being driven or used on roads within the townsite of Manjimup in the Manjimup Road District.

> Giblett Street, Manjimup. Angle Parking.

1. No person shall park a vehicle in the areas set apart and marked for that purpose on the South-Eastern side of Giblett Street between Mount Street and Ipsen Street, except at an angle of 45 degrees.

2. No person in charge of any vehicle which exceeds the length of 26 feet measured from the extreme limits of the vehicle and/or any load carried thereon, shall permit any such vehicle to be parked on the South-Eastern side of Giblett Street.

# TRAFFIC ACT, 1919-1954. Dundas Road Board. Parking By-laws.

## L.G. 234/53.

THE Dundas Road Board, pursuant to an Order in Council under section 48 of the Traffic Act, 1919-1954, published in the *Government Gazette* on the 10th day of September, 1948, and in the exercise of the power thereby conferred, doth hereby make the following by-law prescribing rules to be observed in respect of any vehicle being driven or used on the roads and in the use of footpaths within the townsite of Salmon Gums in the Dundas Road District:—

(1) No person in charge of any vehicle shall permit such vehicle to be parked in that portion of Rogers Street (West side) between Lewis Street and Mann Street, unless parked at an angle of 45 degrees.
(2) No person in charge of any motor wagon (utility excepted) or any vehicle with trailer or semi-trailer attached shall permit such vehicle to be parked in that portion of Rogers Street (West side) between Lewis Street and Mann Street.

# ROAD DISTRICTS ACT, 1919-1951.

## Busselton Road Board.

Building By-laws-Numbering of Houses.

# L.G. 2690/52.

PURSUANT to the powers conferred by the Road Districts Act, 1919-1951, and other powers thereto enabling the Busselton Road Board doth hereby make and publish the following by-laws for the numbering of houses and other buildings within the boundaries of the Busselton and Dunsborough townsites.

> (1) The Board may allot to each house or other building within the boundaries of the Busselton and Dunsborough townsites a separate number.

> (2) The Board may give notice in a newspaper circulating in the district requiring the owners of land within any specified street to affix the lot numbers to the houses or other buildings situated in and fronting to that street.

> (3) The number plates to be fitted in accordance with by-law 2 shall be not less than  $2\frac{1}{2}$  in. in height.

(4) Number plates affixed to houses or other buildings under this by-law may be affixed to the building itself or to the fence in front of the building.

(5) The Board may supply a number plate to any person desiring to purchase one upon payment of not more than 3s. per number or set of numbers for each house or other building. (6) If within one month after notice has been published in a newspaper circulating in the district the owner of the land required by the advertisement and these by-laws to affix a number plate has failed to do so the Board may serve upon him a notice in writing requiring him to affix a number plate within a period of one month.

(7) If the owner fails to affix a number plate within one month after being served with a written notice so to do he shall be guilty of an offence.

(8) If the owner of the land resides outside the State or his address is unknown to the Board the Board may serve upon the occupier of the building a notice requiring him to affix a number plate in accordance with these by-laws. If the occupier neglects or refuses to affix a number plate within a period of one month he shall be guilty of an offence.

(9) No person shall remove, deface or in any way damage any number plate affixed in accordance with these by-laws.

(10) Any person committing a breach of these by-laws shall be liable on conviction to a penalty not exceeding  $\pounds 2$ .

# ROAD DISTRICTS ACT, 1919-1948.

#### Yalgoo Road Board.

#### By-law to Control Dumping of Rubbish.

WHEREAS under the provisions of the Road Districts Act, 1919-1948, the road board of any district is empowered to make, alter and repeal any by-laws: Now, therefore, the Yalgoo Road Board doth hereby alter the General By-laws published in the *Government Gazette* of the 21st day of January, 1921, by inserting therein a new by-law numbered 76A as follows:—

76A. Dumping of Rubbish.

The Board prohibits the dumping of rubbish, filth or scrap material upon any road-site, reserve or common under the control of the said Board.

Any person contravening this by-law shall be liable to a penalty of  $\pounds 5$ .
