WHEREAS it is provided by regulation 2 of the Schedule to the Road Districts Act, 1919-1954, in reference to buildings on any block of land laid out for building, that the area allotted to any building, and the open space used in connection with such building, shall together be not less than the area for the time being fixed by proclamation as the proper area to be allotted to such building; and whereas a proclamation was issued under the said Act and published in the Government Gazette on the 15th day of October, 1954, page 1766, declaring that the minimum area to be allotted to every building intended to be or capable of being used as a dwelling house and the open space exclusively belonging thereto in the locality forming part of the Peppermint Grove Road District which is bounded on the North by the Southern alignment of Johnston Street from its intersection with Stirling Highway to the intersection of

that alignment with the Western alignment of Palmerston Street proceeding in a Southerly direc-tion along that alignment to the Southern boundary of the Peppermint Grove Road District, thence following the said Southern boundary in a West-erly direction to the intersection of that boundary with the Eastern alignment of Stirling Highway, with the Eastern alignment of Stirling Highway, thence proceeding in a Northerly direction along Stirling Highway to the starting point, which locality is referred to as Locality "A," shall be an area of not less than 3,648 square feet and that the minimum area to be allotted to every building intended to be or capable of being used as a dwel-ling house and of the open space exclusively be-longing thereto in the locality of the Peppermint Grove Road District excluding therefrom the said Locality "A" shall be an area of not less than 9,500 square feet; and whereas it is deemed expe-dient to vary the said proclamation and in lieu dient to vary the said proclamation and in lieu thereof to provide for the minimum area to be allotted to every building intended to be or capable of being used as a dwelling house, and of the open space exclusively belonging thereto in the district: Now, therefore I, the said Governor, actdistrict: Now, therefore I, the said Governor, act-ing with the advice and consent of the Executive **Council**, do hereby revoke the said proclamation of the 15th day of October, 1954, and do hereby declare and proclaim that the minimum area to be allotted to every building intended to be or capable of being used as a dwelling house and of the open space exclusively belonging thereto in the said Peppermint Grove Road District shall be an area of not less than 7,500 square feet. an area of not less than 7,500 square feet

### Marketing of Onions Act, 1938-1953.

### PROCLAMATION

WESTERN AUSTRALIA, TO WIT, } CHARLES HENRY GAIRDNER, Governor. [L.S.]

By His Excellency Lieutenant-General Sir Charles Henry Gairdner, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Knight Commander of the Royal Vic-torian Order, Companion of the Most Honour-able Order of the Bath, Commander of the Most Excellent Order of the British Empire, Governor in and over the State of Western Australia and its Dependencies in the Commonwealth of Australia.

WHEREAS it is enacted by section 4 of the Marketing of Onions Act, 1938-1953, that the Governor may at any time, on the application of The Western Australian Onion Marketing Board provide and declare by proclamation that the property in all onions belonging to growers shall, forthwith upon the date of publication of the proclamation or on or from some other date specified therein, be divested from the growers thereof and become vested in and be the absolute property of the Board as the owner thereof, and that any onions belonging to the growers thereafter coming into existence within a time specified in the proclamation shall become vested in and be the absolute property of become vested in and be the absolute property of the Board, and may by such proclamation make such further provision as will enable the Board effectively to obtain possession of such onions, and to deal with the same, as may be deemed necessary or convenient in order to give full effect to the objects and purposes for which the Board has been constituted; and whereas the Board has made application for the issue of a proclemation generation application for the issue of a proclamation accordingly, and it is deemed desirable and expedient that such proclamation shall be issued: Now, therefore I, the Governor, acting with the advice and con-sent of the Executive Council, and pursuant to the application of The Western Australian Onion Marketing Board, and in exercise of the powers conferred by section 4 of the Act, do hereby provide and declare for the purposes of the Act, that from the 1st day of October, 1955, to the 30th day of September, 1956, the property in all onions then belonging to growers within the meaning of the Act shall, subject to all lawful exceptions and to any exemptions which may be lawfully granted by

the Board, be divested from the growers thereof, and shall become vested in and be the absolute property of The Western Australian Onion Mar-keting Board as the owner thereof, and the Board may, but subject to the regulations at any time or from time to time in force do such lawful acts and things, and take such lawful means, as the owner thereof to obtain effectively possession of the onions which by notice of this proclamation are the abso-lute property of the Board, and to deal with the same as the Board may deem necessary or con-venient, in order to give full effect to the objects and purposes for which the Board has been constituted.

WHEREAS by section 33 of the Land Act, 1933-1954, it is made lawful for the Governor to direct that any reserve shall vest in and be held by any municipality, road board, or other person or persons to be named in the order, in trust for any of the purposes set forth in section 29 of the said Act, or for the like or other public purposes to be specified in such order and with power of subleasing; and whereas it is deemed expedient that reserve No. 23372 (Kukerin Lot 141) should vest in and be held by the Dumbleyung Road Board in trust for the purpose of Saleyards. Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned reserve shall vest in and be held by the Dumbleyung Road Board in trust for Saleyards, with power to the said Dumbleyung Road Board subject to the approval in writing of the Minister for Lands being first obtained, to lease the whole or any portion of the said reserve for any term not exceeding twenty-one (21) years from the date of the lease.

### Traffic Act, 1919-1954.

## Carnarvon Municipal Council.

ORDER IN COUNCIL. L.G. 1292/52.

HIS Excellency the Governor, acting by and with the advice and consent of the Executive Council, hereby makes the following order under section 49 of the Traffic Act, 1919-1954, namely, that the Carnarvon Municipal Council is hereby empowered to make by-laws in pursuance of—

- clause (a) of paragraph (i) of subsection
   (1) of section 47 of the said Act, prescribing the rules to be observed in respect of any vehicle being driven or used on roads;
- (2) clause (u) of paragraph (i) of subsection
  (1) of section 47 of the said Act, prohibiting the use of any specified road by any vehicle or by any person riding, driving, or in charge of any animal;
- (3) clause (v) of paragraph (i) of subsection (1) of section 47 of the said Act, prohibiting the use of any specified road by any vehicle or by any person riding, driving or in charge of any animal, except when proceeding in a prescribed direction;
- (4) clause (w) of paragraph (i) of subsection
  (1) of section 47 of the said Act, prescribing the routes to be followed by all classes of traffic, or any particular class of traffic or vehicle, from one specified point to another, either generally or between any specified times;
- (5) clause (y) of paragraph (i) of subsection (1) of section 47 of the said Act, providing for the placing, erection or installation on roads or footpaths of traffic signs and directions, and for the marking on roads or footpaths of signs for the direction of traffic, both vehicular and pedestrian;
- (6) clause (zd) of paragraph (i) of subsection
   (1) of section 47 of the said Act, appointing stands and parking places for different classes of vehicles and regulate the use thereof;
- (7) clauses (zl) and (zm) of paragraph (i) of subsection (1) of section 47 of the said Act, prohibiting or restricting the parking of vehicles or vehicles of a specified class or classes, in all roads, or in specified roads or specified parts of roads, at all times or at specified times, and prescribing a penalty for any breach thereof.

Subject to the condition that no such by-law shall be valid and effectual unless it has prior to notification of its making being published in the *Government Gazette* been submitted to and approved by the Governor.

Now, therefore, His Excellency the Lieutenant-Governor, by and with the advice of the Executive Council, hereby vests in Ross Campbell Dawkins and any persons appointed to act temporarily in his place, the appointment of foreman and all other persons employed on such works at a daily rate of wages.

### Adjustment of Accounts.

### ORDER IN COUNCIL.

L.G. 1771/52.

WHEREAS by an Order in Council published in the *Government Gazette* of the 10th June, 1955, at page 1329, there was severed from the Canning Road District and annexed to the South Perth Road District an area of land specified in the said order; and whereas under the provisions of section 10 of the Road Districts Act it is provided that the Governor may adjust and finally deter-mine all questions relating to the adjustment and sharing of property, debts and liabilities, etc., of any local authority affected by the severance of any part of a district; and whereas it is desirable any part of a district; and whereas it is desirable that certain property of the Canning Road Board as well as certain debts and liabilities should be transferred and adjusted as between the Can-ning Road District and the South Perth Road Dis-trict: Now, therefore, in exercise of the powers conferred by section 10 of the Road Districts Act, the Governor acting with the advise and consent the Governor, acting with the advice and consent of the Executive Council, doth hereby apportion and allocate the assets and liabilities in respect of that area which was severed from the Canning Road District and annexed to the South Perth Road District by declaring that the Canning Road Board shall transfer to the South Perth Road Board the assets and liabilities specified in Schedules 1, 2 and 3 hereunder and doth also further determine that in respect of all loans raised by the Canning Road Board on or before the 30th of June, 1955, the said Canning Road Board shall remain liable to repay to the debenture holders the whole of the moneys still unpaid.
