ORDER IN COUNCIL

Corres. 3694/70.

WHEREAS by section 33 of the Land Act, 1933-1969, it is *inter alia*, made lawful for the Governor by Order in Council, to direct that any land reserved pursuant to the provisions of this Act shall be granted in fee simple to any person (as defined in the said Section) subject to the condition that the person shall not lease or mortgage the whole or any part of the land without the consent of the Governor and subject to such other conditions and limitations as the Governor shall deem necessary to ensure that the land is used for the purpose for which the land is reserved as aforesaid; and whereas it is deemed expedient that Reserve No. 30827 (Swan Location 8590) should, subject as aforesaid be granted in fee simple to the Anglican Homes for the Aged to be held in trust for "Aged Persons' Homes": Now, therefore, His Excellency the Governor by and with the advice and consent of the Executive Council doth hereby direct that the beforementioned reserve shall be granted in fee simple to the aforesaid body, to be held in trust for the aforesaid purpose, subject to the condition that the land shall not be leased or mortgaged in whole or in part without the consent of the Governor.

ORDERS IN COUNCIL.

WHEREAS by section 288 of the Local Government Act, 1960-1970, it shall be lawful for the Governor, on request by a council of a Municipal District, by Order published in the *Government Gazette*, to declare any lands reserved or acquired for use by the public or used by the public as a street, way, public place, bridge or thoroughfare, under the care, control, and management of the Council, or lands comprised in a private street, constructed and maintained to the satisfaction of the Council, or lands comprised in a private street of which the public has had uninterrupted use for a period of not less than ten years, as a public street and if the Council thinks fit, that the Governor shall declare the width of the carriageway and footpaths of the public street; and whereas the Councils mentioned in the schedule hereto have requested that certain lands named and described in the said schedule, which have been reserved for streets within the said Councils, be declared public streets: Now, therefore, His Excellency the Governor by and with the advice and consent of the Executive Council, doth hereby declare the said lands to be public streets, and such land shall, from the date of this Order, be absolutely dedicated to the public as streets within the meaning of any law now or hereinafter in force.
