circle of five miles to which the Governor may from time to time by proclamation declare that the Act shall extend; and whereas it is also provided by that section that the Governor shall not make or issue any proclamation under that section to extend the limits of that Act to any place situated within the district of any municipal council or of any road board outside the said circle of five miles unless and until the municipal council or the road board concerned (as the case may be) has by resolution consented thereto; and whereas the Swan Shire Council has by resolution passed on the 31st day of December, 1970, consented to the extension of the limits of the Act to the whole of the former municipal district of the Town of Midland and now comprising the Midland Ward of the municipal district of the Shire of Swan: Now, therefore, I, the Governor, acting with the advice and consent of the Executive Council and in exercise of the powers aforesaid and of every other power in this behalf me enabling, do hereby proclaim and declare that the limits of the Act shall extend to and include the whole of the former municipal district of the Town of Midland and now comprising the Midland Ward of the municipal district of the Shire of Swan, being an area outside a circle of five miles from the General Post Office in the City of Perth.

Land Act, 1933-1969.

ORDER IN COUNCIL.

Corr. 5244/50.

WHEREAS by section 33 of the Land Act, 1933-1969, it is made lawful for the Governor to direct that any Reserve shall vest in and be held by any Municipality, Body Corporate, or other person or persons to be named in the Order, in trust for any of the purposes set forth in Section 29 of the said Act, or for the like or other public purposes to be specified in such Order and with power of sub-

leasing; and whereas it is deemed expedient that Reserve No. 23237 should vest in and be held by the Shire of Yilgarn in trust for the purpose of "Arboretum and Caravan Park": Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned Reserve shall vest in and be held by the Shire of Yilgarn in trust for "Arboretum and Caravan Park" with power to the said Shire of Yilgarn subject to the approval in writing of the Minister for Lands being first obtained, to lease the whole or any portion of the said Reserve for any term not exceeding 21 years from the date of the lease subject nevertheless to the powers reserved to him by section 37 of the said Act and to the following conditions:—

- (a) The portion of Reserve No. 23237 used as a Caravan Park shall not exceed 4.4 acres in extent.
- (b) The Shire Council shall amend its Town Planning Scheme to permit the operation of the Caravan Park on the Reserve.
- (c) The existing trees planted as an arboretum by the Forests Department shall be allowed to remain.
- (d) The Forests Department shall be permitted to plant an additional area of approximately 1.1 acres as provenance trials for River Gums.
- (e) The Shire Council shall provide a plan fixing the boundaries of any section to be leased.

Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned Reserves shall vest in and be held by the abovementioned bodies, in trust for the purposes aforesaid, subject nevertheless to the powers reserved to him by section 37 of the said Act.

WHEREAS by the Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1970, it is provided that, subject to the provisions of the Act, the Metropolitan Water Supply Sewerage and Drainage Board shall, with the approval of the Governor, have power to construct and provide and extend Water Works, Sewerage Works and Metropolitan Main Drainage Works; and whereas the preliminary requirements of the said Act have been complied with and plans, sections and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Governor by and with the advice and consent of the Executive Council, does hereby empower the Metropolitan Water Supply, Sewerage and Drainage Board to undertake the construction of the following works under the said Act, namely:—

City of Melville—Booragoon.

Eighteen-inch Distribution Main—Sicklemore Street and Rogerson Road, Booragoon.

The construction of an eighteen-inch diameter water main about four thousand two hundred feet in length complete with valves and all other necessary apparatus, and shown on plan M.W.B. 10958.

WHEREAS by the Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1970, it is provided that, subject to the provisions of the Act, the Metropolitan Water Supply, Sewerage and Drainage Board shall, with the approval of the Governor, have power to construct, provide and extend Water Works, Sewerage Works and Metropolitan Main Drainage Works; and whereas the preliminary requirements of the said Act have been complied with and plans, sections and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Governor by and with the advice and consent of the Executive Council does hereby empower the Metropolitan Water Supply, Sewerage and Drainage Board to undertake the construction of the following works under the said Act, namely:—

Shire of Kalamunda—Maida Vale.

Twelve-inch Feeder Main in Kalamunda Road.

The construction of a twelve-inch diameter water main, about two thousand one hundred and twenty feet in length, complete with valves and all other necessary apparatus, and shown on plan M.W.B. 10955.

This Order in Council shall take effect from the 21st day of May, 1971.

Local Government Act, 1960-1970.

ORDER IN COUNCIL.

L.G. 736/70.

WHEREAS it is enacted by section 433A of the Local Government Act, 1960-1970, that the Governor may, *inter alia*, make and publish in the *Government Gazette* uniform general by-laws for all or any of the purposes for which by-laws may be made by a council under Part XV of that Act, and by order, declare that all or any such uniform general by-laws as are specified in the order together with any amendments thereof whether by way of addition, substitution or cancellation shall apply to the whole or any portion of a district so specified; and whereas it is enacted, *inter alia*, by section 691 of that Act that power given by that Act to make Orders in Council includes power from time to time to revoke or cancel those orders wholly or in part for the purpose of substituting other Orders in Council for those revoked or cancelled; and whereas the Governor has made and published uniform general by-laws, namely, the Uniform Building By-laws, 1965, and has from time to time made and published amendments thereto: Now, therefore, His Excellency the Governor, acting with the advice and consent of the Executive Council and in exercise of the powers aforesaid, doth hereby revoke wholly every Order in Council heretofore made under section 433A of the Local Government Act, 1960, as amended from time to time, and doth hereby declare that of the Uniform Building By-laws, 1965, published in the *Government Gazette* on the 15th October, 1965, and all the amendments made to those by-laws after that day but before the date of the publication of this Order in Council in the *Government Gazette*—

- (a) the whole of each of them, with the exception of paragraph (a) of by-law 2805, applies to the whole of the municipal district of the Shire of Rockingham;
- (b) the whole of each of them applies to the municipal district of the Shire of Swan with the exception of paragraph (a) of sub-by-law (1) of by-law 203 and sub-by-law (2) of by-law 2832 which apply only

to those portions of the district which are not shown as for "Rural Development", on the Metropolitan Regional Plan;

- (c) the whole of each of them applies to the whole of each of the municipal districts set out in the first schedule hereto; and
- (d) the whole of each of them applies to those portions specified in each of the districts set out in the second schedule.
