Local Government Act. 1960-1970.

#### ORDER IN COUNCIL

L. & S. Corres. 1827/67 (MR769).

WHEREAS by section 288 of the Local Government Act, 1960-1970, it shall be lawful for the Governor, on request by a Council of a Municipal District, by Order published in the Government Gazette to declare any lands reserved or acquired for use by the public or used by the public as a street, way, public place, bridge or thoroughfare, under the care, control, and management of the Council, or lands comprised in a private street, constructed and maintained to the satisfaction of the Council, or lands comprised in a private street of which the public has had uninterrupted use for a period of not less than ten years, as a public street and if the Council thinks fit, that the Governor shall declare the width of the carriageway and footpaths of the public street; and whereas the City of Perth has requested that certain lands remed and described in the schedule certain lands named and described in the schedule hereunder, which have been reserved for a street within its municipal district be declared a public street: Now, therefore, His Excellency the Governor by and with the advice and consent of the Executive Council, doth hereby declare the said lands to be a public street, and such land shall, from the date of this Order, be absolutely dedicated to the public as a street within the meaning of any law now or hereafter in force.

WHEREAS it is provided, inter alia, by section 688 of the Local Government Act, 1960-1970, that where through an accidental omission anything required to be done by or under that Act is not done or is not done within the prescribed time, manner or form the Governor, for the purpose of giving effect to the intention and purposes of the Act, may by order take such measures as are necessary for rectifying the omission and may validate anything which has been done otherwise than in the prescribed time, manner or form; and whereas the Minister for Local Government, acting pursuant to subsection (6) of section 297A of the Local Government Act, 1960-1970, caused to be published in the Government Gazette on the 8th January, 1971, notice that the Governor had approved a resolution passed by the Perth City Council on the 20th July, 1970, "that the private street bounded by Jupiter, Oats and Tuckett Streets be closed and the whole of the private street on the northwest side of Lot 132 and half the section on the southern side be granted to Lot 132, and the balance of the private street be divided between adjoining owners as shown on the compiled diagram" and that notice included in the Schedule thereto a copy of that diagram; and whereas, by

accidental omissions, notices required, under pararaph (c) of subsection (1) of that section 297A, to be served on the owners of Lots 68, 69 and 5, being lots, as shown on that diagram, that abut on the private street the subject of the resolution, were not so served until about the 5th March, 1971; and whereas those owners have not since objected to the closure of the private street and division of its balance in accordance with the resolution: Now, therefore, His Excellency the Governor, acting with the advice and consent of the Executive Council and pursuant to the powers conferred by section 688 of the Local Government Act, 1960-1970, doth hereby-

- (a) rectify those omissions by directing that the Town Clerk of the City of Perth shall, as soon as practicable, cause a copy of this Order to be served on each of the owners referred to above; and
- (b) validate-
  - (i) the notices served about the 5th March, 1971 on those owners; and
  - (ii) the closure of the private street and the division of its balance in accordance with that notice published in the Government Gazette on the 8th January, 1971.

#### PART III.—NON-CONFORMING USE OF LAND.

- 3.1 No provision of the Scheme shall prevent-
  - (a) the continued use of any land or building for the purpose for which it was being lawfully used at the time of the coming into force of the Scheme; or
  - (b) the carrying out of any development thereon for which, immediately prior to that time a permit or permits required under the Town Planning and Development Act, 1928 (as amended), and any other law authorising the development to be carried out have been duly obtained and was current.
