WHEREAS by section 31 of the Land Act, 1933-1969, the Governor may by Proclamation and subject to such conditions as may be expressed therein, classify as of Class A any lands of the Crown reserved to Her Majesty for any of the purposes specified in the said section; and whereas it is deemed expedient that the addition to Class "A" Reserve No. 24491 for the purpose of "National Park," as described hereunder, should be classified as of Class A: Now, therefore, I, the Governor with the advice of Executive Council do by this my Proclamation classify as of Class A the reserve described hereunder.

ORDER IN COUNCIL.

Corres. 645/71.

ORDER IN COUNCIL.

ORDER IN COUNCIL.

L.G. 394/65.

WHEREAS it is enacted by section 433A of the Local Government Act, 1960-1970, that the Governor may, *inter alia*, make and publish in the *Government Gazette* uniform general by-laws for all or any of the purposes for which by-laws may be made by a council under Part XV of that Act and, by order, declare that all or any such uniform general by-laws as are specified in the order together with any amendments thereof whether by way of addition, substitution or cancellation shall apply to the whole or any portion of a district so specified; and whereas the Governor has made and published uniform general by-laws, namely the Uniform Building By-laws, 1965 and has from time to time made and published amendments thereto: Now, therefore, His Excellency the Governor, acting with the advice and consent of the Executive Council and in exercise of the powers aforesaid, doth hereby declare that the whole of each of the Uniform Building By-laws, 1965 published in the *Government Gazette* on the 15th October, 1965 and all the amendments made to those by-laws after that day but before the date of the publication of this Order in Council in the *Government Gazette* applies to that portion of the district of the Shire of Carnarvon set out in the Schedule hereto.

TOWN PLANNING SCHEME.
Scheme Text.

THE Serpentine-Jarrahdale Shire Council, under and by virtue of the powers conferred upon it in that behalf by the Town Planning and Development Act, 1928 (as amended) and the Metropolitan Region Town Planning Scheme Act, 1959 (as amended) hereby makes the following Town Planning Scheme for the purpose of:—

- (a) setting aside land for future public use as reserves;
- (b) controlling land development;
- (c) other matters authorised by the enabling Act.

PART I.—PRELIMINARY.

1.1 This Town Planning Scheme may be cited as the Shire of Serpentine-Jarrahdale Town Planning Scheme hereinafter called "the Scheme" and shall come into operation on the publication of notice of the Minister's final approval thereof in the *Government Gazette*.

1.2 The Scheme shall apply to the whole of the Municipality of the Shire of Serpentine-Jarrahdale, which is 287.6 square miles in area.

1.3 The Scheme is complementary to, and is not a substitute for, the Metropolitan Region Scheme and the provisions of the Metropolitan Region Scheme as amended from time to time, shall continue to have effect.

1.4 The responsible authority for carrying out the Scheme is the Council of the Shire of Serpentine-Jarrahdale (hereinafter referred to as the Council) except that where land is shown in the Scheme Map as—

- (i) "Regional Reservation" the responsible authority shall be deemed to be the Metropolitan Region Planning Authority and the provision of the Metropolitan Region Scheme shall apply to such reservations.
- (ii) "Primary School" sites, the responsible authority shall be deemed to be the Minister for Education.

1.5 Arrangements of Scheme:

The Scheme Text is divided into the following Parts:

- Part I.—Preliminary.
- Part II.—Reserved Land.
- Part III.—Zones.
- Part IV.—Non-conforming Uses.
- Part V.—General Provisions.
- Part VI.—Finance and Administration.

The remaining documents of the Scheme are as follows:—

- (a) Land Use Map.
- (b) Scheme Map.

1.6 Interpretation: In this Scheme the terms used will have the respective interpretations set out in Appendix "D" of the Town Planning Regulations 1967, unless otherwise specified by this Scheme.

1.7 Appeal Rights: Any person aggrieved by a decision of the Council exercising the discretionary powers embodied in this Scheme Text may appeal from that decision to the Minister for Town Planning or to the Town Planning Court. Procedure for the lodgment and dealing with appeals is as set out in Part 5 of the Town Planning and Development Act, 1928 (as amended) and Regulations made under that Act.

PART II.—RESERVED LAND.

2.1 Reservation of Land and Development thereof:—

- (a) Land set aside under this Scheme for the purposes of a reservation is deemed to be reserved for the purposes indicated on the Scheme Map. Primary school sites are as shown on drawings 1 and 2 in the 2nd Schedule of this text. Reservations of the Metropolitan Region Scheme are shown in the Scheme in order to comply with the provisions of the Metropolitan Region Town Planning Scheme Act.
- (b) Except as otherwise provided in this Part a person shall not carry out any development on land reserved under this Scheme, other than the erection of a boundary fence, without first applying for and obtaining the written approval of the Council.
- (c) In giving its approval the Council shall have regard to the ultimate purpose intended for the reserve. In the case of land reserved for the purpose of a public authority, the Council shall confer with that authority before the application is determined.
- (d) No provision of this Part shall prevent the continued use of land for the use for which it was being lawfully used immediately prior to the Scheme having the force of law, or the repair and maintenance, for which the prior consent in writing of the Council has been obtained, of buildings or works lawfully existing on the land.

2.2 (a) Where a Council refuses approval for the development of land reserved for its purposes under the Scheme, on the grounds that the land is reserved for public purposes, or grants approval subject to conditions that are unacceptable to the applicant, the owner of the land may, if the land is injuriously affected thereby and within six months of the Council's decision claim compensation for such injurious affection.

(b) Claims for such compensation shall be lodged at the office of the Council not later than six months after the date of the decision of the council refusing approval or granting it subject to conditions that are unacceptable to the applicant.

(c) In lieu of paying compensation the Council may purchase the land affected by such decision of the Council at a price not exceeding the value of the land at the time of refusal of approval or of the grant of approval subject to conditions that are unacceptable to the applicant.

PART III.—ZONES.

3.1 Notwithstanding anything to the contrary in this Scheme and without affecting the generality of clause 1.3 of Part I, the Council may with the consent of the Minister, or when required by the Metropolitan Region Planning Authority so to do, shall require that the development of any land within the District, however zoned shall be subject to the provisions of Clauses 10, 24 and 30 of the Metropolitan Region Scheme.

3.2 The Scheme area is divided into two (2) zones set out hereunder:—

- (a) Rural Zone.
- (b) Urban Zone.

3.3 Table No. 1 appended to Clause 3.4 of this Part indicates the several uses permitted by this Scheme in the various zones, such uses being determined by cross reference between the list of "Use classes" on the left-hand side of the Table and the list of "Zones" on the top of that Table.

In respect of any use that is not specifically listed in the Table the Council shall determine in which Zone or Zones the use may be permitted provided that such a proposal to commence the use shall be determined pursuant to the "SP" procedure detailed below.

3.4 The symbols used in the cross reference in Table No. 1 appended to this clause have the following meanings:

"P"—A use that is permitted under this Scheme.

"AA"—A use that is not permitted unless Council gives its approval in writing after giving consideration to the effect that such a use would have on the amenity, health, convenience and economy of the existing or planned uses nearby.

"SP"—A use that is not permitted unless written approval for such use is granted by the Council. The Council shall require that the applicant will at his own cost, and to the satisfaction of the Council:

- (1) Place in a conspicuous position on the site proposed for such a use and in the office of the Council a notice in the Form SP No. 1 contained in Schedule 1;
- (2) Advertise the proposed use in Form SP No. 1 contained in Schedule 1, once a week for three consecutive weeks in a newspaper having a circulation in the Shire of Serpentine-Jarrahdale; and

- (3) Give notice in Form SP No. 2 contained in Schedule 1, of the proposed use to the owners and occupiers of all land nearby that in the opinion of the Council may be affected by the proposed use. This provision does not prevent any resident or ratepayer of the District from objecting to or supporting the proposed use and as far as practicable, Form SP No. 3 shall be used for such a purpose;

The Council shall then consider any objections to and support for the proposed use, which are delivered to the Council in writing within 35 days of the date shown on the notice in Form SP No. 1 referred to in paragraph (1).

"IP"—A use that is not permitted unless such use is incidental to the predominant use as decided and approved by the Council.

"X"—A use that is not permitted.

PART IV.—NON-CONFORMING USE OF LAND.

4.1 No provision of the Scheme shall prevent:

- (a) the continued use of any land or building for the purpose for which it was being lawfully used at the time of the coming into force of the Scheme; or
- (b) the carrying out of any development thereon for which immediately prior to that time, a permit or permits required under the Town Planning and Development Act, 1928 (as amended) and any other law authorising the development to be carried out have been duly obtained and was current.

4.2 (a) Where in respect of land reserved under Part II of the Scheme a non-conforming use exists or was authorised as mentioned in clause 4.1 of this Part on that land all or any erections alterations or extensions of the buildings thereon or use thereof shall not be carried out unless the approval of the Council has been obtained in writing.

(b) Where in respect of land zoned under Part III of the Scheme a non-conforming use exists or was authorised as mentioned in clause 4.1 of this Part on that land, and provided the prior consent in writing of the Council has been obtained, buildings may be extended to the limits prescribed by the Uniform Building By-laws made under the Local Government Act, 1960 (as amended), or by any other by-laws made under that Act for the purpose of limiting the size, location and distance from boundaries and any other matter required by law for that class of use within the boundary of the lot or lots on which the use was carried on immediately prior to the coming into force of the Scheme.

4.3 Change of Non-Conforming Use: The Council may permit the use of any land to be changed from one non-conforming use to another non-conforming use, provided the proposed use is, in the opinion of the Council, less detrimental to the amenity of the neighbourhood than the existing use, or is in the opinion of the Council closer to the intended uses of the zone.

4.4 Discontinuance of Non-conforming Use:

- (a) Notwithstanding the preceding provisions of this Part, except where a change of non-conforming use has been permitted by the Council under clause 4.3, when a non-conforming use of any land or building has been discontinued, such land or building shall not thereafter be used other than in conformity with the provisions of the Scheme.
- (b) The Council may effect the discontinuance of a non-conforming use by the purchase of the affected property, or by the payment of compensation to the owner or the occupier or to both the owner and the occupier of that property, and may enter into an agreement with the owner for that purpose.

PART V.—GENERAL PROVISIONS.

5.1 Residential Development: For residential development the provisions of the General Residential Zone—Class 4 (GR-4) as specified in the Uniform Building By-laws shall apply.

5.2 Waste Disposal: No land shall be used for the disposal of refuse, garbage or industrial waste without the prior consent of the Council.

5.3 Mining, Quarrying and other Extractive Industry: The Council shall have the right to impose such conditions as it sees fit on the rehabilitation and use of areas required for the extraction of material.

PART VI.—FINANCE AND ADMINISTRATION.

6.1 Disposal of Land: The Council may deal with or dispose of any land which it owns or which it has acquired pursuant to the provisions of the Scheme, in accordance with the Act and in conformity with the provisions of the Scheme, and for such purpose may make such agreements with other owners as it deems fit.

6.2 Compensation: Claims for compensation by reason of the Scheme other than for the purpose of Part II shall be made not later than six months from the date on which notice of approval of the Scheme is published in the Government Gazette, except in the case of reserved land where the provisions of Part II shall apply.

6.3 Entry to Premises: The Council may by an authorised officer at all reasonable times enter any building or land for the purpose of ascertaining whether the provisions of the Scheme are being observed.

6.4 Penalties: Any person who fails to comply with any of the provisions of the Scheme is guilty of an offence and without prejudice to any other remedy given herein is liable to such penalties as are prescribed by the Act.

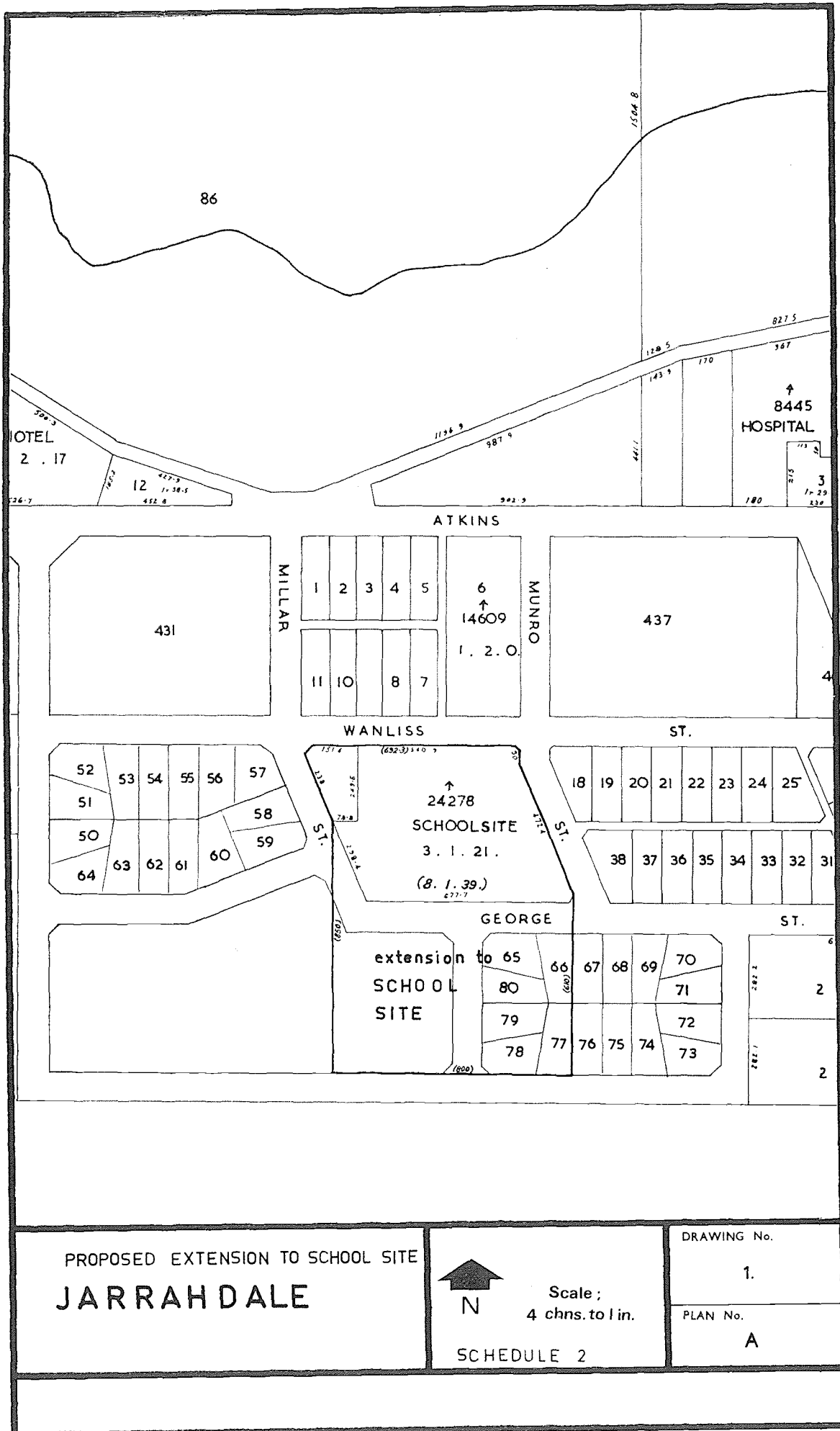

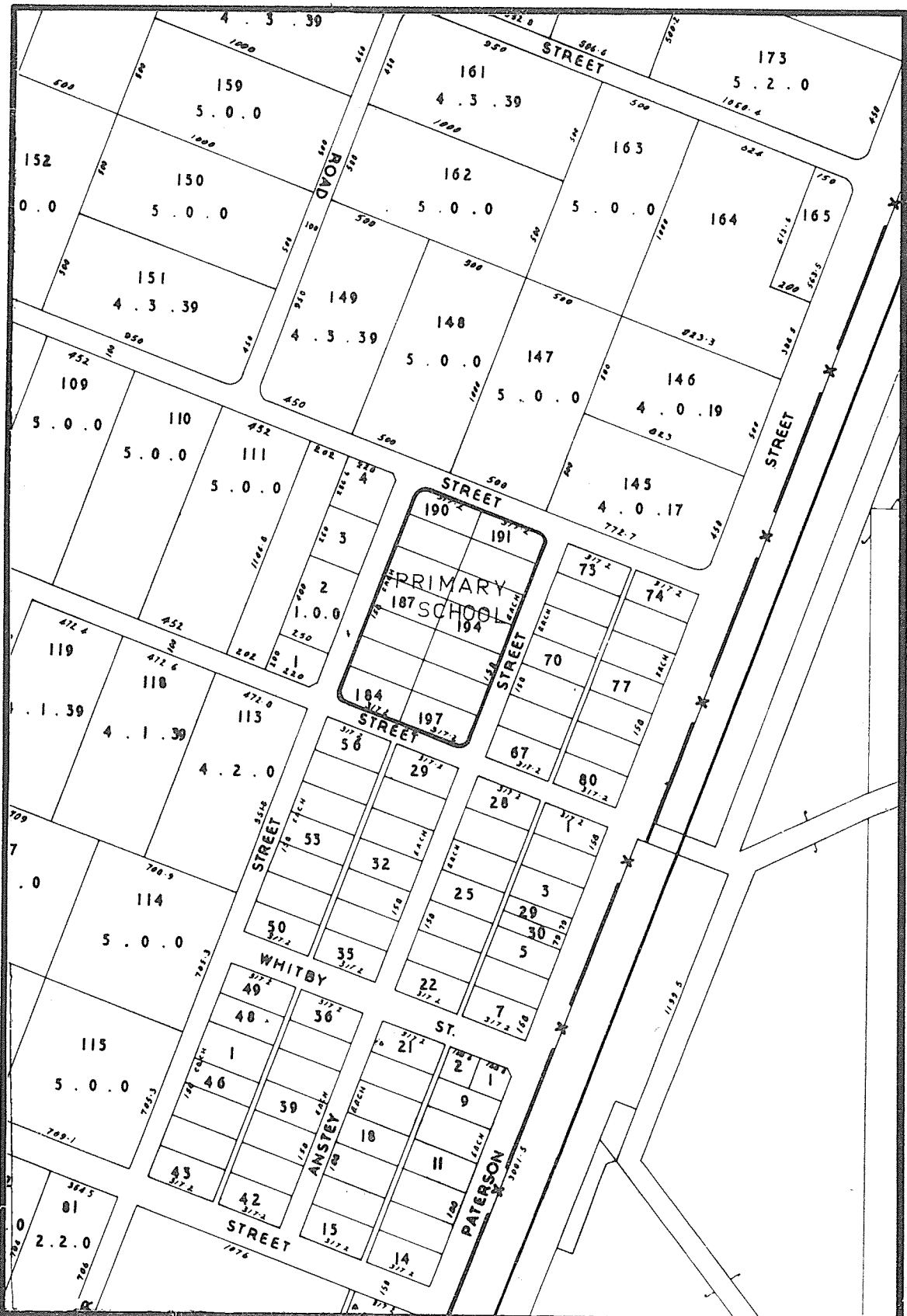

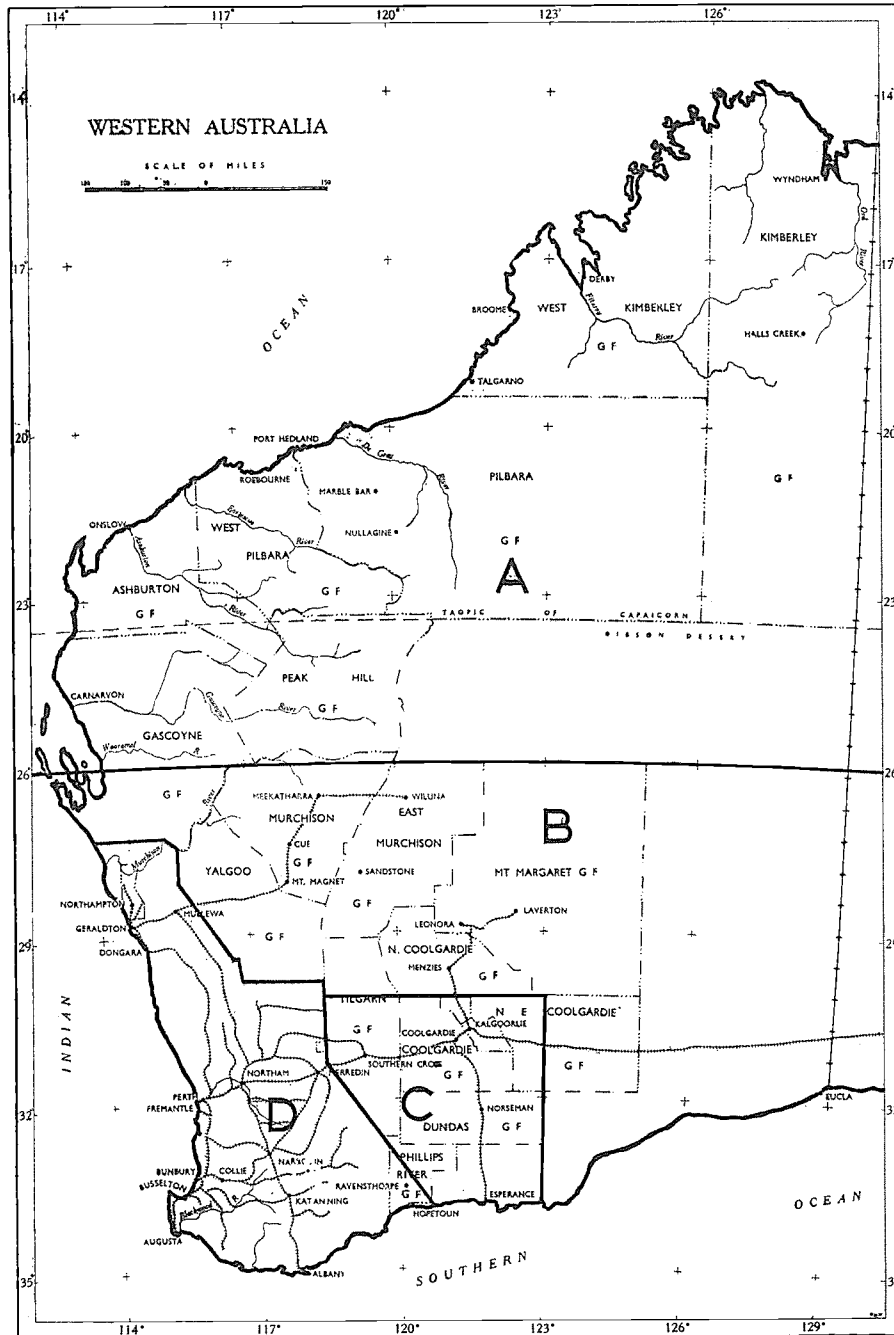
