Coolgardie Sewerage Scheme.

PURSUANT to the provision of section 57 (2) of the Health Act 1911-1979 the Council of the Shire of Coolgardie hereby give notice that it proposes to construct a Sewerage Scheme within the town of Coolgardie for the purpose of draining waste water and effluent from dwellings and business premises in the town site of Coolgardie and to treat the waste water in the sewerage lagoons located west of Coolgardie.

The construction of Stage 1 part A and B within the boundary of the shaded area and the lagoon site of plan No. 5042 1 of 9 prepared by G. J. Looten, Consulting Chartered Engineer, is anticipated to take place over the years 1982/83 to and including the year 1983/84.

It is estimated that the capital cost of Stage 1 part A & B of the Scheme is \$85 000.00 and it is proposed to fund the works by loans to be raised by the Shire of Coolgardie.

The estimated annual value of the properties to be served is \$12 500.

Water Supply for the scheme will come from existing P.W.D. Country Water Supply Scheme.

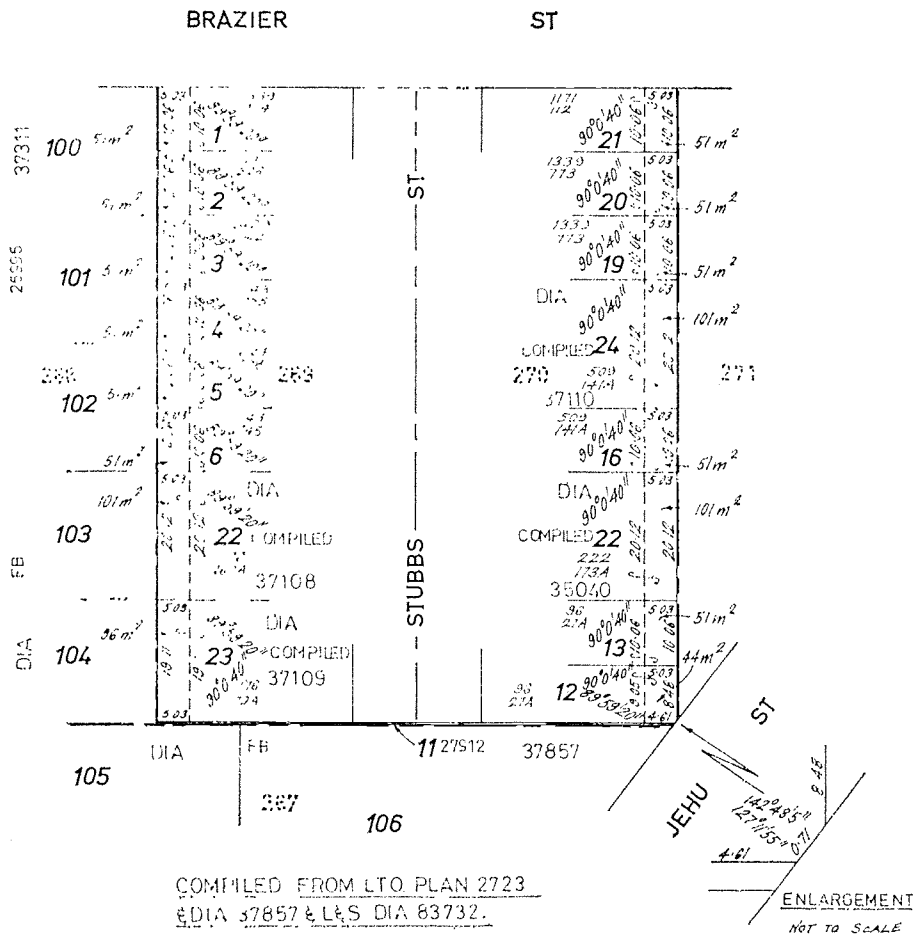

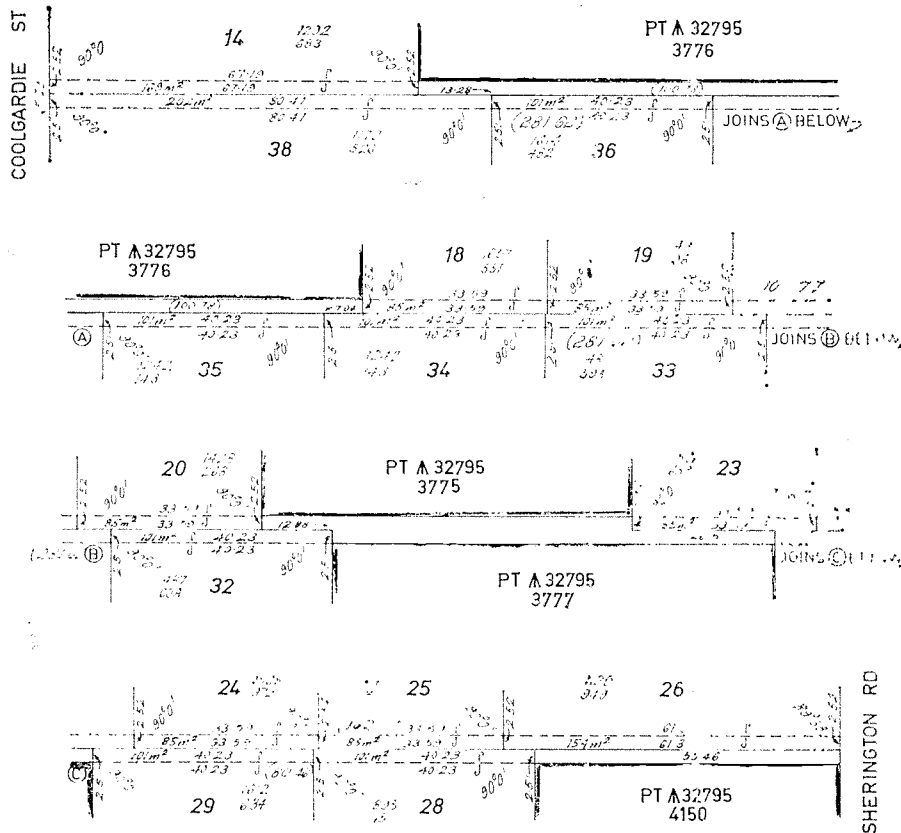

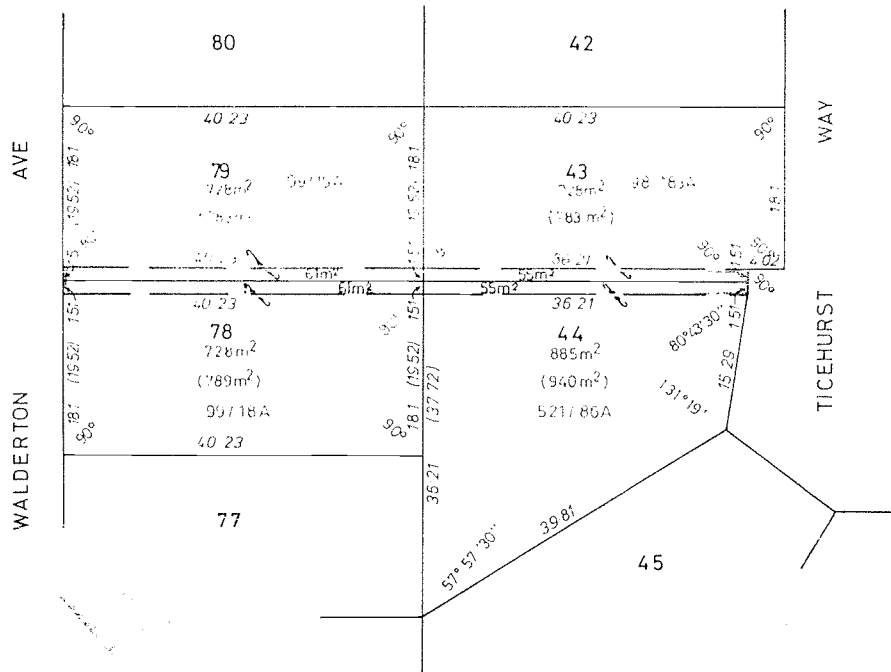
