PREVENTION OF EXCESSIVE PRICES ACT 1983. Notice.

I, ARTHUR RAYMOND TONKIN, Minister for Consumer Affairs, and the Minister for the time being administering the Prevention of Excessive Prices Act 1983, in pursuance of the powers vested in me by section 10 (1) of the said Act, hereby declare for the purposes of the said Act the following goods and services—

- (a) particular goods being motor fuel being petrol or diesel fuel used in propelling a motor vehicle;
- (b) particular services being the provision for reward of commercial accommodation at sites being premises at which motor fuel is sold by retail and is usually dispensed through dispensing equipment.

This notice shall apply to and require all persons being franchisors within the meaning of the Petroleum Retail Marketing Franchise Act 1980 being a supplier of the above declared services to notify the Prices Commissioner not less than fourteen (14) working days prior to the day on which a proposed increase is to take effect of a proposed increase in the rate for that declared service to which such person proposes to give effect and shall comply with the provisions of section 11 (2) of the said Act.
