does hereby empower the Metropolitan Water Authority to undertake the construction of the following works under the said Act, namely:—

Town of Armadale.

Neerigen Brook Main Drain—Improvements—South Western Railway to Dale Road—Armadale.

Works comprise improvements to that section of the existing Neerigen Brook Main Drain which is located between the South Western Railway and Dale Road, Armadale. The total length of drain to be improved is approximately four hundred and fifty metres.

The improvements include:—

- (i) The construction of two, one thousand eight hundred millimetre diameter reinforced concrete pipe culverts complete with end structures. One culvert is to cross Railway Avenue and is to be approximately thirty metres long. The second is to cross Abbey Road and is to be approximately forty metres long.
- (ii) The relocating, deepening, widening and straightening of the remaining open earth sections of drain. These improved sections of drain are to have a bottom width of approximately 4.0 metres, side slopes of approximately one vertical to one horizontal, depths varying from 1.8 to 3.0 metres and a total length of approximately three hundred and eighty metres.
- (iii) The construction of a reinforced concrete drop structure.

Works are to be complete with all apparatus and things connected therewith and includes all land acquisitions arising therefrom and restoration and reinstatement where required.

Actual construction works will take place in or adjacent to the following properties:—

Lots 6, 7, 146, 147 and 148 Railway Avenue, Lots 157 and 158 Abbey Road, Lots 80, 81, 82 and 83 Marian Avenue, Lot 3 Dale Road, Lots 201, 202, 203 and 204 Forest Court, the South Western Railway Reserve, Railway Avenue (itself) Abbey Road (itself) and various pieces of land which have already been set aside for drainage purposes.

It should be noted that not all portions of the improvement works will be carried out at the same time. Where improvements are deferred flow will continue to discharge down the existing watercourse which will be subject only to normal maintenance and minor improvement. The timing of the construction of the future work has not yet been determined, but will be dependent on further increases in peak flow rates.

The location of the above works, including that which is to be carried out in the future, is shown on plan M.W.A. 18012A As Amended.

This Order in Council shall take effect from the 21st day of October 1983.

## MAIN ROADS ACT 1930-1982.

## MAIN ROADS (CONTROL OF SIGNS) REGULATIONS 1983.

MADE by His Excellency the Governor in Executive Council on the recommendation of the Commissioner of Main Roads.

- Citation. 1. These regulations may be cited as the Main Roads (Control of Signs) Regulations 1983.
- Interpretation. 2. (1) In these regulations, unless the contrary intention appears—  
 “illuminated sign” means a sign that is so arranged as to be capable of being lighted from within or without by artificial light provided, or mainly provided, for that purpose;  
 “railway land” means land on which a railway is constructed or which is used in connection with or for the purposes of a railway;  
 “regulation” means a regulation appearing in these regulations;  
 “residential area” means—  
 (a) an area that has been so designated under a town planning scheme or in by-laws made under section 31 of the Town Planning and Development Act 1928 or section 248 of the Local Government Act 1960;  
 (b) any lot, not exceeding 2 000 m<sup>2</sup> in area, used or intended to be used for residential purposes;  
 “sign” means—  
 (a) any sign, model, placard, board, notice, device or representation in the nature of, and employed wholly or partly for the purposes of, advertisement; and  
 (b) any hoarding or similar structure used for the display of anything mentioned in paragraph (a) of this definition;  
 the expressions “building line”, “council”, “district”, “owner” and “street alignment” have the respective meanings given to them by section 6 of the Local Government Act 1960.  
 (2) For the purposes of regulation 5 (1), a sign is in the vicinity of a highway or main road if it is primarily directed at persons travelling in or on vehicles on that highway or main road.
- Application. 3. (1) These regulations do not apply to—  
 (a) a sign, indicating that the premises whereon it is affixed or erected are for sale or for letting, that does not exceed 1 m<sup>2</sup> in area;  
 (b) a sign, indicating the name, or the name and the trade or occupation, of the occupier of premises, that—  
 (i) is affixed to the premises or erected or affixed on or behind the building line and does not exceed 0.4 m<sup>2</sup> in area;  
 (ii) is erected or affixed on the street alignment, or between the street alignment and the building line, and does not exceed 0.2 m<sup>2</sup> in area;  
 (c) a sign inside a building, other than an illuminated sign directed primarily at persons travelling in or on vehicles;  
 (d) a sign indicating the name of a block of residential flats or home units, that is affixed to the building and that consists of a single line of letters which do not exceed 300 mm in height.  
 (2) For the purposes of subregulation (1) the area of a sign shall be ascertained by reference to a notional rectangle enclosing the outermost portions of the sign; and in computing the area only that part or those parts of the sign which are reasonably capable of being seen and discerned from any one direction at a time shall be counted.
- Certain by-laws not affected. 4. These regulations are in addition to, and not in derogation of, any by-laws made or adopted by a council under the Local Government Act 1960 which relate to the prohibition, regulation or control of signs, within the district in which that council has jurisdiction.
- Offence to erect or display sign without consent of Commissioner. 5. (1) Subject to regulation 13 (2), a person who erects or displays, or causes or permits to be erected or displayed, any sign on or in the vicinity of any highway or main road without the written consent of the Commissioner, or otherwise than in accordance with the terms and conditions of such consent, commits an offence.  
 (2) A consent of the Commissioner—  
 (a) is in force for the purposes of subregulation (1)—  
 (i) only for such time as is specified in the consent; or  
 (ii) until it is sooner cancelled under regulation 8; and  
 (b) may be given on such terms and conditions as the Commissioner thinks fit.  
 (3) For the purposes of subregulation (1), but without limiting the generality thereof, a person who—  
 (a) puts a sign in place;  
 (b) attaches or affixes a sign to any structure;  
 (c) paints any figure, letter or representation comprising a sign or part thereof; or  
 (d) maintains a sign,  
 is deemed to erect and display it.

- Applications for consent.
6. (1) An application for the consent of the Commissioner to the erection and display of a sign shall be made through the council which has jurisdiction in the district in which it is to be erected or displayed.
- (2) The application shall be made in the manner prescribed by any by-law made by that council which relates to the prohibition, regulation or control of signs or, if no such by-law has been made, then in the manner prescribed by the latest draft model by-law, as amended, relating thereto published in the *Gazette* pursuant to section 258 of the Local Government Act 1960, as if the same had been adopted by that council.
- Criteria to be applied by Commissioner.
7. (1) Where an application for consent is made under regulation 6, the Commissioner shall consent to the erection and display of the sign unless, in his opinion, it—
- (a) would not comply with any by-law, relating to the prohibition, regulation, and control of signs made, or deemed by subregulation (2) of this regulation to have been made, by the council which has jurisdiction in the district in which it is to be erected and displayed;
  - (b) would be erected or displayed on a road;
  - (c) would be a danger to public safety by creating a traffic hazard;
  - (d) would detract from the aesthetic environment of a public park or pleasure ground;
  - (e) would result in the proliferation of signs on any premises or in any area;
  - (f) would contain material which is too lengthy or the meaning of which is not sufficiently clear or unambiguous;
  - (g) would not be reasonably visible and discernible to all persons to whom it would be directed;
  - (h) would be erected or displayed on any natural feature, including a rock or tree, or on any bridge or viaduct or the abutments or structural approaches to a bridge or viaduct;
  - (i) would be situated in a residential or a rural area and would be otherwise than for the purpose of identifying the premises, or a business carried on in the premises, on which it would be situated;
  - (j) would be situated on railway land and within 100 metres of a railway level crossing which may be used by vehicular traffic;
  - (k) would be erected or displayed on a vehicle left standing or parked on a highway or main road primarily for the purpose of displaying or exhibiting such sign;
  - (l) in the case of an internally illuminated sign, would be displayed in such a manner as to cause glare or dazzle to, or to otherwise distract, the drivers of vehicles, or to affect the amenity of the area;
  - (m) in the case of an externally illuminated sign the light would not be directed solely on to the sign and its surround, and the light source would not be so shielded that glare would not occur or extend beyond the sign;
  - (n) would be likely to interfere with adversely, or to cause risk of danger to, road traffic by virtue of the fact that it—
    - (i) may be mistaken for or confused with any traffic control device on account of its use of reflectors or red, green or amber shapes;
    - (ii) may obstruct, obscure or otherwise reduce the clarity or effectiveness of, any traffic control device;
    - (iii) would invite traffic to turn and would be sited so close to the turning point that there would be no reasonable time for a person to signal and turn safely;
    - (iv) would invite traffic to move contrary to any traffic control device, or to turn where there is fast moving traffic;
    - (v) may obscure the vision of persons driving vehicles;
    - (vi) would not be discernible without close study and there would be no place where persons may stop their vehicles for that purpose without obstructing other traffic;
    - (vii) in the case of an illuminated sign—
      - (aa) may be mistaken for, or confused with, the stop or tail lights of vehicles;
      - (ab) would include animation which would incorporate more than 4 changes per minute or, in the case of chasing globes, more than one globe in 4 would chase;
      - (ac) would include rotation and the rotation would exceed 4 equal changes per minute for a two-faced sign, 3 equal changes per minute for a three-faced sign, or 2 equal changes per minute for a four-faced sign;
      - (ad) would operate at a time when it might cause a traffic hazard;

(viii) not being for the purpose of identifying premises, would be erected or displayed—

(aa) within 200 m of a freeway (as defined in the Road Traffic Code 1975) or freeway interchange (as delineated by the Commissioner under subregulation (5)) and would be clearly discernible by drivers on that freeway or freeway interchange;

(ab) within 100 m of a roundabout (as defined in the Road Traffic Code 1975) or major interchange (as delineated by the Commissioner under subregulation (5)) and would be clearly discernible by drivers negotiating that interchange or roundabout.

(2) A Council which has not made any by-laws referred to in paragraph (a) of subregulation (1) of this regulation shall be deemed, for the purposes of that paragraph, to have adopted the latest draft model by-laws relating to the prohibition, regulation and control of signs published in the *Gazette* pursuant to section 258 of the Local Government Act 1960.

(3) For the purposes of subregulation (1) (b) of this regulation, a sign which is erected or displayed on a part of a building or structure and which projects beyond the building alignment onto a road shall not be treated as being erected or displayed on a road for the purposes of that paragraph.

(4) For the purposes of subregulation (1) (i)—

(a) a sign which is situate on railway land in a rural area or which is clearly discernible from a rural area, shall be deemed to be situate in that rural area; and

(b) a sign which is situate on railway land in a residential area or which is clearly discernible from a residential area, shall be deemed to be situate in that residential area.

(5) For the purposes of subparagraph (viii) of subregulation (1) (n), the Commissioner may cause plans or maps of any freeway interchange or major interchange to be published in the *Gazette* and to be available for inspection at the offices of the Main Roads Department in Perth; and that subparagraph shall not apply to a freeway interchange or a major interchange unless it is delineated in a map or plan which has been so published and which remains in force.

(6) The Commissioner may—

(a) by notice in the *Gazette* declare that a plan or map published under subregulation (5) is no longer in force;

(b) published in the *Gazette* a plan or map in substitution for one in respect of which such a declaration has been made.

Cancellation of consent.

8. (1) The Commissioner may, subject to this regulation, cancel a consent given under regulation 7, or deemed by regulation 13 (3) to have been given, where he is of the opinion that, on account of significant changes in the amount or type of traffic in the area since the consent was given, the continued presence or display of the sign is a danger to public safety in that it creates, or is likely to create, a traffic hazard.

(2) The Commissioner shall, before he cancels a consent under subregulation (1) of this regulation, notify the holder of the consent in writing of the traffic hazard or likely traffic hazard complained of, and give him an opportunity within a period specified in the notice, being not less than 7 days after the receipt thereof, to—

(a) remove the cause of the complaint and satisfy the Commissioner that he has taken all steps reasonably available to him to ensure that it will not recur; and

(b) make such representations concerning the cause of the complaint and the proposed cancellation as he may wish to make.

(3) The Commissioner may cancel a consent under subregulation (1) only where, after the expiration of the period referred to in subregulation (2), the holder of the consent has failed to remove the cause of the complaint or the Commissioner is not satisfied as mentioned in paragraph (a) of that subregulation.

Removal of illegal signs.

9. The Commissioner or his agent duly authorized in writing may enter any land or building and obscure, obliterate or remove, without notice, any sign on or in the vicinity of any highway or main road which in the opinion of the Commissioner is erected or displayed in contravention of regulation 5.

Recovery of costs.

10. (1) The Commissioner may, without incurring any liability therefore, dispose of anything lawfully removed under these regulations in such manner as he thinks fit.

(2) Where any materials in the possession of the Commissioner as a result of the removal of a sign are disposed of by way of sale, the Commissioner shall apply the proceeds of sale first in defraying his costs and expenses, and secondly in the payment of any penalty imposed under these regulations in respect of the sign; and any balance shall be paid to any person who proves his entitlement thereto.

(3) A person who fails to comply with a notice served on him under regulation 14 (2), or a person who has contravened regulation 5 in respect of any sign which the Commissioner has obscured, obliterated or removed

under regulation 9, is liable for the costs and expenses reasonably incurred by the Commissioner in enforcing these regulations against that person, or the balance of the same as the case may be; and the Commissioner may recover the same in a court of competent jurisdiction as a debt due to him by that person.

False statements.

11. A person who, for the purposes of an application under regulation 6, knowingly makes any statement which is false or misleading in a material particular commits an offence.

Penalty.

12. A person who commits an offence against regulation 5, 11 or 14 (3) is liable to a fine not exceeding \$200 and, in addition, in the case of an offence against regulation 5 or 14 (3), to a penalty not exceeding \$20 per day for each day on which the offence continues after conviction.

Repeal, savings and transitional provisions.

13. (1) The Main Roads (Control of Advertisements) Regulations 1973 are repealed.

(2) Without limiting regulation 14, the consent of the Commissioner under regulation 7 is not required to a sign which was erected or displayed on 2 February 1973, being the day on which the regulations referred to in subregulation (1) of this regulation came into force.

(3) A consent to the erection or display of any sign which was granted under the regulations referred to in subregulation (1) of this regulation shall, subject to the terms thereof, be deemed to be a consent granted under regulation 7 of these regulations.

Removal or alteration of existing sign may be ordered.

14. (1) Where the Commissioner is of the opinion that if an application were made under these regulations for the erection and display of a sign referred to in regulation 13 (2) the application would be refused for any one or more of the reasons set out in regulation 7, he may by notice in writing addressed to a person referred to in subregulation (2) of this regulation—

(a) direct him to obscure, obliterate or remove that sign within the time specified in the notice; or

(b) direct him to alter it in the manner and within the time so specified.

(2) A notice under this regulation shall be served upon the owner of the sign concerned or, where the owner thereof is unknown or cannot be found after reasonable inquiry, upon the owner of the land on which it is situate; and such service shall be effected personally or by registered post or, if both of those methods of service are impracticable, by affixing a copy of the notice to some conspicuous part of the sign.

(3) A person who, without reasonable excuse, fails to comply with a notice addressed to him and served under this regulation commits an offence.

(4) If within the time specified in a notice served under this regulation the sign is not obscured, obliterated or removed, or is not altered in the manner specified, as the notice may require, the Commissioner may, by his agent duly authorized in writing, enter the land and any building thereon and obscure, obliterate or remove the sign.

(5) Where the identity of the owner of a sign, or of the land on which it is situate, is not known to the Commissioner, a notice under this regulation may be addressed to "the owner" thereof.

## BUSH FIRES ACT 1954-1981.

## Shire of Bridgetown-Greenbushes.

## Fire Break Order.

## Notice to Owners and Occupiers of Land.

WITH reference to section 33 of the Bush Fires Act 1954-1981, you are required to carry out fire prevention work on land owned or occupied by you in accordance with the provisions of this order.

This work must be carried out by 30 November 1983 and kept maintained throughout the summer months until 13th March, 1984.

An inspection of firebreaks and hazard removal will be carried out in all areas of the Shire by an authorised Officer.

Persons who fail to comply with the requirements of this order may be issued with an infringement notice (penalty \$40) or prosecuted with an increased penalty, and additionally, Council may carry out the required work at cost to the owner or occupier.

If it is considered for any reason to be impractical to clear firebreaks or remove inflammable materials as required by this notice you may apply to the Council or its duly authorised officer not later than 1 November 1983 for permission to provide firebreaks in alternative positions or to take alternative action to abate fire hazards on the land (Guidelines and conditions for alternative breaks are listed overleaf). If permission is not granted by the Council or its duly authorised officer, you shall comply with the requirements of this notice. If the requirements of this notice are carried out by burning, such burning must be in accordance with the relevant provisions of the Bush Fires Act.

## Managed Farm Land.

1. Rural Land: A fire break not less than two metres in width—

- (a) inside and along those portions of the boundaries of all cleared or part cleared land which enjoy a common boundary with a formed public road, and within fifty metres of that boundary;
- (b) immediately surrounding all buildings and haystacks, with a further firebreak not less than two metres in width as close as practicable to twenty metres of the perimeter of haystacks or haysheds;
- (c) around the perimeter of land on which a crop is planted; and
- (d) on all cleared land within twenty metres of and parallel to any boundary of a railway reserve.

## Unmanaged Rural Land.

2. A fire break not less than four metres in width inside and along the boundary of cleared or part cleared land on each lot or location.

Not less than two metres in width immediately surrounding all buildings and haystacks, with a further fire break not less than two metres in width as close as practicable to twenty metres of the perimeter of haystacks or haysheds.

## Residential, Commercial and Industrial Land.

3. A firebreak not less than one metre in width—

- (a) inside and along the boundary of each lot; and
- (b) around the perimeter of all buildings.

In addition such lots shall be cleared of all inflammable material and rubbish likely to create a fire hazard and shall be kept clear of such material and rubbish until 13 March 1984.

## Pine Plantations.

4. A fire break not less than ten metres in width—

- (a) inside and around the perimeter of land in separate ownership on which pines are planted, but this fire break is not required around unplanted areas; and
- (b) inside and along the boundary of those portions of pine plantations adjoining a formed public road.

- (c) additionally and in such position that no area of pine plantation shall exceed 200 hectares without being enclosed by a ten metre break.

A fire break not less than six metres in width in such positions that no part or compartment of a pine plantation shall exceed 28 hectares in area.

All fire breaks referred to in this order shall be constructed and maintained in a condition trafficable by tractors and four wheel drive vehicles, and overhanging trees abutting all breaks shall be pruned to minimise accumulation of litter and allow vehicle access.

In addition to the breaks specified pine plantations traversed by S.E.C. power transmission lines have additional obligations under the Electricity Act.

#### Eucalypt Plantations.

5. A fire break not less than five metres in width—

- (a) inside and around the perimeter of land in separate ownership on which trees are planted, but this fire break is not required around unplanted areas; and
- (b) inside and along the boundary of those portions of plantations adjoining a formed public road.
- (c) a fire break not less than five metres in width in such positions that no part or compartment of a plantation shall exceed 28 hectares in area.

All fire breaks referred to in this order shall be constructed and maintained in a condition trafficable by tractors and four wheel drive vehicles, and overhanging trees abutting all breaks shall be pruned to minimise accumulation of litter and allow vehicle access.

#### Definitions.

For the purpose of this order the following definitions apply:—

“Managed Farm Land” means any lot, location or holding consisting of adjoining lots or locations wholly or mainly maintained or used for grazing, dairying, pig-farming, poultry-farming, viticulture, horticulture, fruit-growing or the growing of crops of any kind, or other similar businesses, where the activity substantially reduces the accumulation of inflammable matter.

“Unmanaged Farm Land” means land over 2 000 square metres on which inflammable matter has been permitted to accumulate, other than managed farm land, residential, commercial and industrial land, and pine or eucalypt plantations.

“Residential, Commercial and Industrial Land” means all land used for those purposes, and includes any ungrazed lot under 2 000 square metres.

“Pine Plantation” means land on which pine trees are planted covering an area greater than 400 square metres per lot or location, and intended for commercial purposes.

“Firebreak” means ground from which all inflammable material has been removed and on which no inflammable material is permitted to accumulate during the period earlier referred to.

“Haystack” means any collection of hay including fodder rolls placed or stacked together.

“Eucalypt Plantation” means land not being native forests, on which eucalypts have been planted covering an area greater than 400 square metres per lot or location, and intended for commercial purposes.

#### Guidelines for Alternative Breaks.

- (a) An alternative break shall be cleared as near as practicable to the position required by this notice, and such position shall be approved by either the Bush Fire Control Officer or Captain of the Bush Fire Brigade in the area concerned and forwarded in writing by 1 November 1983, by the owner or occupier to the Shire Council for confirmation, enclosing a map of the alternative positions endorsed by the said Fire Control Officer or Captain.

(b) In relation to strategic or district breaks any alternative submitted must be by mutual agreement between the land holders and the Brigade, and in addition to the requirements of the preceding paragraph shall be accompanied by a letter from the Bush Fire Brigade showing that the alternative has been approved at a properly constituted meeting of the Brigade.

(c) Any alternative submitted has no effect until approved by the Council after which notification in writing will be given.

(d) All alternative breaks approved may be reviewed by the Council at any time after the expiry of 1 year.

(e) Cultivation of roadsides will be allowed on road reserves only with the written permission of the Council, and for the purpose of protection of fencing only, and not as an alternative to a firebreak.

(f) Pine Plantations: Alternative firebreaks may be provided by special permission of the Council after application by 1 November 1983, supported by a plan showing full detail, and where two or more owners are concerned an agreement in writing that they will be jointly and severally liable for compliance. Upon application and with special approval of the Council a totally cleared road survey on which a road has not been formed may be utilised as a firebreak.

#### Special Notice to Land Owners and Occupiers.

The council forwards a copy of this firebreak order with rate assessments each year. The notice is also published in the *Warren Blackwood Times* and additional copies are obtainable at the Shire Office counter.

The aim of the Council is to eliminate destructive bush fires and to this aim, some areas of the Shire are subject to hazard removal and roadside burning which is carried out by the Shire's bush fire brigades and council workforce.

The requirements of this order are considered to be the minimum standard of fire prevention work required to protect not only individual properties but the district generally. In addition to the requirements of this order, council may issue separate special orders on owners or occupiers if hazard removal is considered necessary in some specific area.

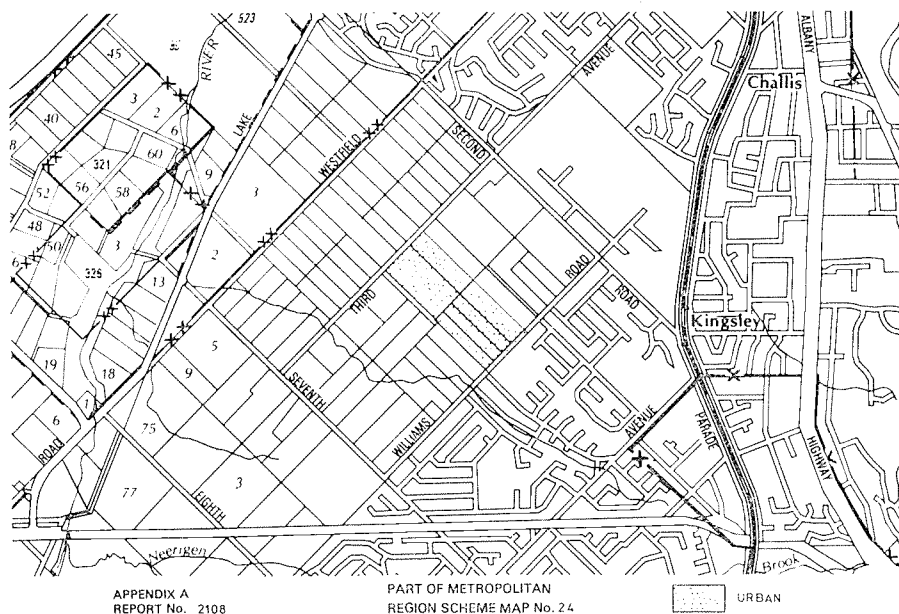
