## DISTRICT PLANNING SCHEME NO.1

## Amendment No. 58

Ref: 853/6/12/18 Pt 58

It is hereby notified for public information, in accordance with section 87 of the Planning and Development Act 2005 that the Minister for Planning and Infrastructure approved the Shire of Harvey local planning scheme amendment on 19 April 2006 for the purpose of—

- Rezoning part Lot 333 Old Coast Road, Australind from the 'Residential' zone to the 'Residential Development' zone as depicted on the Scheme Amendment Map.
- Add to Schedule 19—'Additional Requirements—Residential Development Zone' of the Scheme by the following—

**“AREA 4: PART OF LOT 333 OLD COAST ROAD, AUSTRALIND***SUBDIVISION*

- Subdivision and development shall generally be in accordance with Plan No. 03265P-03 dated April 2004
- No further subdivision of the 'Large' residential lots as specified on the Structure Plan, is permitted.

*DEVELOPMENT—GENERAL*

- (c) Kit homes shall not be permitted unless deemed by Council to be visually compatible with adjacent residential development.
- (d) Outbuildings and other structures shall be located at the rear of dwelling houses and be designed and constructed to be visually compatible to the dwelling they are ancillary to.
- (e) The maximum height of any building on any lot shall not exceed 3 storeys.

*BUILDING SETBACKS*

- (f) Residential lots of less than 1,200m<sup>2</sup> in area shall comply with the R15 provisions of the Residential Design Codes.
- (g) Residential lots of 1200m<sup>2</sup> area or more shall comply with the R10 provisions of the Residential Design Codes except that the rear setback shall be a minimum of 10 metres.

*SITE WORKS*

- (h) Excavation and site works shall be minimised wherever possible.
- (i) Excavation and site works shall be contained within the setbacks with the exception of works to accommodate an access driveway.

*LANDSCAPING*

- (j) Additional planting of native trees and vegetation is encouraged, especially on lots adjoining the Old Coast Road reserve. This may be included as a condition of planning approval issued for the subject lots.

*ACCESS*

- (k) No direct vehicular access is permitted to Old Coast Road.

*BUILDING STYLE & FENCING*

- (l) Building materials that compliment the natural vegetation are encouraged.
- (m) Pole housing is encouraged on lots with slopes of more than 5 degrees.
- (n) Fencing directly adjacent to the foreshore reserve boundary shall be constructed of brick/masonry pier and metal grill infill or brick/masonry pier and open picket infill or similar to the satisfaction of Council. No cement fibre or opaque fencing is permitted.

*OTHER CONSIDERATIONS*

- (o) General materials and goods are not to be stored in front setback areas or where they are noticeably visible to the access street.

Acting pursuant to the powers conferred by Regulation 48A of the Navigable Waters Regulations the department by this notice revokes the 8-knot speed restrictions currently in force—

- under the Narrows Bridge, the Canning Bridge and the southern arch of the Causeway Bridges and
- within 45 metres of all the Barrack Street Jetties.

Under Section 67 of the Western Australian Marine Act 1982, the department also revokes the 8-knot speed limit in the area—

**APPLICATION DETAILS**

Permit applications shall specify a work program (e.g. minimum number of wells to be drilled, kilometres of seismic, geophysical, geochemical surveys etc.) to be carried out and estimated expenditures for **each of six years**. Wells referred to in the work program should not include development wells.

Applicants should also make themselves aware of the existence of any areas, which have the potential to restrict exploration activities eg, National Parks, Nature Reserves, Marine Parks, World Heritage Areas and Conservation Reserves.

Insofar as Reserved Land is concerned, entry for exploration purposes is subject to approval by the Minister. In this regard, it should be noted that Government policy provides that no petroleum exploration or extraction may take place in national parks and nature reserves in respect of new petroleum titles granted after February 2001.

Any applications over the above onshore areas will be subject to the provisions of the Commonwealth Native Title Act 1993 (NTA) and applicants should be prepared to negotiate with Native Title parties pursuant to the right to negotiate provisions of the NTA.
