HERITAGE OF WESTERN AUSTRALIA ACT 1990**ENTRY OF PLACES IN THE REGISTER OF HERITAGE PLACES**

Notice is hereby given in accordance with section 51(2) of the *Heritage of Western Australia Act 1990* that, pursuant to directions from the Minister for Heritage, the place described in Schedule 1 has been entered in the Register of Heritage Places on a permanent basis with effect from today.

Schedule 1**Description of Place**

Subiaco Fallen Soldiers' Memorial at Rankin Gardens, cnr Rokeby & Hamersley Roads, Subiaco; Ptn of Lot 897 on DP 214130 being part of Res 5694 & part of the land contained in CLT V 3136 F 327 & Ptn of the Hamersely Road road Res as shown on HCWA Survey Drawing No. 2452 prepared by Steffanoni Ewing & Cruickshank.

Pursuant to directions from the Minister for Heritage, notice is hereby given in accordance with section 49(1) of the *Heritage of Western Australia Act 1990* that it is proposed that the places described in Schedule 2 be entered in the Register of Heritage Places on a permanent basis. The Heritage Council invites submissions on the proposal, which must be in writing & should be forwarded to the address below not later than 22 September 2006. The places will be entered in the Register on an interim basis with effect from today in accordance with section 50(1) of the *Heritage of Western Australia Act 1990*.

National Bank, Narrogin at 27 Fortune Street, Narrogin; Lot 48 on DP 222890 being the whole of the land contained in C/T V 2141 F 912.

National Australia Bank, Northam at 141 Fitzgerald Street, Northam; Lot 7 on D 11282 and being the whole of the land contained in C/T V 1065 F 737.

NOTICE OF ADVICE REGARDING REGISTRATION OF CROWN PROPERTY
