



**HERITAGE OF WESTERN AUSTRALIA ACT 1990**

**ENTRY OF PLACES IN THE REGISTER OF HERITAGE PLACES**

Notice is hereby given in accordance with section 51(2) of the *Heritage of Western Australia Act 1990* that, pursuant to directions from the Minister for Heritage, the places described in Schedule 1 have been entered in the Register of Heritage Places on a permanent basis with effect from today.

**Schedule 1**

**Description of Place**

**Doctor's House (fmr), Norseman** at 66 Talbot Street cnr Simon Street, Norseman; Lot 834 on DP 160723 being the whole of Res 35764 and being the whole of the land contained in CLT V 3030 F 826.

**Government Quarries (fmr)** at Lot 2823 Hudman Road, Boya; Ptn of Swan Locs 2823 and 6255 and Ptn of Greenmount Sub Lot 219 being part of Res 8006, Ptn of Hudman Road road Res; Ptn of Lots 5687 and 5688 on DP 164025 being part of the land contained in C/T V 1229 F 10 and V 1222 F 148 respectively, together as is defined on HCWA Survey Drawing No 16788 prepared by Whelans and dated 10 February 2005.

**Gwalia Museum Group** at Tower Street, Gwalia; Lots 1127 and 1128 on DP 188906 being the whole of Crown Res 46751 and being the whole of the land contained in CLT V 3126 F 787 and V: 3060 F: 319. **State Battery (fmr), Sandstone** at 6km west of Menzies Sandstone Road, Sandstone; Lot 42 on DP 189100 being Res 41075 and being the whole of the land contained in CLT V 3055 F 281.

**NOTICE OF ADVICE REGARDING REGISTRATION OF CROWN PROPERTY**

In accordance with section 47(5) of the *Heritage of Western Australia Act 1990*, the Heritage Council hereby gives notice that it has advised the Minister for Heritage that it has resolved that—

1. the places listed in Schedule 2 are of cultural heritage significance, and are of value for the present community and future generations;
2. the protection afforded by the *Heritage of Western Australia Act 1990* is appropriate; and
3. the places should be entered in the Register of Heritage Places on an interim basis.

The place will be entered in the Register of Heritage Places on an interim basis with effect from today in accordance with section 50(1)(b) of the *Heritage of Western Australia Act 1990*. The places listed in Schedule 2 are vested in the Crown, or in a person on behalf of the Crown, in right of the State.

The Heritage Council hereby invites submissions as to whether the places listed in Schedule 2 should be entered in the Register of Heritage Places on a permanent basis. The submissions must be in writing and should be forwarded to the address set out below not later than 19 October 2006.

**Canning Bridge** at Canning Highway, Applecross and Como; Main Roads of Western Australia Bridge Numbers 912 and 913, Ptn of the Canning River river bed to High Water Mark being unallocated Crown land, Ptn of the Kwinana Freeway road Res, Ptn of the Canning Highway road Res, Ptn of Lot 12508 on DP 219118 being part of Res 33804 and part of the land contained in CLT V 3119 F 153 and Ptns of unnumbered unallocated Crown land all as defined on HCWA Survey Drawing No. 16178 prepared by Steffanoni Ewing & Cruickshank Pty Ltd.
