RETAIL TRADING HOURS ACT 1987**RETAIL TRADING HOURS (CHRISTMAS TRADING) EXEMPTION ORDER 2006**

Made by the Minister for Consumer Protection.

PART 1—PRELIMINARY**1. Citation**

This order may be cited as the *Retail Trading Hours (Christmas Trading) Exemption Order 2006*.

2. Interpretation

In this order—

“**motor shop**” means a general retail shop or portion of a general retail shop, as the case requires—

- (a) in, on or from which motor vehicles are sold by way of retail sale; or
- (b) in, on or from which spare parts for motor vehicles are sold by way of retail sale in conjunction with the sale of motor vehicles;

“**Perth area**” has the same meaning as the Retail Trading Hours (Tourism Precincts) Exemption Order 1996.

3. Application

- (1) This order applies to all general retail shops, other than motor shops, in the metropolitan area.
- (2) This order does not affect the operation of the *Retail Trading Hours Exemption Order (No 12) 1994*.
- (3) This order does not affect the operation of the *Retail Trading Hours (Rockingham) Exemption Order 1995*.
- (4) This order does not affect the operation of the *Retail Trading Hours (Wanneroo) Exemption Order 1995*.

PART 2—EXEMPTIONS FROM ACT PROVISIONS**4. Application of current exemption order**

The *Retail Trading Hours (Tourism Precincts) Exemption Order 1996* does not apply to a general retail shop on a day to which this Part applies.

5. Sunday 10 December 2006

Each general retail shop to which this order applies is exempted from section 12(1)(d) of the Act on 10 December 2006 provided the shop is closed on that day until 10.00 a.m. and from and after 5.00 p.m.

6. Sunday 17 December 2006

Each general retail shop to which this order applies is exempted from section 12(1)(d) of the Act on 17 December 2006 provided the shop is closed on that day until 10.00 a.m. and from and after 5.00 p.m.

7. Wednesday 20 December 2006

Each general retail shop to which this order applies is exempted from section 12(1)(a) of the Act on 20 December 2006 provided the shop is closed on that day until 8.00 a.m. and from and after 9.00 p.m.

8. Friday 22 December 2006

Each general retail shop to which this order applies is exempted from section 12(1)(a) of the Act on 22 December 2006 provided the shop is closed on that day until 8.00 a.m. and from and after 9.00 p.m.

9. Sunday 24 December 2006

Each general retail shop to which this order applies is exempted from section 12(1)(d) of the Act on 24 December 2006 provided the shop is closed on that day until 10.00 a.m. and from and after 5.00 p.m.

10. Wednesday 27 December 2006

Each general retail shop to which this order applies is exempted from section 12(1)(a) of the Act on 27 December 2006 provided the shop is closed on that day until 8.00 a.m. and from and after 9.00 p.m.

PART 3—1996 EXEMPTION DISAPPLIED**11. Part disapplication of Retail Trading Hours (Tourism Precincts) Exemption Order 1996**

Clause 5 of the *Retail Trading Hours (Tourism Precincts) Exemption Order 1996* does not apply to a general retail shop in the Perth area on Thursday 21 December 2006.

RETAIL TRADING HOURS ACT 1987**RETAIL TRADING HOURS (REGIONAL CHRISTMAS TRADING) EXEMPTION ORDER 2006**

Made by the Minister for Consumer Protection.

1. Citation

This order may be cited as the *Retail Trading Hours (Regional Christmas Trading) Exemption Order 2006*.

2. Interpretation

In this order—

“**motor shop**” means a general retail shop or portion of a general retail shop, as the case requires—

- (a) in, on or from which motor vehicles are sold by way of retail sale; or
- (b) in, on or from which spare parts for motor vehicles are sold by way of retail sale in conjunction with the sale of motor vehicles.

3. Application

(1) This order applies to all general retail shops, other than motor shops, within the municipal boundaries of the Local Government Authorities specified in the Schedule.

(2) This order does not affect the operation of the *Retail Trading Hours Exemption Order (No. 12) 1994*.

4. Part disapplication

This order does not apply to retail shops situated within the Farm Fresh Food Market site at the corner of Chester Pass Road and Catalina Street, Albany, which are subject to the terms prescribed in Permit 1156.

This order does not affect the operations of the *Retail Trading Hours (Burt Street Precinct, Boulder) Exemption Order 2001*.

5. Exemptions from Act provisions**Sunday 10 December 2006**

Each general retail shop to which this order applies is exempted from section 12(1)(d) of the Act on 10 December 2006 provided that the shop is closed on that day until 10.00 a.m. and from and after 5.00 p.m.

Sunday 17 December 2006

Each general retail shop to which this order applies is exempted from section 12(1)(d) of the Act on 17 December 2006 provided that the shop is closed on that day until 10.00 a.m. and from and after 5.00 p.m.

Wednesday 20 December 2006

Each general retail shop to which this order applies is exempted from section 12(1)(a) of the Act on 20 December 2006 provided that the shop is closed on that day until 8.00 a.m. and from and after 9.00 p.m.

Friday 22 December 2006

Each general retail shop to which this order applies is exempted from section 12(1)(a) of the Act on 22 December 2006 provided that the shop is closed on that day until 8.00 a.m. and from and after 9.00 p.m.

Sunday 24 December 2006

Each general retail shop to which this order applies is exempted from section 12(1)(d) of the Act on 24 December 2006 provided that the shop is closed on that day until 10.00 a.m. and from and after 5.00 p.m.

Wednesday 27 December 2006

Each general retail shop to which this order applies is exempted from section 12(1)(a) of the Act on 27 December 2006 provided that the shop is closed on that day until 8.00 a.m. and from and after 9.00 p.m.
