# SCHOOL EDUCATION ACT 1999 DECLARATION OF LOCAL-INTAKE AREAS FOR SCHOOLS WITH PRIMARY STUDENTS

(Pursuant to Sections 60, 78, 79 and 80)

The Hon. Minister for Education has declared that the local-intake areas for the schools listed hereunder shall be as stated in this notice. Children of compulsory school age who reside within the local-intake areas stated shall be entitled to attend the schools to which such local-intake areas apply if there is an appropriate educational program for them at that school. Children who reside outside these local-intake areas may apply to attend the schools to which such local-intake areas apply.

#### ALBANY PRIMARY SCHOOL (Dec06)

The following defines the local-intake area of this school—

From the junction of Hanrahan Road and Serpentine Road, south along Serpentine Road to the south west extension of Wellington Street, north east along this extension and continuing along Wellington Street to Centennial Park, north east through Centennial Park to the junction of Sanford Road and North Road, south east along North Road to the northerly extension of Bluff Street, south along Bluff Street to Beauchamp Street, east along Beauchamp Street to Hanson Street, continuing east along Hanson Street and its easterly extension to the coastline (Middleton Bay), generally south and west along the coastline to Melville Point, north to Princess Royal Drive, north west along Princess Royal Drive to Hanrahan Road, and north along Hanrahan Road to Serpentine Road. The boundary parts of North Road (south side), Lockyer Avenue (both sides), Cockburn Road (both sides), Bluff Street (both sides), Beauchamp Street (both sides), Hanson Street (both sides), Princess Royal Drive (north side) and Hanrahan Road (east side) are included within the local-intake area of this school. The boundary parts of Serpentine Road (both sides) and Wellington Street (both sides) are excluded from this local-intake area.

## ASHBURTON DRIVE PRIMARY SCHOOL (Dec06)

The following defines the local-intake area of this school—

From the junction of Verna Street and Ashburton Drive, northwest along Ashburton Drive to Stennett Street, northeast along Stennett Street to Kellerman Way, northeast and east along Kellerman Way to the southerly extension of Rowland Court, north from this point between Rowland Court and Wilkinson Court to Goodall Street, northeast along Goodall Street to Corfield Street, northwest along Corfield Street to Astinal Drive west along Astinal Drive to a point immediately west of Warren Street, south from this point to the junction of Dionne Place and Prescott Drive, northwest along Prescott Drive to Hood Place, southwest along Hood Place and its extension to Moonstone Place, southwest along Moonstone Place to Compton Road, west along Compton Road to Anaconda Drive, south and southwest along Anaconda Drive to Greenwood Court, southeast along Greenwood Court and its extension to Southern River Road, southwest along Southern River Road to the Southern River, in a general southerly direction along the Southern River to the extension of Verna Street and northeast along the extension of Verna Street and Verna Street to Ashburton Drive.

The boundary parts of Goodall Street, Prescott Drive, Compton Road and Southern River Road, and the boundary streets of Hood Place and Moonstone Place (both sides in all cases) are included within the local-intake area for Ashburton Drive Primary School, while the boundary parts of Ashburton Drive, Stennett Street, Kellerman Way, Corfield Street, Astinal Drive, Anaconda Drive and Verna Street (both sides in all cases) and the boundary street of Greenwood Court are excluded from the area fro Ashburton Drive Primary School.

The following defines an optional area between Ashburton Drive and Seaforth Primary Schools-

The area bounded by Ashburton Drive, Kellerman Way and Stennett Street. The boundary parts of Ashburton Drive and Stennett Street and the boundary street of Kellerman Way are included within this optional area.

The following defines an optional area between Ashburton Drive, Gosnells, Seaforth and Wirrabirra Primary Schools—

The area bounded by Corfield Street, Goodall Street, Eudoria Street and Stalker Road. The boundary parts of the four boundary streets are included within this optional area.

The following defines an optional area between Ashburton Drive and Wirrabirra Primary Schools—

The area bounded by Anaconda Drive, Greenwood Court, Southern River Road, the Southern River and Shearwater Way. The boundary part of Anaconda Drive and the boundary streets of Greenwood Court and Shearwater Way (both sides in each case) are included within this optional area, while the boundary part of Southern River Road (both sides) is excluded from this optional area.

The following defines an optional area between Ashburton Drive Primary School and Seaforth Primary School—

From the bridge on Southern River Road crossing the Southern River, generally south along the Southern River to the Tonkin Highway, south west along the Tonkin Highway to Ranford Road, north west along Ranford Road to Southern River Road and north east along Southern River Road to the Southern River. The boundary parts of the Tonkin Highway (north west side) are

included within this optional area. The boundary parts of Ranford Road (both sides) and Southern River Road (both sides) are excluded from this optional area.

#### BALDIVIS PRIMARY SCHOOL (Dec06)

The following defines the local-intake area of this school—

From the junction of Mandurah Road and Sixty Eight Road, east along Sixty Eighty Road to Baldivis Road, north along Baldivis Road to Safety Bay Road, west along Safety Bay Road to Eighty Road, north along Eighty Road to the road to Tamworth Hill, west along the road to Tamworth Hill, and continuing along this road to Mandurah Road, north along Mandurah Road to Millar Road, east and north east along Millar Road West to Wellard Road, generally east along the locality boundary of Baldivis to the bridge over the drain near the junction of Mundijong Road and Duckpond Road, south along the drain to a point due north of the junction of Karnup Road and Yangetti Road, south along Yangetti Road to Henderson Road, west along Henderson Road and its westward extension to the Serpentine River, south along the Serpentine River to the southern boundary of the locality of Karnup, west along the southern boundary of the locality of Karnup to Mandurah Road and north along Mandurah Road to Sixty Eight Road.

The boundary parts of Baldivis Road (east side), Safety Bay Road (north side), the roads to and from Tamworth Hill (north side in each case), Mandurah Road (northern section, east side), Millar Road West (both sides), Yangetti Road (both sides), Henderson Road (both sides) and Mandurah Road (southern section, east side) are included within the local-intake area for Baldivis Primary School. The boundary parts of Sixty Eight Road (both sides) and Eighty Road (both sides) are excluded from this local-intake area.

The following defines an optional area between Baldivis Primary School and Settlers Primary School—

From the intersection of Safety Bay Road and Mandurah Road, north along Mandurah Road to the road leading to Tamworth Hill, north east along the road to Tamworth Hill, east along this road to Eighty Road, south along Eighty Road to Safety Bay Road and west along Safety Bay to Mandurah Road. The boundary parts of Mandurah Road (east side), the roads to and from Tamworth Hill (south side in both cases), Eighty Road (both sides) and Safety Bay Road (north side) are included within this optional area.

The following defines an optional area between Baldivis Primary School, Marri Grove Primary School and Mundijong Primary School—

From the junction of Duckpond Road and Mundijong Road, west along Mundijong Road to the locality boundary between Baldivis and Oldbury, north west along this locality boundary and continuing east and north east along the locality boundary between Oldbury and Wellard to the railway line, east along the railway line to a drain, south south east along the drain to the Birraga Main Drain, south and south west along the main drain to Mundijong Road and west along Mundijong Road to Duckpond Road. The boundary parts of Mundijong Road (north side) are included in this optional area.

## BERTRAM PRIMARY SCHOOL (Dec06)

The following defines the local-intake area of this school—

From the intersection of the Kwinana Freeway and Mortimer Road, west along Mortimer Road to Bertram Road, continuing west along Bertram Road to Challenger Avenue, north west along Challenger Avenue to the proposed railway line, north east along the proposed railway line to a point due east of the junction of Sicklemore Road and Adamson Road, east from this point on the railway line to the Kwinana Freeway and south along the Kwinana Freeway to Mortimer Road.

The boundary parts of Mortimer Road (north side), Bertram Road (north side), Challenger Avenue (north side) and the Kwinana Freeway (west side) are included within this local-intake area.

The following defines an optional area for Bertram Primary School and Medina Primary School—

From the junction of Wellard Road and Bertram Road, south east along Wellard Road to Baldivis Road, east along Baldivis Road to the Kwinana Freeway, north along the Kwinana Freeway to Millar Road, east along Millar Road and its south east extension to the north west extension of Duckpond Road, south east along Duckpond Road to Banksia Road, north east and north west along Banksia Road to Lydon Road, north east along Lydon Road to Casuarina Road, north along Casuarina Road to Mortimer Road, west along Mortimer Road to Bertram Road, north west and west along Bertram Road to Challenger Road, north west along Challenger Road to the proposed railway line, south west along the proposed railway line to Wellard Road and east along Wellard Road to the junction with Bertram Road. The boundary parts of Wellard Road (north and east sides), Baldivis Road (north side), the Kwinana Freeway (west side), Millar Road (both sides), Duckpond Road (both sides), Banksia Road (both sides), Lydon Road (both sides), Casuarina Road (both sides), Mortimer Road (south side), Bertram Road (south side) and Challenger Road (south west side) are included in this optional area.

The following defines an optional area for Bertram Primary School, Medina Primary School and North Parmelia Primary School—

From the intersection of the Kwinana Freeway and Thomas Road, east along Thomas Road to the local government boundary between the Town of Kwinana and the Shire of Serpentine-Jarrahdale, south along this local government boundary to Mortimer Road, west along Mortimer Road to the Kwinana Freeway and north along the Kwinana Freeway to Thomas Road. The boundary parts of Thomas Road (south side), Mortimer Road (north side) and the Kwinana Freeway (east side) are included within this optional area.

## **BUTLER PRIMARY SCHOOL (Dec06)**

The following defines the local-intake area of this school—

From the junction of Marmion Avenue and Lukin Drive, east along Lukin Drive and its proposed extension to Connolly Drive, north west along Connolly Drive and its extension to the proposed Exmouth Drive, north along the proposed Exmouth Drive and its northern extension to the locality boundary between Alkimos and Butler, west along the locality boundary between Alkimos and Jindalee, continuing west along the locality boundary between Alkimos and Jindalee, south along the coastline to the locality boundary between Alkimos and Jindalee to the coastline, south along the coastline to the locality boundary between Jindalee and Quinns Rocks, east along the locality boundary between Jindalee and Quinns Rocks to Marmion Avenue, and south along Marmion Avenue to the junction with Lukin Drive. The boundary parts of Lukin Drive (north side), Connolly Drive (west side), Exmouth Drive (west side) and Marmion Avenue (east side) are included within the local-intake area of this school.

#### CARINE PRIMARY SCHOOL (Dec06)

The following defines the local-intake area of this school—

From the junction of Reid Highway and Marmion Avenue, east along Reid Highway to Okely Road, north along Okely Road to Beach Road, west along Beach Road to Marmion Avenue, and southeast along Marmion Avenue to Reid Highway. The boundary parts of Reid Highway (north side), Okely Road (both sides), Beach Road (south side), and Marmion Avenue (east side) are included in the local-intake area for Carine Primary School.

The following defines an optional area between Carine Primary School and Karrinyup Primary School—

From the junction of Reid Highway and North Beach Road, south and east along North Beach Road to Okely Road, north along Okely Road and its extension to Reid Highway, and west along Reid Highway to North Beach Road. The boundary parts of North Beach Road (north side), Okely Road (west side) and Reid Highway (south side) are included within this optional area.

The following defines an optional area between Carine Primary School and Lake Gwelup Primary School—

From the junction of Okely Road and North Beach Road, north along Okely Road to Reid Highway, east along Reid Highway to Duffy Road, south along Duffy Road to North Beach Road and west along North Beach Road to Okely Road. The boundary parts of Okely Road (east side), Reid Highway (south side), Duffy Road (west side) and North Beach Road (north side) are included within this optional area.

## CARRAMAR PRIMARY SCHOOL (Dec06)

The following defines the local-intake area of this school—

From the junction of Wanneroo Road and Flynn Drive, north and east along Flynn Drive to the locality boundary between Banksia Grove and Carramar (as shown in the Perth 2006 StreetSmart street directory), south along this locality boundary to Joondalup Drive, south west along Joondalup Drive to Wanneroo Road and north along Wanneroo Road to Flynn Drive. The boundary parts of Flynn Drive (east and south sides), Joondalup Drive (north side) and Wanneroo Road (east side) are included within the local-intake area of this school.

The localities of Mariginiup and Neerabup are optional areas for Carramar Primary School and Wanneroo Primary School.

## COMET BAY PRIMARY SCHOOL (Dec06)

The following defines the local-intake area of this school—

From Mandurah Road, west along the locality boundary between Secret Harbour and Golden Bay to the southern extension of Kingscliff Drive, north along this extension and along Kingscliff Drive to Bancoura Parkway, east along Bancoura Parkway to Warnbro Sound Avenue, north along Warnbro Sound Avenue to the western extension of Atlin Lane, east along this extension and along Atlin Lane to Summerville Avenue, north east along Wissota Pass to Colebrook Circle, north and east along Colebrook Circle to the junction with Waconia Way, north from the junction of Colebrook Circle and Wacona Way to and across Anstey Road to the currently unnamed proposed north-south road, north along this unnamed north-south road to the junction with Lennox Drive, and due north from this junction to and across Surf Road to the locality boundary between Secret Harbour and Port Kennedy, east along this locality boundary to Mandurah Road and south along Mandurah Road to the locality boundary between Secret Harbour and Golden Bay.

The boundary parts of Bancoura Parkway (both sides), Warnbro Sound Avenue (east side), the unnamed proposed north-south road (both sides) and Mandurah Road (west side) are included within the local-intake area of this school. The boundary parts of Kingscliff Drive (both sides), Atlin Lane (both sides), Wissota Pass (both sides) and Colebrook Circle (both sides) are not included within the local-intake area of this school.

The following defines an optional area for Secret Harbour Primary School and Comet Bay Primary School—

From the intersection of Warnbro Sound Avenue and Anstey Road, south along Warnbro Sound Avenue to the western extension of Atlin Lane, east along this extension and along Atlin Lane to Summerville Avenue, north east along Wissota Pass to Colebrook Circle, north and east along Colebrook Circle to the junction with Wacona Way, north from the junction of Colebrook Circle and Wacona Way to Anstey Road and west along Anstey Road to Warnbro Sound Avenue. The

boundary parts of Warnbro Sound Avenue (east side), Atlin Lane (both sides), Wissota Pass (both sides), Colebrook Circle (both sides) and the unnamed proposed north-south road (both sides) are included within this optional area.

#### EAST BUTLER PRIMARY SCHOOL (Dec06)

The following defines the local-intake area of this school—

From the intersection between the proposed Lukin Drive and the proposed Connolly Drive, north west along Connolly Drive and its extension to the proposed Exmouth Drive, north along the proposed Exmouth Drive and its northern extension to the locality boundary between Alkimos and Butler, east along the locality boundary between Alkimos and Butler to the proposed Mitchell Freeway, south east along the proposed Mitchell Freeway to the proposed Lukin Drive and west along the proposed Lukin Drive to the proposed Connolly Drive. The boundary parts of Connolly Drive (east side), Exmouth Drive (east side), Mitchell Freeway (west side) and Lukin Drive (north side) are included within the local-intake area of this school.

#### EAST KENWICK PRIMARY SCHOOL (Dec06)

The following defines the local-intake area of this school—

From a point on the standard gauge railway line (Woodbridge to Kwinana Section) on the north west extension of Bickley Road, in a general southerly direction along the standard gauge railway line to the Perth-Armadale railway line, southeast along the Perth-Armadale Railway line to Austin Avenue, northeast along Austin Avenue to Davison Street, southeast along Davison Street to Hayley Street, northeast along Hayley Street to Ryelane Street, northwest along Ryelane Street to Marion Road, northeast along Marion Road to Stebbing Road, south east along Stebbing Road to Mandarin Road, north east along Mandarin Road to Wildfire Road, south east along Wildfire Road to Kelvin Road, northeast along Kelvin Road to Eva Street, and southeast along Eva Street to Maddington Road, north east along Maddington Road to Tonkin Highway, north north west along Tonkin Highway to the locality boundary between Kenwick and Maddington, south east along this locality boundary to Bickley Road, north west along Bickley Road to the standard gauge railway line.

The boundary parts of Austin Avenue (both sides), Davison Street (both sides) and Maddington Road (north side) are included within the area for the East Kenswick Primary School. The boundary parts of Hayley Street, Ryelane Street, Marion Street, Stebbing Road, Mandarin Road, Wildfire Street, Kelvin Road and Eva Street (both sides in each case) are excluded from the local-intake area for the East Kenwick Primary School.

The following has been declared as an optional area between the East Kenwick, Beckenham, Maddington and Thornlie Primary Schools—

From the intersection of Austin Avenue with Perth-Armadale railway line, southwest along Austin Avenue and its south westerly extension to the Canning River, generally northwest along the Canning River to the standard gauge Railway line (Woodbridge to Kwinana Section), northeast along the standard gauge Railway line to the Perth-Armadale Railway line, and in a general south easterly direction along the Perth-Armadale Railway line to the Austin Avenue railway crossing. The boundary parts of Austin Avenue (both sides) are included within this optional area.

The following defines an optional area between Wattle Grove Primary School and East Kenwick Primary School—

From the bridge carrying Welshpool Road over the railway line, south east along the locality boundary between Kenwick and Wattle Grove, continuing north east and south east along this locality boundary to Boundary Road, north east along the extension of Boundary Road to Tonkin Highway, south east along Tonkin Highway to the locality boundary between Kenwick and Maddington, south east along this locality boundary to Bickley Road, north west along Bickley Road to the railway line and north along the railway line to Welshpool Road. The boundary parts of Tonkin Highway (west side) are included within this optional area, and the boundary parts of Bickley Road (both sides) are excluded from this optional area.

## FALLS ROAD PRIMARY SCHOOL (Dec06)

The following defines the local-intake boundary of this school—

From the junction of Sampson Road and Nangkita Road, west along Nankita Road and its extension to and along Nangkita Way to Karralika Avenue, north along Karralika Avenue to Orange Valley Road, north-east along Orange Valley Road to Whistlepipe Gully, in a general westerly direction along Whistlepipe Gully to the gate at the north eastern end of Lewis Road, south to Lesmurdie Brook, south east to the south western extremity of Falls Road, south east to and along Maxine Court to Nelson Crescent, east to Victory Place, north east along Victory Place to Grove Road, south east along Grove Road to Trafalgar Road, north east along Trafalgar Road to the southern arm of Waterloo Crescent, south east and north east along Waterloo Crescent and its northeasterly extension to Lesmurdie Brook, southeast along Lesmurdie Brook to a point just south of the southern extremity of Catherine Place, northeast from this point to the junction of Lesmurdie Road and Glyde Road, east along Glyde Road to Heslop Road, north, northwest and north along Heslop Road to Kaolunga Way, east along Kaolunga Way to Fletcher Road, north along Fletcher Road to Lesmurdie Road, east along Lesmurdie Road to Sampson Road, and north along Sampson Road to Nangkita Road.

The boundary parts of Karralika Avenue, Orange Valley Road, Maxine Court, Grove Road, Trafalgar Road, Waterloo Crescent, Glyde Road, Heslop Road and Kaolunga Way (both sides in all cases) are included in the local-intake area for the Falls Road Primary School. The boundary

parts of Nangkita Road, Nangkita Way, Victory Place, Fletcher Road, Lesmurdie Road, and Sampson Road (both sides in all cases) are excluded from the local-intake area for the Falls Road Primary School.

The following defines an optional area between the Falls Road Primary School and the Kalamunda Primary School—

From the junction of Crayden Road and Sampson Road, northwest along Crayden Road to Lyndhurst Road, west along Lyndhurst Road to Orange Valley Road, north along Orange Valley Road to Winsor Road, west along Winsor Road to Robins Road, south along Robins Road to Grace Road, west along Grace Road to Betti Road, west and southwest along Betti Road to its junction with Orange Valley Road, west along Orange Valley Road to its extremity due south from this point to Whistlepipe Gully, in a general easterly direction along Whistlepipe Gully to the eastern section of Orange Valley Road, southwest along Orange Valley Road to Karralika Avenue, south along Karralika Avenue to Nankita Way, east along Nangkita Way and its extension to and along Nangkita Road to Sampson Road, and north along Sampson Road to Crayden Road.

The northern and western boundary parts of Orange Valley Road, the boundary parts of Robins Road, Grace Road and Betti Road, and the boundary streets of Crayden Road, Lyndhurst Road, Nangkita Way and Nangkita Road (both sides in each case) are included within the optional area, as provided above, while the southern boundary part of Orange Valley Road and the boundary parts of Karralika Avenue and Sampson Road, and the boundary street of Winsor Road (both sides in each case) are excluded from the optional area.

The following defines an optional area between the Falls Road Primary School and the Lesmurdie Primary School—

From the south western end of Falls Road, south east to and along Maxine Court to Nelson Crescent, east to Victory Place, north east along Victory Place to Grove Road, south east along Grove Road (north west section) to Trafalgar Road, north east along Trafalgar Road to the southern arm of Waterloo Crescent, south east and north east along Waterloo Crescent and its north easterly extension to Lesmurdie Brook, southeast along Lesmurdie Brook to a point just south of the southern extremity of Catherine Place, northeast from this point to the junction of Lesmurdie Road and Glyde Road, east along Glyde Road to Cagney Way, south along Cagney Way to Neil Tonkin Park and continuing south through the community centre to Grove Road, west along Grove Road and its westerly extension to Lesmurdie Road, west across Lesmurdie Road to Grove Road (western section), continuing west along Grove Road to George Road, south west along George Road to Ford Road, west along Grove Road to Kell Place, south west along Kell Place to the locality boundary between the localities of Lesmurdie and Forrestfield, north along this locality boundary to the south western extremity of Falls Road.

The boundary parts of Victory Place (both sides), Grove Road (north west section) and Cagney Way (both sides) are included in this optional area. The boundary parts of Maxine Court (both sides), Trafalgar Road (both sides), Waterloo Crescent (both sides), Glyde Road (both sides), Grove Road (western and eastern sections, both sides), George Road (both sides), Ford Road (both sides) and Kell Place (both sides) are excluded from this optional area.

## FLINDERS PARK PRIMARY SCHOOL (Dec06)

The following defines the local-intake area of this school—

From Oyster Harbour, west along Yakamia Creek to Lower King Road, north along Lower King Road to Mercer Road, west along Mercer Road to a point on the northern extension of Curtiss Road, north from this point to the junction of Chester Pass Road and Willyung Road, north east along Chester Pass Road to King River, generally north west along King River to Hazzard Road, west along Hazzard Road to the junction with the southern extension of Bailey Road, north along this extension to Bailey Road, north along Bailey Road and its northern extension to the local government boundary between the City of Albany and the Shire of Plantagenet, east and north along this local government boundary to the intersection with Armstrong Road, east along Armstrong Road, to the junction of Takenup Road, south east on Takenup Road and Mindijup Roads, south east along Mindijup Road to Deep Creek Road, west, south west and south Coast Highway to Dempster Road, south Coast Highway, north east and east along South Coast Highway to Dempster Road to Two Peoples Bay Road, east along Two Peoples Bay Road to the foreshore at Two Peoples Bay, generally south and west along the ocean foreshore to the Oyster Harbour foreshore, and north, west and south around the Oyster Harbour foreshore to Yakamia Creek.

The boundary parts of Lower King Road (both sides), Mercer Road (both sides), Chester Pass Road (southern section, both sides), Yungup Road (both sides), Morande Road (both sides), Yellanup Road (both sides), Sixpenny Road (both sides), Millinup Road (both sides), Chester Pass Road (northern section, both sides), Armstrong Road (both sides), Mindijup Road (both sides), Deep Creek Road (both sides), Nanarup Road (both sides) and Two Peoples Bay Road (both sides) Dempster Road and Hazzard Road (both sides) are included within the local-intake area of this school. The boundary parts of Bailey Road (both sides) and South Coast Highway (both sides) are excluded from this local-intake area.

#### GOOSEBERRY HILL PRIMARY SCHOOL (Dec06)

The following defines the local intake area of this school—

From the junction of Kalamunda Road and Watsonia Road, north east, north west and north along Watsonia Road to Ridge Hill Road, north east along Ridge Hill Road to the locality boundary between Helena Valley and Gooseberry Hill, east and north east along this boundary to the Helena River, south east along the Helena River to the intersection of the locality boundary

between Paulls Valley, Piesse Brook and Darlington, south along the locality boundary between Piesse Brook and Paulls Valley (and along Fern Road) to a point due east of the junction of Spring Road and Robusta Road, west from this point to the locality boundary between Kalamunda and Piesse Brook, west, north and west along this locality boundary to the north east extension of Shelley Road, south west from this point to Shelley Road, south east along Shelley Road to Williams Street, north west along Williams Street to the extension of Parke Road, west along Parke Road to Davies Crescent, south west along Davies Crescent to Kalamunda Road, north west along Kalamunda Road to Watsonia Road.

The boundary parts of Ridge Hill Road (south eastern side) and Kalamunda Road (north side) are included within the local-intake area of this school. The boundary parts of Watsonia Road (both sides), Shelley Road (both sides), Williams Street (both sides), Parke Road (both sides) and Davies Crescent (both sides) are excluded from the local-intake area of this school.

#### KALAMUNDA PRIMARY SCHOOL (Dec06)

The following defines the local intake area of this school—

From the intersection of Kalamunda Road and the north-south alignment of Nangana Way, south along Kalamunda Road to Davies Crescent, north east along Davies Crescent to Parke Road, east along Parke Road and across Railway Road to Williams Street, south east along Williams Street to Shelley Road, north east along Shelley Road and continuing north east to the locality boundary between Gooseberry Hill and Kalamunda, east, south, and east along this boundary to the Schipp Road WalkTrail, from this point in an easterly direction through Kalamunda National Park to Fern Road and the locality boundary of Paulls Valley and Piesse Brook, generally north along this locality boundary to the Helena River, generally east along the Helena River to Mundaring Weir Road, south west along Mundaring Weir Road to the Water Catchment Area Boundary (which is also the boundary of the locality of Reservoir), generally south west along this boundary until it intersects with the locality boundary between Bickley and Hacketts Gully, north west along the locality boundary between Bickley and Hacketts Gully to the three-way intersection of the locality boundaries of Bickley, Hacketts Gully and Piesse Brook, west along the locality boundary to Aldersyde Road, north along Aldersyde Road to Mundaring Weir Road, north west along Mundaring Weir Road to the locality boundary between Bickley and Kalamunda, west, south, west along this boundary and continuing west along Stanhope Road to Canning Road, south across Canning Road to the north east extension of Sampson Close, south east along the extension and Sampson Close to Sampson Road, west, south west along Sampson Road to Crayden Road, northwest along Crayden Road to Lyndhurst Road, west along Lyndhurst Road to Orange Valley Road, north along Orange Valley Road to Winsor Road, west along Winsor Road to Robins Road, south along Robins Road to Grace Road, west along Grace Road to Betti Road, west and southwest along Betti Road to its junction with Orange Valley Road, west along Orange Valley Road to its extremity due south from this point to Whistlepipe Gully, west along Whistlepipe Gully to the gate at the north eastern end of Lewis Road, north to Holmes Road, north along Holmes Road to Maud Road, east from this point to Simeon Close, east along Simeon Close to West Terrace, south and southeast along West Terrace to the walk trail, east along the walk trail to a point just east of the eastern end of Brie Brie Crescent, north from this point to Nangana Way and north along the north-south alignment of Nangana Way to Kalamunda Road.

The boundary parts of Kalamunda Road (south side), Davies Road (both sides), Parke Road (both sides), Williams Street (both sides), Shelley Road (both sides), Fern Road (both sides), Mundaring Weir Road (eastern section, both sides), Aldersyde Road (both sides), Mundaring Weir Road (western section, both sides) and Winsor Road are included within the local-intake area of this school. The boundary parts of Stanhope Road (both sides), Sampson Close (both sides), Sampson Road (both sides), Crayden Road (both sides), Lyndhurst Road (both sides), Orange Valley Road (eastern section, both sides), Robins Road (both sides), Grace Road (both sides), Betti Road (both sides), Orange Valley Road (western section, both sides), Holmes Road (both sides), Simeon Close (both sides), West Terrace (both sides) and Nangana Way (both sides) are excluded from the local-intake area of this school.

The following defines an optional area between the Falls Road Primary School and the Kalamunda Primary School: from the junction of Crayden Road and Sampson Road, northwest along Crayden Road to Lyndhurst Road, west along Lyndhurst Road to Orange Valley Road, north along Orange Valley Road to Winsor Road, west along Winsor Road to Robins Road, south along Robins Road to Grace Road, west along Grace Road to Betti Road, west and southwest along Betti Road to its junction with Orange Valley Road, west along Orange Valley Road to its extremity due south from this point to Whistlepipe Gully, in a general easterly direction along Whistlepipe Gully to the eastern section of Orange Valley Road, southwest along Orange Valley Road to Karralika Avenue, south along Karralika Avenue to Nankita Way, east along Nangkita Way and its extension to and along Nangkita Road to Sampson Road, and north along Sampson Road to Crayden Road.

The northern and western boundary parts of Orange Valley Road, the boundary parts of Robins Road, Grace Road and Betti Road, and the boundary streets of Crayden Road, Lyndhurst Road, Nangkita Way and Nangkita Road (both sides in each case) are included within the optional area, while the southern boundary part of Orange Valley Road and the boundary parts of Karralika Avenue and Sampson Road, and the boundary street of Winsor Road (both sides in each case) are excluded from the optional area.

The following defines an optional area between Kalamunda Primary School and Maida Vale Primary School—

From the junction of Kalamunda Road with West Terrace, south along West Terrace to Norwood Road, west along Norwood Road to Holmes Road, south along Holmes Road to Maud Road, east

from this point to Simeon Close, east along Simeon Close to West Terrace, south and southeast along West Terrace to the walk trail, east along the walk trail to a point just east of Brie Brie Crescent, north from this point to Nangana Way, north along the north-south alignment of Nangana Way to Kalamunda Road and northwest along Kalamunda Road to West Terrace. The boundary parts West Terrace (southern section, both sides), Nangana Way (both sides) and Kalamunda Road (south side) and the boundary street of Simeon Close (both sides) are included within the optional area, while the boundary parts of West Terrace (northern section, both sides), Norwood Road (both sides) and Holmes Road (both sides) are excluded from the optional area.

#### KARRINYUP PRIMARY SCHOOL (Dec06)

The following defines the local-intake area for this school—

From the junction of Karrinyup Road and Marmion Avenue, east along Karrinyup Road to Huntriss Road, north along Huntriss Road and its northern extension through Lake Karrinyup to North Beach Road, west and north along North Beach Road to Reid Highway, west along Reid Highway to Marmion Avenue and south along Marmion Avenue to Karrinyup Road. The boundary parts of Karrinyup Road (north side), Huntriss Road (both sides), North Beach Road (south side) and Marmion Avenue (east side) are included within this local-intake area.

The following defines an optional area between Carine Primary School and Karrinyup Primary School—

From the junction of Reid Highway and North Beach Road, south and east along North Beach Road to Okely Road, north along Okely Road and its extension to Reid Highway, and west along Reid Highway to North Beach Road. The boundary parts of North Beach Road (north side), Okely Road (west side) and Reid Highway (south side) are included within this optional area.

#### LEDA PRIMARY SCHOOL (Dec06)

The following defines the local-intake area of this school—

The boundary parts of Canning Road (west side) and Welshpool Road East (south side) are included within this local-intake area. The boundary parts of Alice Road (both sides), Mabel Road (both sides) and Edward Road (both sides) are excluded from this local-intake area.

The following defines an optional area between Walliston Primary School and Pickering Brook Primary School—

From the intersection of Welshpool Road East and Canning Road, south east along Canning Road to the locality boundary between Pickering Brook and Carmel, generally north along the locality boundary between Carmel and Pickering Brook (and including Francais Road) to the locality boundary between Bickley and Carmel, west along the locality boundary between Bickley and Carmel (including Palmeteer Drive and Television Road), and west along the locality boundary between Carmel and Walliston (including Annetts Road) to Canning Road, south east along Canning Road to Welshpool Road East. The boundary parts of Wanneroo Road (west side), Joondalup Drive (south side) and Ocean Reef Road (north side) are included within the local-intake area of this school.

The localities of Mariginiup and Neerabup are optional areas for Carramar Primary School and Wanneroo Primary School.

The localities of Jandabup and Sinagra are optional areas for East Wanneroo Primary School and Wanneroo Primary School.

The following defines an optional area between Tapping Primary School and Wanneroo Primary School—

From the junction of Wanneroo Road and Pinjar Road, north east along Pinjar Road to the eastern extension of Castagno Approach, west along this extension and west along Castagno Approach to Yanez Lane, continuing west along Yanez Lane to Carosa Road, north along Carosa Road to Monet Drive, west along Monet Drive to Wanneroo Road and south west along Wanneroo Road to Pinjar Road. The boundary parts of Pinjar Road (west side), Castagno Approach (both sides), Yanez Lane (both sides), Carosa Road (both sides), Monet Drive (both sides) and Wanneroo Road (east side) are included within this optional area.

## YAKAMIA PRIMARY SCHOOL (Dec06)

The following defines the local-intake area of this school—

From the roundabout linking Albany Highway and Hanrahan Road, south west along Hanrahan Road to Serpentine Road, south along Serpentine Road to the south west extension of Wellington Street, north east along this extension and continuing along Wellington Street to Centennial Park, north east through Centennial Park to the junction of Sanford Road and North Road, north

from this junction to the junction of Bond Road and Lockheed Road, east along Bond Road to Curtiss Road, north along Curtiss Road and the northern extension of Curtiss Road to the junction of Chester Pass Road and Willyung Road, north east along Chester Pass Road to King River, generally north west along King River to Hazzard Road, west along Hazzard Road to the junction with the southern extension of Bailey Road, north along this extension to Bailey Road, north along Bailey Road and its northern extension to the local government boundary between the City of Albany and the Shire of Plantagenet, generally west along this local government boundary to Albany Highway and south east along Albany Highway to the roundabout with Hanrahan Road.

The boundary parts of Hanrahan Road (east side), Serpentine Road (both sides), Wellington Street (both sides), Bond Road (both sides), Curtiss Road (both sides), Bailey Road (both sides) and Albany Highway (east side) are included within the local-intake area of this school. The boundary parts of Chester Pass Road (both sides) and Hazzard Road (both sides) are excluded from the local-intake area of this school.

Children of compulsory school age who reside within the local-intake areas of the following secondary schools shall be entitled to attend the schools to which such local-intake areas apply if there is an appropriate educational program for them at that school. The local-intake area of a secondary school may be defined in this notice by listing the names of the contributory primary schools, the local-intake areas and the traditional catchment areas of which, when amalgamated, constitute the local-intake area of that secondary school. Children who reside outside these local-intake areas may apply to attend the schools to which such local-intake areas apply.

#### ATWELL HIGH SCHOOL (Dec06)

The following description will define the local-intake area of Atwell High School from 2008.

The local-intake area for this school contains the following primary schools: Atwell, Harmony and Jandakot.

The following defines the local-intake area of Atwell High School—

From the iunction of Armadale Road and Liddelow Road, south along Liddelow Road to Rowley Road, east along Rowley Road to De Haer Road, south along De Haer Road to the more southern of the two junctions with Leslie Road, south from this point on De Haer Road to the locality boundary between Anketell and Oakford on Anketell Road, west along Anketell Road to the Kwinana Freeway, north along the Kwinana Freeway to Rowley Road, west along Rowley Road, and continuing west along the local government boundary between the City of Cockburn and the Town of Kwinana to Mandogalup Road, north along Mandogalup Road and its northern extension to Russell Road, east along Russell Road to a point due south of the centre of Kogolup Lake, north from this point on Russell Road through Thompsons Lake and Kogolup Lake to Beeliar Drive, east along Beeliar Drive to the Kwinana Freeway, and continuing east along Armadale to Solomon Road, north east along Solomon Road to Jandakot Road, and continuing north east along Solomon Road and its extension to the north west/south east runway of Jandakot airport, south east along the south east extension of the runway to Fraser Road, south west along Fraser Road to Jandakot Road, west along Jandakot Road to Fraser Road (southern section) and continuing south west along Fraser Road (southern section) to Armadale Road, east along Armadale Road to Liddelow Road.

The boundary parts of Liddelow Road (west side), Rowley Road (eastern section, south side), De Haer Road (north side), Anketell Road (north side), Kwinana Freeway (east side), Rowley Road (western section, north side), Mandogalup Road (east side), Russell Road (south side), Beeliar Drive (south side), Armadale Road (western section, south side) Solomon Road (east side), Fraser Road (both northern and southern sections, west side) Jandakot Road (north side) and Armadale Road (eastern section, south side).

The following defines an optional area for Atwell High School and Armadale Senior High School—

From the junction of Armadale Road and Warton Road, north east along Warton Road to Jandakot Road, north west along Jandakot Road to Fraser Road, south west along Fraser Road to Armadale Road and south east along Armadale Road to Warton Road. The boundary parts of Armadale Road (north side), Jandakot Road (south side) and Fraser road (east side) are included in this optional area, while the boundary parts Warton Road (both sides) are excluded from this optional area.

The following defines an optional area for Atwell High School and Kwinana High School—

From the intersection of the Kwinana Freeway and Rowley Road, south along the Kwinana Freeway to Anketell Road, west along Anketell Road to Clementi Road, north from this junction to Madogolup Road, north west along Madogolup Road to the local government boundary between the City of Cockburn and the Town of Kwinana, east along this local government boundary to Rowley Road, and continuing east along Rowley Road to the Kwinana Freeway. The boundary parts of the Kwinana Freeway (west side), Anketell Road (north side), Mandogolup Road (east side) and Rowley Road (south side) are included in this optional area.

#### ELLENBROOK SECONDARY COLLEGE (Dec06)

The local-intake area for this school contains all of the local-intake areas of Arbor Grove Primary School and Ellenbrook Primary School, and the traditional catchment area of Upper Swan Primary School.

The following defines the local-intake area of this school—

From the junction of West Swan Road and Woollcott Avenue, north along West Swan Road to Douglas Road, east along Douglas Road and its eastern extension to the Maali Bridge over the Swan River, north along the Swan River to the Ellen Brook, north along the Ellen Brook to the Ellen Brook Bridge and the locality boundary between Belhus and Ellenbrook, north along this locality boundary to the dam at Coruna Park, north west from the dam to the western end of Millhouse Road, north from the western end of Millhouse Road to a point on the locality boundary

between Ellenbrook and The Vines nearest the southern end of Taittinger Grove), west, north, west and north along this locality boundary to Maralla Road, west along Maralla Road to the proposed Perth-Darwin Highway, south west and south along the proposed Perth-Darwin Highway to the south western extension of Youle-Dean Road, north east along this extension and north east along Youle-Dean Road to Woollcott Avenue, and south east along Woollcott Avenue to West Swan Road.

The boundary parts of West Swan Road (west side), Douglas Road (both sides), Youle-Dean Road (north side) and Woollcott Avenue (north side) are included within this optional area. The boundary parts of Maralla Road (both sides) are excluded from this local-intake area.

The following defines an optional area between Ellenbrook Secondary College and Governor Stirling Senior High School—

From a point on the Swan River on the western extension of Padbury Avenue, north along the Swan River to the Ellen Brook, north along the Ellen Brook to the Ellen Brook Bridge and the locality boundary between Belhus and Ellenbrook, north along this locality boundary to the dam at Coruna Park, north west from the dam to the western end of Millhouse Road, north from the western end of Millhouse Road to a point on the locality boundary between Ellenbrook and The Vines nearest the southern end of Taittinger Grove), west, north, west and north along this locality boundary to Maralla Road, east along Maralla Road and its eastern extension to the intersection of the locality boundary between Upper Swan and Bullsbrook and Great Northern Highway, east along this locality boundary to the locality boundary between Brigadoon and Gidgegannup (on the Swan River), east and south along this locality boundary to the locality boundary to Padbury Avenue, west along Padbury Avenue and west along its western extension to the Swan River.

The boundary parts of Padbury Avenue (both sides) are included within this optional area. The boundary parts of Maralla Road (both sides) are excluded from this optional area.

From a point on the western extension of Hope Valley Road on the Indian Ocean coastline, east along this extension and Hope Valley Road to Rockingham Road, north along Rockingham Road to the local government boundary between the City of Cockburn and the Town of Kwinana, east along this local government boundary to Mandogalup Road, south along Mandogalup Road to a point due north of the junction between Anketell Road and Clementi Road, south to this road junction, east along Anketell Road to the Kwinana Freeway, continuing east along Anketell Road to the local government boundary between the Town of Kwinana and the Shire of Serpentine-Jarrahdale, south along this local government boundary to Thomas Road and continuing south along the local government boundary to Casuarina Road, south along Casuarina Road to Lydon Road, continuing south along Lydon Road to Banksia Road, generally south along Banksia Road to Duckpond Road, north west along Duckpond Road and its north west extension to Millar Road, north west and west along Millar Road to Millar Road West, generally south west along Millar Road West to Mandurah Road, north west along Mandurah Road to Gilmore Avenue, north east along Gilmore Avenue to the local government boundary between the Town of Kwinana and the City of Rockingham to Wellard Road, west along the local government boundary to the coastline of the Indian Ocean and north along the coastline to the western extension of Hope Valley Road.

The boundary parts of Hope Valley Road (south side), Rockingham Road (east side), Mandogolup Road (west side), Anketell Road (south side), Casuarina Road (both sides), Lydon Road (both sides), Banksia Road (both sides), Duckpond Road (both sides), Millar Road (both sides), Mandurah Road (north east side) and Gilmore Road (south side) are included within the local-intake area of this school. The boundary parts of Millar Road West (both sides) are excluded from this local-intake area.

The following defines an optional area between Hamilton Senior High School and Gilmore College—

From a point on the western extension of Hope Valley Road on the Indian Ocean coastline, east along this extension and Hope Valley Road to Rockingham Road, north along Rockingham Road to the local government boundary between the City of Cockburn and the Town of Kwinana, east along this local government boundary to Mandogalup Road, north along Mandogalup Road and its northern extension to Russell Road, west and north west along Russell Road to Rockingham Road, north along Rockingham Road to the western section of Russell Road, west along the western section of Russell Road and its western extension to the coastline, and south along the coastline to the western extension of Hope Valley Road. The boundary parts of Hope Valley Road (north side), Rockingham Road (southern section, west side), Mandogolup Road (west side), Russell Road (eastern section, south side), Rockingham Road (northern section, west side) and Russell Road (western section, south side) are included within this optional area.

The following defines an optional area for Atwell High School and Kwinana High School—

From the intersection of the Kwinana Freeway and Rowley Road, south along the Kwinana Freeway to Anketell Road, west along Anketell Road to Clementi Road, north from this junction

to Madogolup Road, north west along Madogolup Road to the local government boundary between the City of Cockburn and the Town of Kwinana, east along this local government boundary to Rowley Road, and continuing east along Rowley Road to the Kwinana Freeway. The boundary parts of the Kwinana Freeway (west side), Anketell Road (north side), Mandogolup Road (east side) and Rowley Road (south side) are included in this optional area.

The following defines an optional area between Gilmore College and Armadale Senior High School—

From the junction of Anketell Road and Thomas Road, south west along Thomas Road to the locality boundary between Anketell and Oakford, north along this locality boundary to Anketell Road and east along Anketell Road to Thomas Road. The boundary parts of Anketell (south side) are included within this optional area, and the boundary parts of Thomas Road (both sides) are excluded from this optional area.

## GOVERNOR STIRLING SENIOR HIGH SCHOOL (Dec06)

The local-intake area for this school contains all or part of the local-intake areas of Herne Hill, Middle Swan and Woodbridge Midland Primary Schools and the traditional catchment areas of the following primary schools: Bassendean, Guildford, Midvale and Upper Swan.

From the bridge carrying Toodyay Road over Jane Brook, south-west along Toodyay Road to the Roe Highway, south along the Roe Highway to Great Eastern Highway, west along Great Eastern Highway to Lloyd Street, south along Lloyd Street to Clayton Street, south along Clayton Street to Military Road, south along Military Road to Bushmead Road, east along Bushmead Road to the Roe Highway, south along the Roe Highway to the Great Eastern Highway Bypass, west along the Great Eastern Highway Bypass to Great Eastern Highway, south-west along Great Eastern Highway to Ivy Street, north-west along Ivy Street to the Swan River, south and west along the Swan River to the extension of Iveson Place, north along Iveson Place to Reid Street, west along Reid Street to Elder Parade, north along Elder Parade to Chapman Street, west and north-west along Chapman Street to the railway line, north-east along the railway line to the Swan River, generally north along the Swan River to the western extension of Padbury Avenue, east along this extension, east along Padbury Avenue to Range Road, south along Range Road and continuing south along the locality boundary between Herne Hill and Red Hill to Toodyay Road, south west along Toodyay Road to the bridge over Jane Brook.

The boundary parts of Toodyay Road (north side), Roe Highway (west side), Great Eastern Highway (north side), Lloyd Street (both sides), Bushmead Road (south side), Roe Highway (west side), Great Eastern Highway Bypass (north side), Elder Parade (east side), Chapman Street (north side) and Range Road (both sides) are included within the area for Governor Stirling Senior High School. The boundary parts of Military Road (both sides), Ivy Street (both sides), Iveson Place (both sides), Reid Street (both sides) and Padbury Avenue (both sides) are excluded from the area for Governor Stirling Senior High School.

The following defines the boundary for an optional area between Governor Stirling Senior High School and Swan View Senior High School—

From the western extension of Rollinson Road on the coastline of the Indian Ocean, east along this extension, and east along Rollinson Road to Cockburn Road, north along Cockburn Road to Rockingham Road, south east along Rockingham Road to Carrington Street, north along Carrington Street to Winterfold Road, east along Winterfold Road and continuing along Torquil Road to North Lake Road, south along North Lake Road to the proposed Roe Highway, north east along the proposed Roe Highway to Progress Drive, south along Progress Drive to the eastward extension of Phoenix Road, west along the extension of Phoenix Road and Phoenix Road to Sudlow Road, south along Sudlow Road to Spearwood Avenue, north west along Spearwood Avenue to Wellard Street, south along Wellard Street to Barrington Street, west along Barrington Street to the railway line, and south along the railway line to Russell Road, north west along Russell Road to Rockingham Road, north along Rockingham Road to the western section of Russell Road and its western extension to the coastline, and north along the coastline to the western extension of Rollinson Road.

The boundary parts of Cockburn Road (east side), Rockingham Road (northern section, south side), Carrington Street (east side), Winterfold Road (south side), Torquil Road (south side), North Lake Road (west side), Progress Drive (both sides), Phoenix Drive (north side), Sudlow Road (west side), Spearwood Avenue (north side), Wellard Street (west side), Barrington Street (north side), Russell Road (eastern section, north side), Rockingham Road (southern section, east side) and Russell Road (western section, north side) are included within the area for Hamilton Senior High School. The boundary parts of Rollinson Road (both sides) are excluded from this area.

The following defines an optional area between Hamilton Senior High School and South Fremantle Senior High School—

From the western extension of Rollinson Road on the coastline of the Indian Ocean, east along this extension, and east along Rollinson Road to Cockburn Road, north along Cockburn Road to Hampton Road, continuing north along Hampton Road to Douro Road, west along Douro Road and its extension to the coastline, and south along the coastline to the western extension of Rollinson Road. The boundary parts of Rollinson Road (both sides), Cockburn Road (west side), Hampton Road (west side) and Douro Road (south side) are included within this optional area.

The following defines an optional area between Hamilton Senior High School and South Fremantle Senior High School—

From the junction of Rockingham Road and Carrington Street, north along Carrington Street to Healy Road, west along Healy Road to Rockingham Road and south east along Rockingham Road to Carrington Street. The boundary parts of Carrington Street (west side), and Rockingham Road (north side) are included within this optional area. The boundary parts of Healy Road (both sides) are excluded from this optional area.

The following defines an optional area between Hamilton and South Fremantle Senior High Schools—From the intersection of Stock Road and Winterfold Road, east along Winterfold Road and continuing into Torquil Road to North Lake Road, north along North Lake Road to South Street, west along South Street to Stock Road and south along Stock Road to Winterfold Road. The boundary parts of Winterfold Road (north side), Torquil Road (north side), North Lake Road (west side), South Street (south side) and Stock Road (east side) are included within this optional area.

The following defines an optional area between Hamilton and Melville Senior High Schools—

From the intersection of Farrington Road and North Lake Road, east along Farrington Road to Progress Drive, south along Progress Drive to the proposed Roe Highway, west along the proposed Roe Highway to North Lake Road, and north along North Lake Road to Farrington Road. The boundary parts of Farrington Road (south side), Progress Drive (both sides) and North Lake Road (east side) are included within this optional area.

The following defines an optional area between Hamilton Senior High School and Gilmore College—

From a point on the western extension of Hope Valley Road on the Indian Ocean coastline, east along this extension and Hope Valley Road to Rockingham Road, north along Rockingham Road to the local government boundary between the City of Cockburn and the Town of Kwinana, east along this local government boundary to Mandogalup Road, north along Mandogalup Road and its northern extension to Russell Road, west and north west along Russell Road to Rockingham Road, north along Rockingham Road to the western section of Russell Road, west along the western section of Russell Road and its western extension to the coastline, and south along the coastline to the western extension of Hope Valley Road. East, east along Walter Road East and its extension to the Swan River, south along the Swan River to the railway bridge, south west along the railway line to Collier Road, generally west and north along Collier Road to Walter Road West, north along the southern extension of Charnwood Street, north along Charnwood Street and its northern extension to Morley Drive, east along Morley Drive to Crimea Street, north along Crimea Street and its northern extension to Reid Highway, east along Reid Highway to Tonkin Highway, south along Tonkin Highway to Benara Road and east along Benara Road to Beechboro Road.

The boundary parts of Beechboro Road (west side), Seacom Court (both sides), Elettra Close (both sides), Cassia Way (both sides), Challenger Avenue (both sides), Bottlebrush Drive (west side), Morley Drive East (south side), May Road (west side), Robinson Road (north side), Iolanthe Street (west side), Walter Road East (south side), Collier Road (both sides), Crimea Street (east side), Reid Highway (south side), Tonkin Highway (west side) and Benara Road (south side) are included within the local-intake area for Hampton Senior High School.

The boundary parts of Eugene Court (both sides), Redgum Way (both sides), Charnwood Street (both sides) and Morley Drive (both sides) are excluded from the local-intake area of this school.

#### JOHN CURTIN COLLEGE OF THE ARTS (Dec06)

The following defines an optional area between John Curtin College of the Arts, Melville Senior High School and South Fremantle Senior High School—

From the junction of High Street and Oakover Street, north along Oakover Street to Marmion Street, east along Marmion Street to Petra Street, north along Petra Street to Canning Highway, east along Canning Highway to Whittle Court, north along Whittle Court to Birdwood Circus West, north along Birdwood Circus West to Birdwood Circus, north along Birdwood Circus to Phipps Street, north along Phipps Street to the northern end of that street, north west from the northern end of Phipps Street to the Swan River foreshore, generally west and south west along the foreshore into Fremantle Harbour to a point on the north west extension of James Street, south east along this extension to James Street and continuing south east along James Street to Ord Street, south along Ord Street to Knutsford Street, east along Knutsford Street to Montreal Street, north along Montreal Street to High Street and east along High Street to Oakover Street.
