THE TRAFFIC ACT, 1919-1931.

Traffic Regulations, 1931.—Additions and Amendments. REGULATIONS Nos. 193 and 194, published in the *Government Gazette* on the 13th day of February, 1931, are hereby revoked and the following inserted in lieu thereof:—

193. No person shall take up in and/or set down from any omnibus any passenger at any place on any portion of a prescribed route which portion coincides with or runs along or beside the route of any tramway, or at any place within one hundred and fifty yards from the point where a prescribed route intersects a tramway or ceases to coincide with or run along or beside the route of a tramway:

- (a) The terminal points of any prescribed route;
 (b) The setting down of passengers on any portion of the Perth Tramway system from an omnibus along a prescribed route on the inward journey to Perth;
- (c) The taking up of passengers on any portion of the Perth Tramway system in an omnibus along a prescribed route on the outward journey from Perth;
- (d) The setting down of passengers from an omnibus along a prescribed route within the East Fremantle, Fremantle or North Fremantle Municipalities, on the inward journey to Fremantle;
- (e) The taking up of passengers in an omnibus along a prescribed route within the East Fremantle, Fremantle, and North Fremantle Municipalities, on the outward journey from Fremantle;
- Municipalities, on the outward journey from Fremantle; (f) Between the hours of 11.50 p.m. and 6.0 a.m. to those parts of prescribed route No. 8 along Thomas Street, University Avenue, and Hampden Road lying between the junction of Rokeby Road and Thomas Street and the intersection of Perth-Fremantle Road and Hampden Road.

194. No person shall take up any passenger in an omnibus at any place on a portion of a prescribed route running along or beside the route of a railway where such place is within a distance of one hundred and fifty yards from a station on such railway route.

I certify that the foregoing Regulations are within the provisions of the Statute.

THE TRAFFIC ACT, 1919-31.

Traffic Regulations, 1931—Additions and Amendments. A REGULATION, to be numbered 11A, is hereby inserted after Regulation No. 11 published in the *Gov*ernment Gazette on the 13th day of February, 1931, as follows:—

Duplicate Licenses.

11A. The fee for a duplicate or a certified copy of a license issued under Section 59 of the Act shall be five shillings.

Regulation No. 26, published in the *Government Gaz*ette on the 13th day of February, 1931, is hereby revoked and the following inserted in lieu thereof:--

26. (a) Every Licensing Authority shall keep a register of all licenses issued for motor vehicles and trailers
